- This unit controls door lock/door unlock/tail gate open/panic wirelessly.

- Frequency is 433.92MHz

- Remote door lock/unlock/tail gate/panic
- Operating voltage: 3V DC

# **MANUAL**

## **1. LOCK Button**

If the LOCK button is pressed, then TRANSMITTER sends the LOCK data.

## **2. UNLOCK Button**

If the UNLOCK button is pressed, then TRANSMITTER sends the UNLOCK data.

## **3. Tail gate Button**

If the Tail gate button is pressed, then TRANSMITTER sends Tail gate open data.

## **4. PANIC Button**

If the PANIC button is pressed, then TRANSMITTER sends the PANIC data.
