# Professional installation of transmitter

---

According to FCC 15.203, if an intentional radiator has a standard antenna connector, it must be professionally installed.

To demonstrate that professional installation is required, the following three points must be addressed:

- (a) the application (or intended use) of the EUT;
- (b) the installation requirements of the EUT, and
- (c) the method by which the EUT will be marketed.

"The professional installation is required due to the following:

1. The MA850a cannot be sold to the general public, but only to the system's MobileAccess Inc. The customers of this company are exclusively qualified by MobileAccess. When the MobileAccess Inc sells the system to cellular provider or building owner companies, only professional installer, qualified ("licensed") by MobileAccess for this purpose will install the MA850a.
2. The installation must be controlled and follow the requirement of "Installation Manual". Each potential installer receives special training, which is a condition for receiving the license from the MobileAccess Inc to become a "licensed" installer. The installation itself is a complex procedure, as described in the "Installation Manual". It includes not only the mechanical installation, but additional procedure of interconnection to the main computer via modem, software initialization, registration of the specific MA850a in the MobileAccess Inc control center, initiation procedures. Specially trained professional only may perform all these tasks.
3. The intended application of the system is exclusively for the commercial/industry use.
