

# **Product Introduction**


### Thanks for choosing us!

This is a magnetic wireless charger, which can be used in two ways: bracket and horizontal type. It is suitable for mobile phones, earphones with wireless charging function Please read the manual carefully before using the product, and keep properly for checking.



### Using Method

Flat type wireless charging: The wireless charger will automatically align with the back of magnetic mobile phone, and start charging after accurate adsorption: The non-magnetic mobile phone can be charged wirelessly by placing the center position of the mobile phone in the wireless charger's center position.

2 Stand-type wireless charging: This function is only applicable to magnetic phones. After the wireless charger magnetic ally attracts the phone, unfold the back bracket of the wireless charger to the maximum arc and fix it, then place it on the desktop;you can use it charging vertically for watching videos, etc.
