TO REPLACE THE BATTERY FOR WALKIE-TALKIE:

1. REMOVE THE SCREW ON THE BATTERY DOOR WITH A SCREW DRIVER.

2.OPEN THE BATTERY DOOR AND INSERT 4 PCS AG13/LR44 1.5V BATTERY WITH CORRECT POLARITY INTO THE BATTERY COMPARTMENT.

3.REPLACE THE BATTERY DOOR AND THE SCREW ON POSITION.

WALKIE-TALKIE OPERATION

1.TURN THE "WALKIE TALKIE/LIGHT/POWER" SWITCH TO "ON WT" POSITION .

2.PLUG THE EARPHONE INTO THE EARPHONE JACK.(SEE FIG.1) 3.PRESS THE " PUSH TO TALK" BUTTON TO TRANSMIT WHEN YOU SPEAK TO THE MICROPHONE.

4.RELEASE "PUSH TO TALK"BUTTON RECEIVING VOICE . 5.TURN "WALKIE TALKIE/LIGHT/POWER" SWITCH TO "OFF" POSITION AFTER USED.

LITHT OPERATION

1.TURN THE "WALKIE TALKIE/LIGHT/POWER" SWITCH TO " ON LIGHT" POSITION .

2.THE LED ON THE TOP SHOULD LIGHT ON.

3.TURN "WALKIE TALKIE/LIGHT/POWER" SWITCH TO "OFF" POSITION AFTER USED.


