





#### ii) Installation of approved wireless modules

If no integrated wireless LAN Mini-PCI Card or RF CDC module has been preinstalled in your ThinkPad computer, you can install one, provided by IBM as an option. Plug the wireless card option into the Mini-PCI Card slot or CDC slot located under the expansion slot cover of your ThinkPad computer as shown below.




**Attention:** The ThinkPad X40 Series computer contains an authentication mechanism If you install an unauthorized wireless LAN Mini-PCI Card or RF CDC module that is not approved for use in the ThinkPad X40 Series computer, the computer will not start, but only displays an error message and emits beeps.

#### iii) The FCC RF safety requirement


The radiated output power of the Wireless LAN Mini-PCI Cards or RF CDC module authorized to use for the ThinkPad X40 Series computer is far below the FCC radio frequency exposure limits. Nevertheless, the ThinkPad X40 Series computer shall be used in such a manner that the potential for human contact during normal operation is minimized as follows:

Caution: To comply with FCC RF exposure compliance requirements, a separation distance of at least 20 cm (8 inches) must be maintained between the antenna for the integrated Wireless LAN Mini PCI Card built in to the screen section and all persons. You are not allowed to disable "standby mode" for the power management function, if you cannot maintain the sufficient antenna separation (at least 20 cm) in any case the LCD is left opened or closed.



**Note:** The transmission diversity function is implemented for the cards listed above (models WM3B2200BG, WM3B2915ABG, T60H786-U, AR5BMB-44). The function does not emit radio frequencies simultaneously from both antennas. One of the antennas is selected automatically or manually (by users) to have good quality of radiocommunication.



**Note:** The antenna of the models J07M067 and BMDC200 is located on the bottom of the computer lid. Transmitted energy from the *Bluetooth* device is very low compared to other RF devices. Therefore a 20 cm separation from the *Bluetooth* antenna is not required.

#### Use of wireless options




