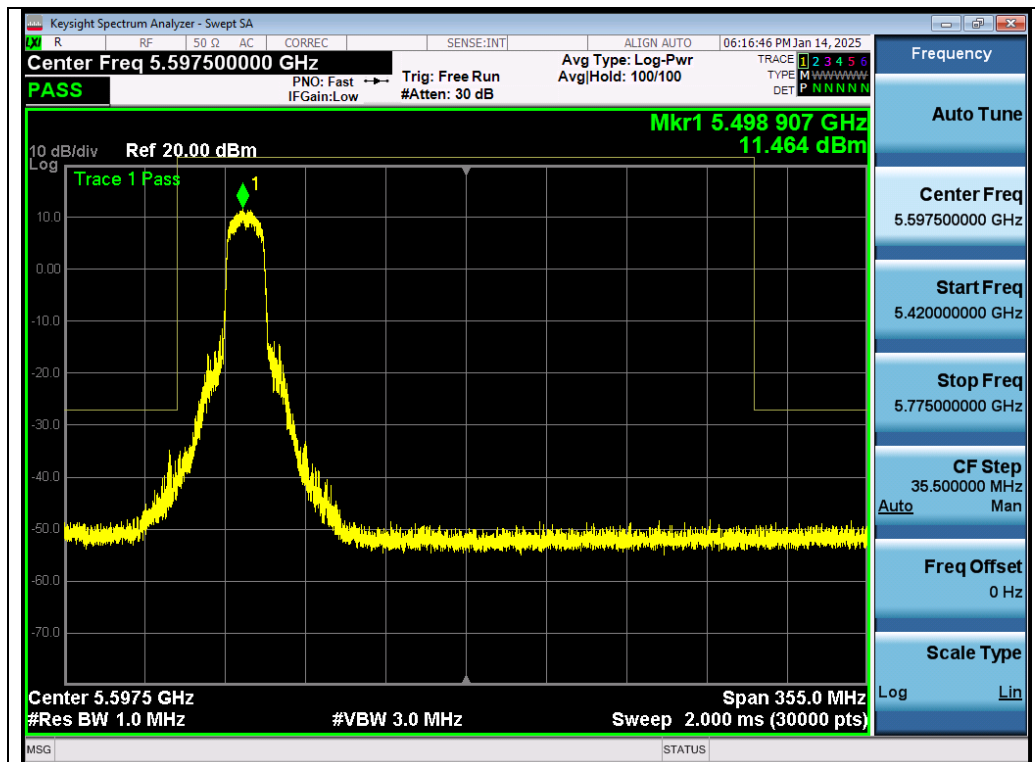

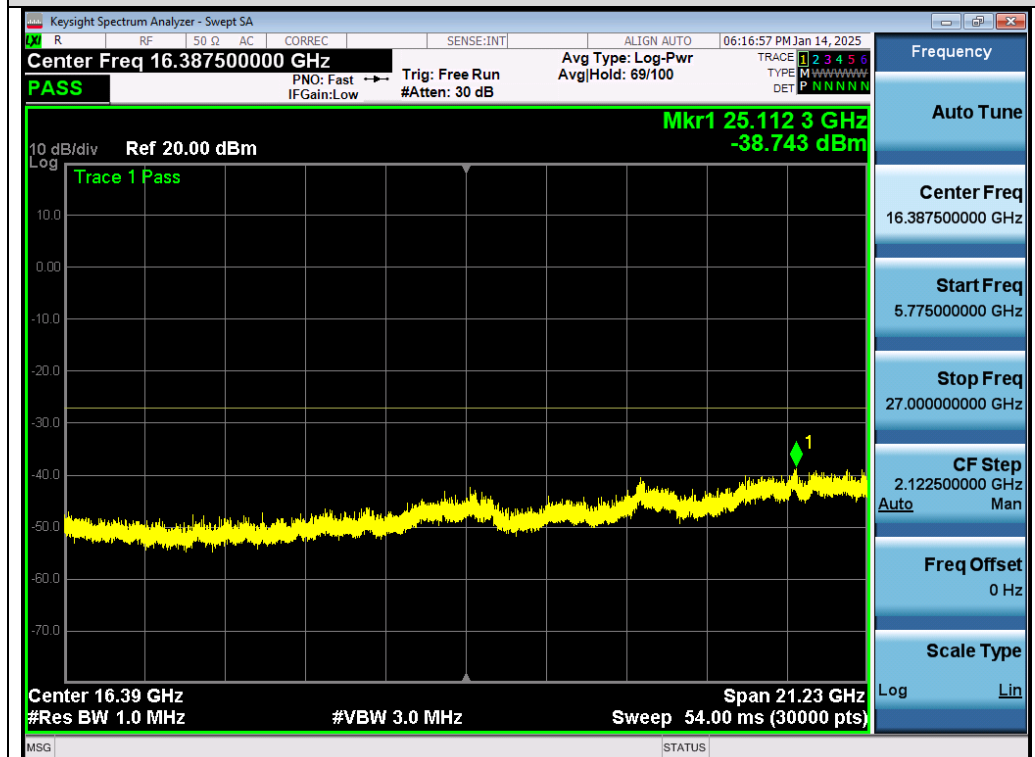

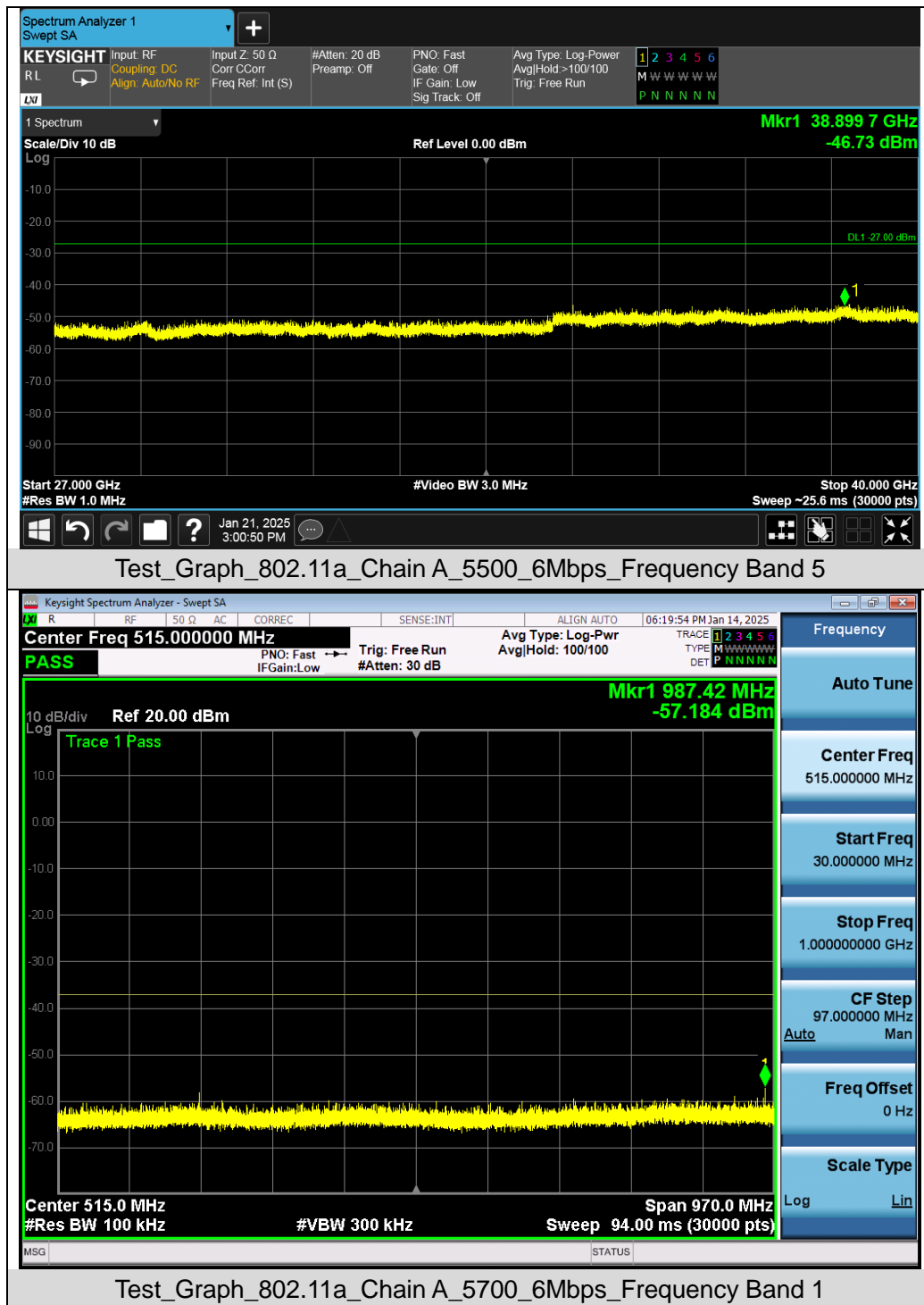


Test\_Graph\_802.11a\_Chain A\_5500\_6Mbps\_Frequency Band 3



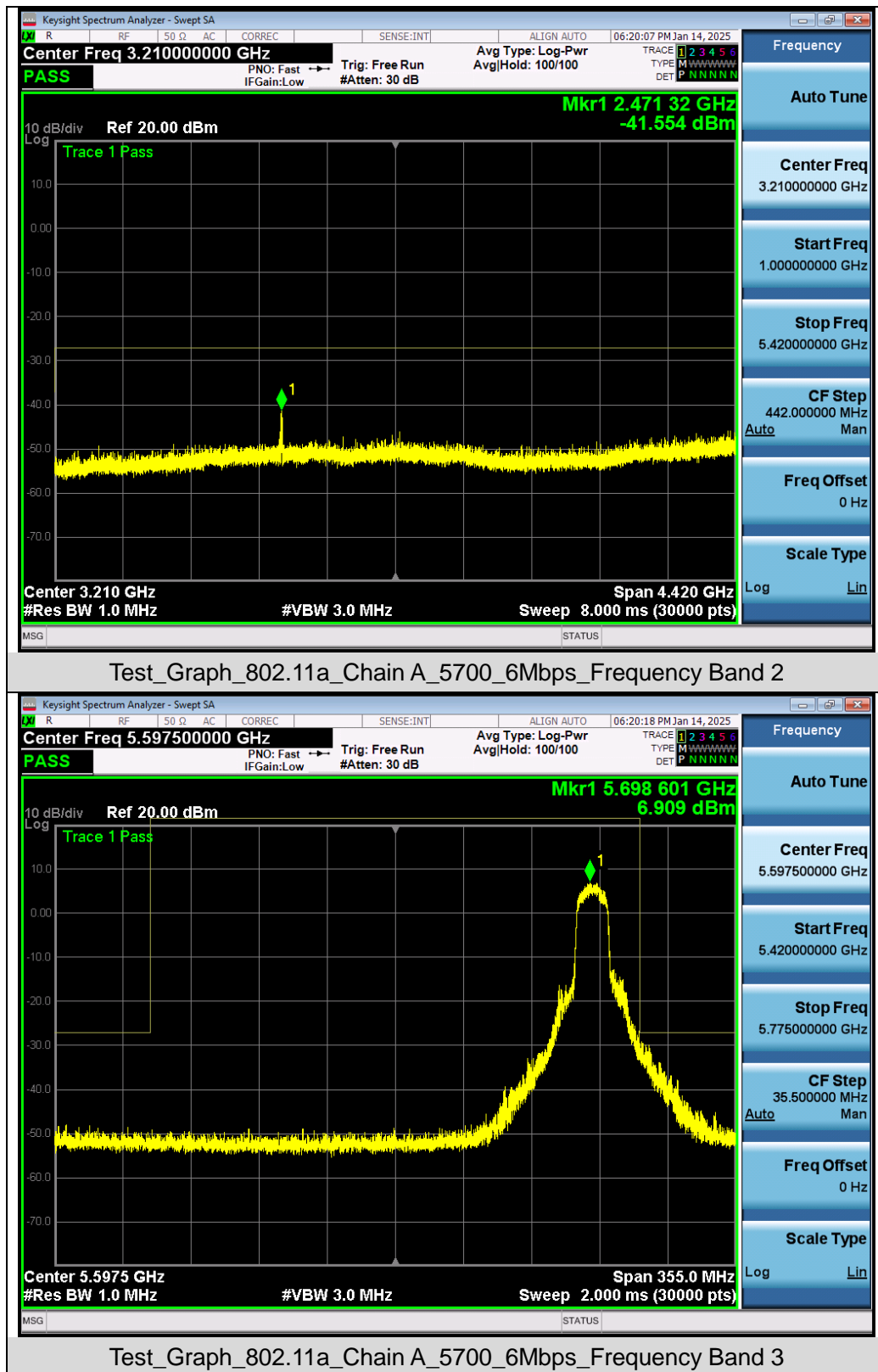
