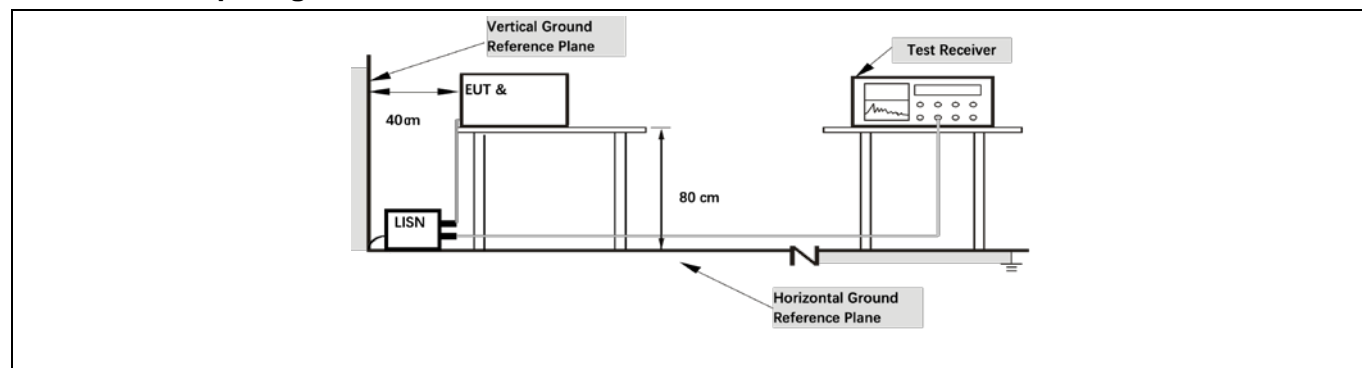

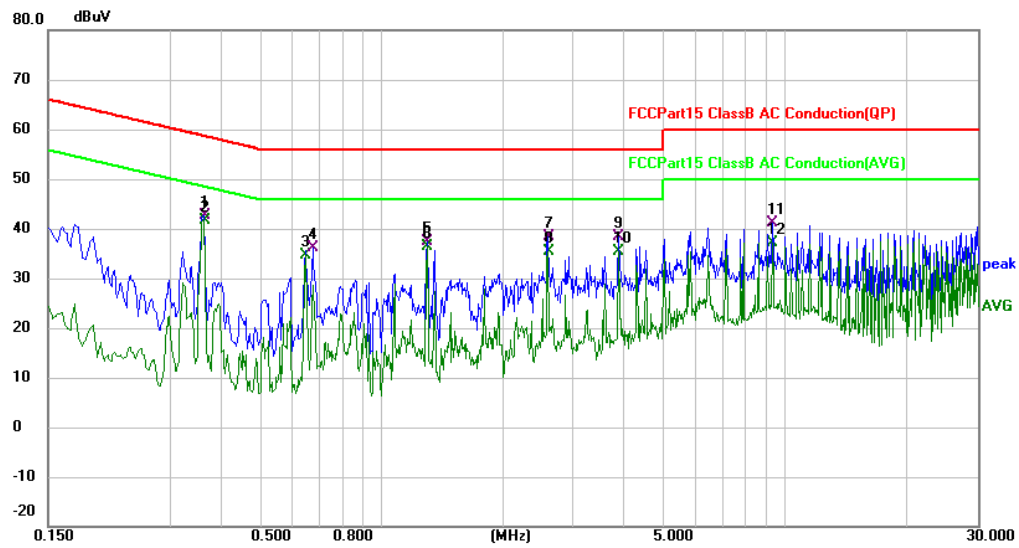

6.1.2 Test Setup Diagram:



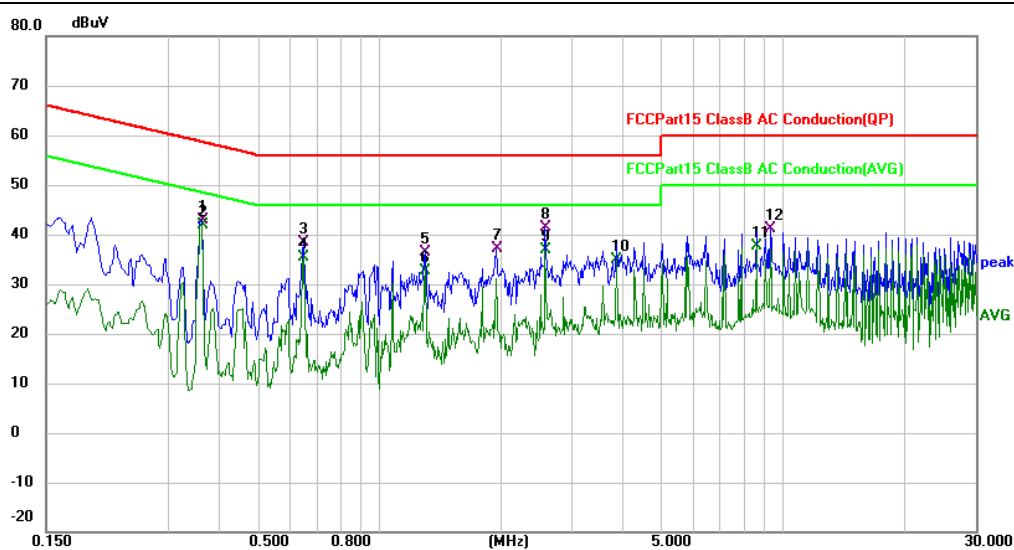

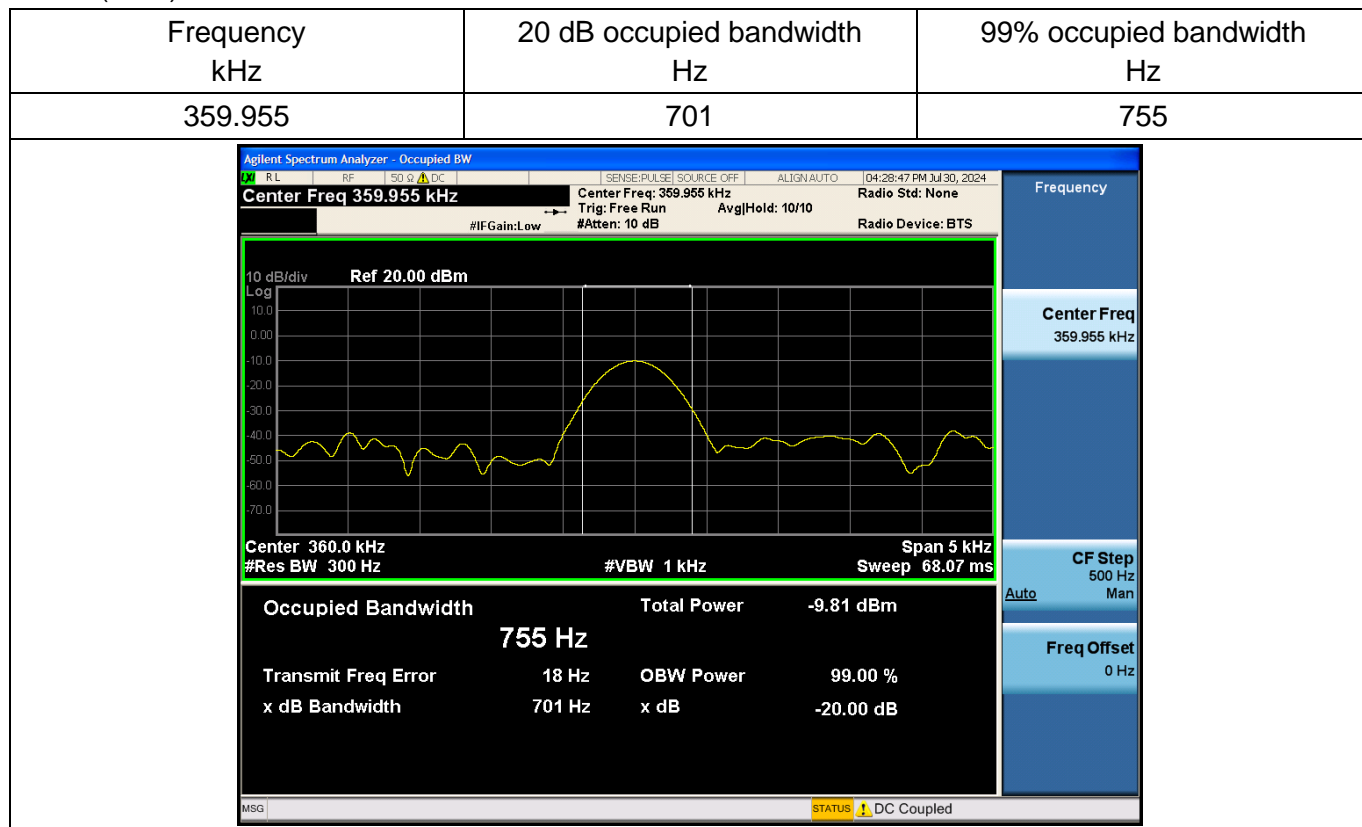

Coil 1(15W):



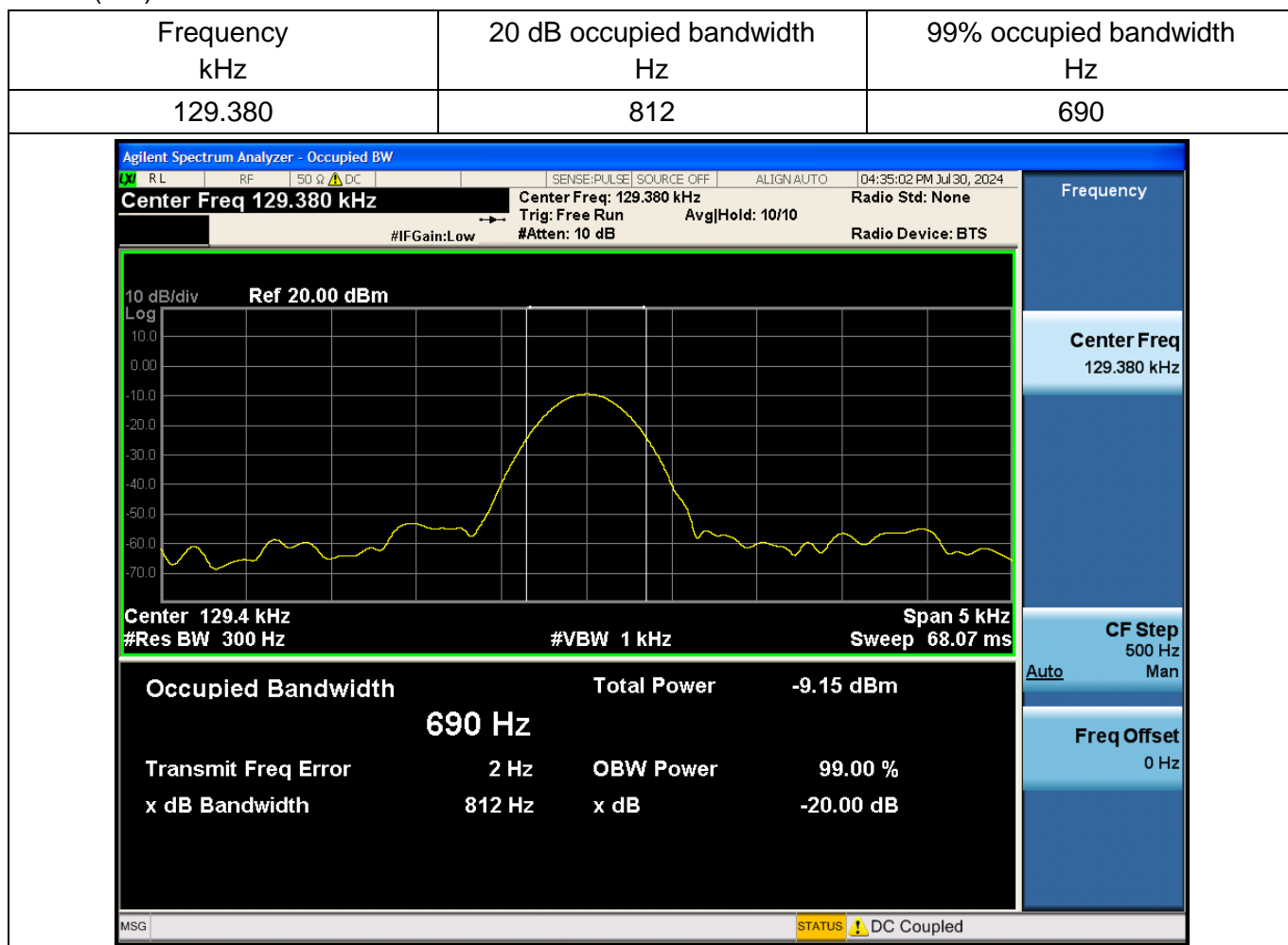

6.3.2 Test Setup Diagram:



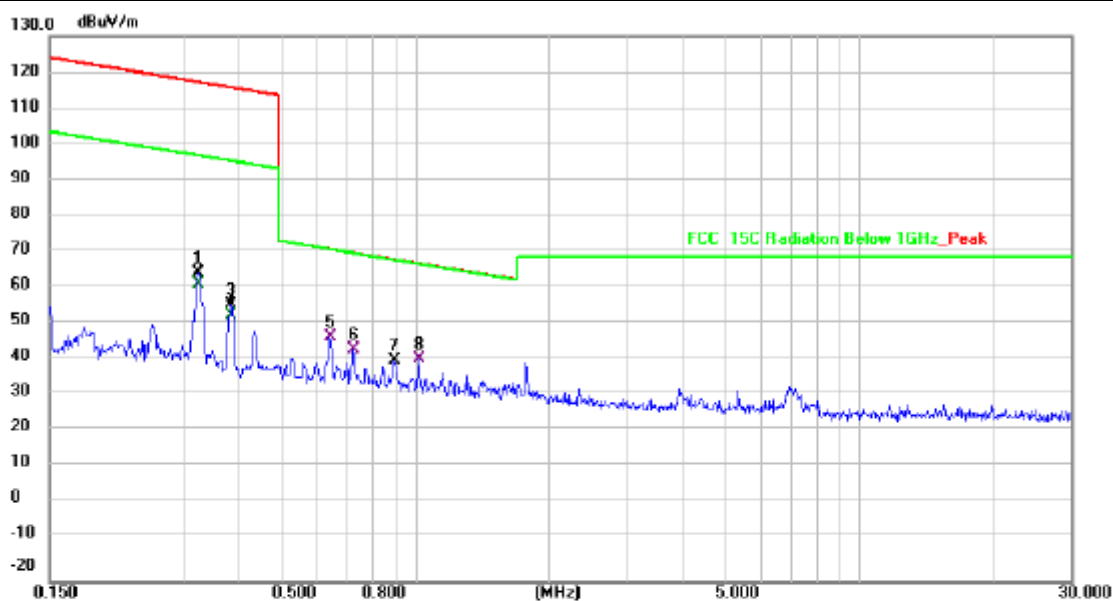

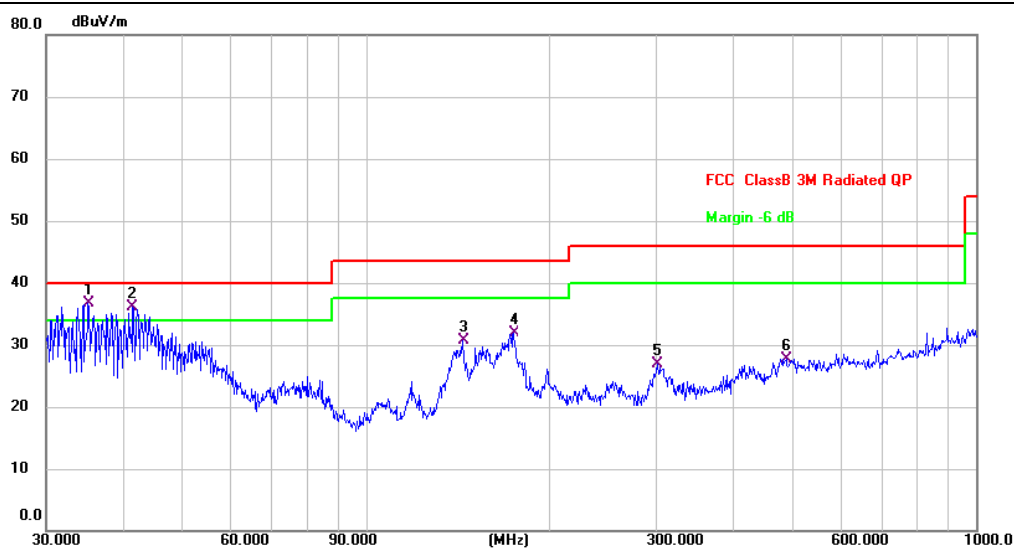
