Hopping Channel Number_DH5_

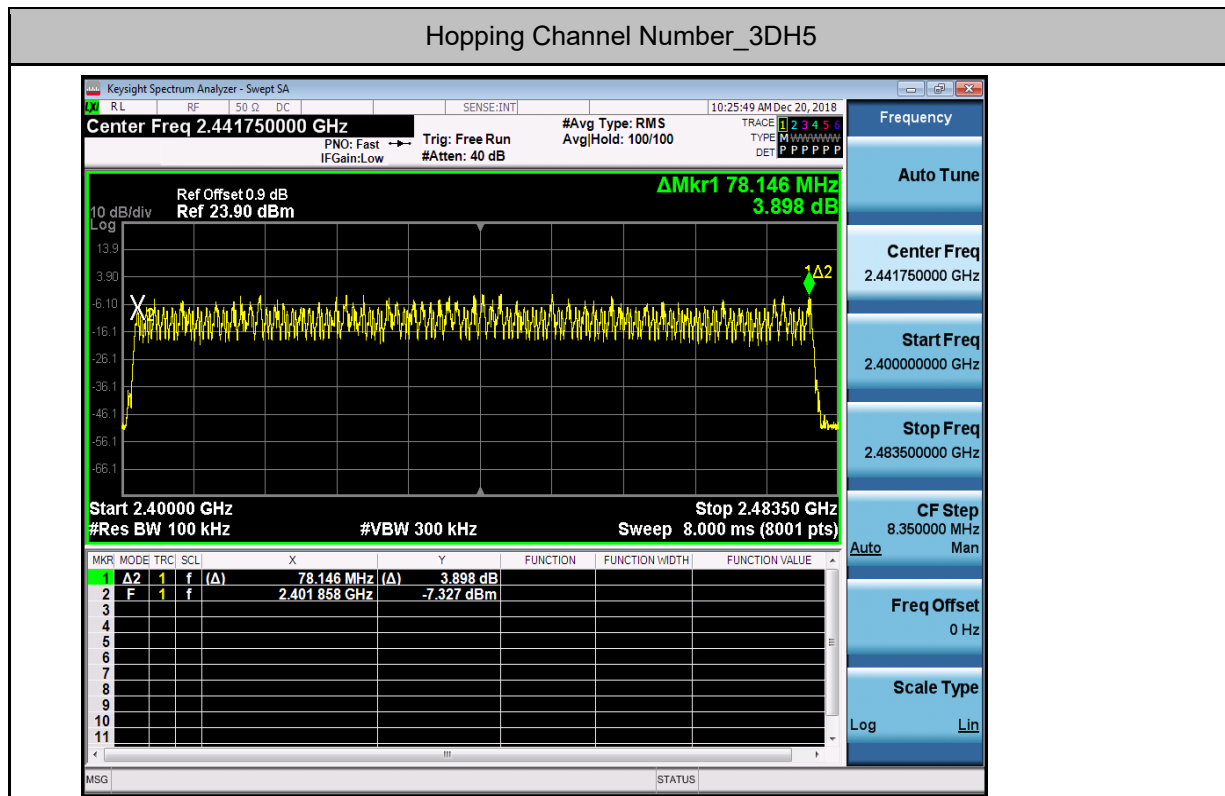


Hopping Channel Number_2DH5

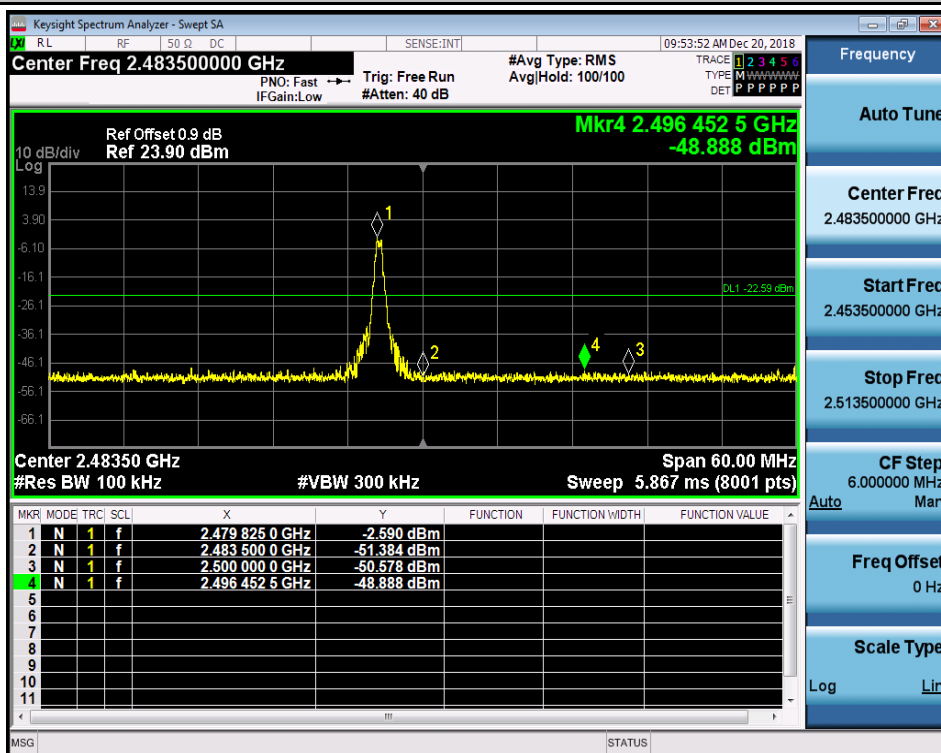
Band-edge for RF Conducted Emissions_DH5_2402_Hopping Off
