

How to Install

Method 1: Use Hooks

Method 2: Use Stickers Use the double-sided stickers.

Use the hooks. For example, hook the lights to the top of a curtain.





Pair to APP

- Scan the QR code on controller box to download the APP. and install it on your phone.
- 2. Turn on the Bluetooth on your phone.
- 3. Open th APP, tap the "+" icon in the top right corner and search new device.
- 4. APP will show the device found, just add it.
- 5. Tap the device icon to enter control panel.

Trouble Shooting

- a) APP can not find the device.
- Make sure the phone bluetooth is on.
- Allow the permissions of APP. APP needs them to connect the device.
