Difference between JOYDA39 and FCC ID JOYCW1011 is as follows:

- i. Deactivation of Band 13 through software and removal of band 13 components.
- ii. Change Memory IC to the alternate component from different manufacturer, which the device specification is identical to the prior one.
- iii. Modify software to support the new Memory IC.
- iv. No other modifications were made.
- v. Based on the modifications, we would like to use test reports RF180129C24, RF180129C24-1, RF180129C24-2 and RF180129C24-3 to support compliance based on KDB 484596.
- vi. We would like to apply conducted and power measurements to test reports RFBHAA-WTW-P21040837, RFBHAA-WTW-P21040837-1, RFBHAA-WTW-P21040837-2, RFBHAA-WTW-P21040837-3, RFBHAA-WTW-P21040941, RFBHAA-WTW-P21040941-1, RFBHAA-WTW-P21040941-2 and RFBHAA-WTW-P21040941-3 for AL-T51A2-1 and AL-T51A2-2.
- vii. We would like to refer Radiated Spurious Emissions (RSE) results to test reports RFBHAA-WTW-P21040837, RFBHAA-WTW-P21040837-1, RFBHAA-WTW-



P21040837-2, RFBHAA-WTW-P21040837-3, RFBHAA-WTW-P21040941, RFBHAA-WTW-P21040941-1, RFBHAA-WTW-P21040941-2 and RFBHAA-WTW-P21040941-3 for AL-T51A2-1 and AL-T51A2-2.

viii. Statement in cover letter stating the applicant takes full responsibility that the test data as referenced in reports RF180129C24, RF180129C24-1, RF180129C24-2 RF180129C24-3, RFBHAA-WTW-P20070391, RFBHAA-WTW-P20070391-1 RFBHAA-WTW-P20070391-2 RFBHAA-WTW-P20070391-3, RFBHAA-WTW-P20090611, RFBHAA-WTW-P20090611-1 RFBHAA-WTW-P20090611-2 and RFBHAA-WTW-P20090611-3 represents compliance for the new FCC ID.
