#### **Equipment Function and Configuration**

The EUT is a portable video recording device incorporating transceiver circuitry in the 2412-2462 MHz frequency band. The transceiver system provides switching ability for remote activation of compliant equipment. The design utilizes permanently attached PCB mounted chip antenna. For testing purposes, the FirstVu HD transceiver was paired with manufacturer provided equipment for frequency selection and activation. This configuration provided operational control of the EUT. The FirstVu HD offers two ports for connection with proprietary compliant USB equipment only and offers no other interface ports. For testing purposes, the FirstVu HD received powered from the rechargeable 3.7-volt battery and was configured to transmit in available modes. The antenna system complies with requirements for unique antenna connection port.



#### **Applicable Standards & Test Procedures**

In accordance with the Federal Communications Code of Federal Regulations Title 47, dated October 1, 2013, Part 2, Subpart J, Paragraphs 2.907, 2.911, 2.913, 2.925, 2.926, 2.1031 through 2.1057, and applicable parts of paragraph 15, Part 15C Paragraph 15.247, and RSS-210 the following information is submitted. Test procedures used are the established Methods of Measurement of Radio-Noise Emissions as described in ANSI C63.10-2009, KDB 558074 D01 v03r1, KDB 662911 D02 MIMO v02, and KDB 913591. Testing for the AC line-conducted and radiated emissions were performed as defined in section 6 of ANSI C63.10-2009.

#### **Equipment Testing Procedures**

#### **AC Line Conducted Emission Test Procedure**

Testing for the AC line-conducted emissions was performed as defined in ANSI C63.10-2009. The test setup, including the EUT, was arranged in the test configurations as presented during testing. The test configuration was placed on a 1 x 1.5-meter wooden bench, 0.8 meters high located in a screen room. The power lines of the system were isolated from the power source using a standard LISN with a 50-µHy choke. EMI was coupled to the spectrum analyzer through a 0.1 µF capacitor internal to the LISN. The LISN was positioned on the floor beneath the wooden bench supporting the EUT. The power lines and cables were draped over the back edge of the table. Refer to diagram 1 showing typical test arrangement and photographs in exhibits for EUT placement used during testing.

#### Radiated Emission Test Procedure

The EUT was placed on a rotating 1 x 1.5-meter wooden platform, 0.8 meters above the ground plane at a distance of 3 meters from the FSM antenna. Radiated emissions testing were performed as required in CFR47 paragraph 15C, RSS-210 and as specified in sections 6 and 7 of ANSI C63.10-2009. EMI energy was maximized by equipment placement, raising and lowering the FSM antenna, changing the antenna polarization, and by rotating the turntable. Each emission was maximized before data was taken using a spectrum analyzer. The frequency spectrum from 9 kHz to 25,000 MHz was searched for during preliminary investigation. Refer to diagrams 2 and 3 showing typical test arrangement and photographs in the test setup exhibits for specific EUT placement during testing.



- 1. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 cm to 40 cm long see (see 6.2.3.1).
- 2. I/O cables that are not connected to an accessory shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m (see 6.2.2).





#### Restricted Bands of Operation

Spurious emissions falling in the restricted frequency bands of operation were measured at the OATS. The EUT utilizes frequency, determining circuitry, which generates harmonics falling in the restricted bands. Emissions were investigated at the OATS, using appropriate antennas or pyramidal horns, amplification stages, and spectrum analyzer. Peak and average amplitudes of frequencies above 1000 MHz were compared to the required limits with worst-case data presented below. Test procedures of ANSI C63.10-2009 paragraph 6 were used during testing. No other significant emission was observed which fell into the restricted bands of operation. Computed emission values take into account the received and measured radiated field strength, receive antenna correction factor, amplifier gain stage, and test system cable losses.

#### AC Line Conducted Emissions Procedure

The EUT was arranged in a typical equipment configuration and placed on a 1 x 1.5-meter wooden bench 80 cm above the conducting ground plane, floor of a screen room. The bench was positioned 40 cm away from the wall of the screen room. The device operates from direct current battery power and may be functioning when USB interface is active. Therefore, AC line conducted emissions testing were performed on the AC adapter of the computer supporting the USB interface. The LISN was positioned on the floor of the screen room 80-cm from the rear of the EUT. The manufacturer supplied AC power cord for the computer supporting the transmitter EUT was connected to the LISN. A second LISN was positioned on the floor of the screen room 80-cm from the rear of the supporting equipment of the EUT. All power cords except the CPU were then powered from the second LISN. EMI was coupled to the spectrum analyzer through a 0.1 µF capacitor, internal to the LISN. Power line conducted emissions testing were carried out individually for each current carrying conductor of the EUT. The excess length of lead between the system and the LISN receptacle was folded back and forth to form a bundle not exceeding 40 cm in length. The screen room, conducting ground plane, analyzer, and LISN were bonded together to the protective earth ground. Preliminary testing was performed to identify the frequency of each radio frequency emission displaying the highest amplitude. The cables were repositioned to obtain maximum amplitude of measured EMI level. Once the worst-case configuration was identified, plots were made of the EMI from 0.15 MHz to 30 MHz then the data was recorded with maximum conducted emissions levels. Refer to figures one and two for plots of the AC Power Line conducted emissions of the computer systems supporting the EUT.




Figure 1 AC Line Conducted Emissions Line 1




Figure 2 AC Line Conducted Emissions Line 2

#### General Radiated Emissions Procedure

The EUT was arranged in a typical equipment configuration and operated through all available modes with worst-case data recorded. Preliminary testing was performed in a screen room with the EUT positioned 1 meter from the FSM. Radiated emissions measurements were performed to identify the frequencies, which produced the highest emissions. Each radiated emission was then maximized at the OATS location before final radiated emissions measurements were performed. Final data was taken with the EUT located at the OATS at a distance of 3 meters between the EUT and the receiving antenna. The frequency spectrum from 9 kHz to 25,000 MHz was searched for general radiated emissions. Measured emission levels were maximized by EUT placement on the table, rotating the turntable through 360 degrees, varying the antenna height between 1 and 4 meters above the ground plane and changing antenna position between horizontal and vertical polarization. Antennas used were Loop from 9 kHz to 30 MHz, Broadband Biconical from 30 to 200 MHz, Biconilog from 30 to 1000 MHz, Log Periodic from 200 MHz to 1 GHz and or Double Ridge or pyramidal horns and mixers above 1 GHz, notch filters, and appropriate amplifiers and external mixers were utilized.

#### Operation in the Band 2400-2483.5 MHz

Radiated emissions were measured on the Open Area Test Site (OATS) at a three-meter distance. The EUT utilizes integral antenna system and provides not provision for alternate antenna system. The EUT was placed on a wooden turntable 0.8 meters above the ground plane at a distance of 3 meters from the FSM antenna located on the OATS. The peak and quasi-peak amplitude of the frequencies below 1000 MHz were measured using a spectrum analyzer. These procedures provide for antenna port measurement or measurement of maximum field strength (summing horizontal and vertical for total output power) and conversion calculations for comparison with requirements.




Figure 1 Plot of Transmitter Emissions (Across Operational Band)




Figure 2 Plot of Transmitter Low Band Edge




Figure 3 Plot of Transmitter High Band Edge
