2. RF Exposure evaluation for FCC

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

Worse case is as below: [2480 MHz, 9.52 dBm, (8.95 mW) output power]

 $(8.95/5) \cdot [\sqrt{2.480(GHz)}] = 2.82 < 3.0 \text{ for } 1-g \text{ SAR}$
