Diagram of Measurement Configuration for Radiation Test (Below 1GHz)

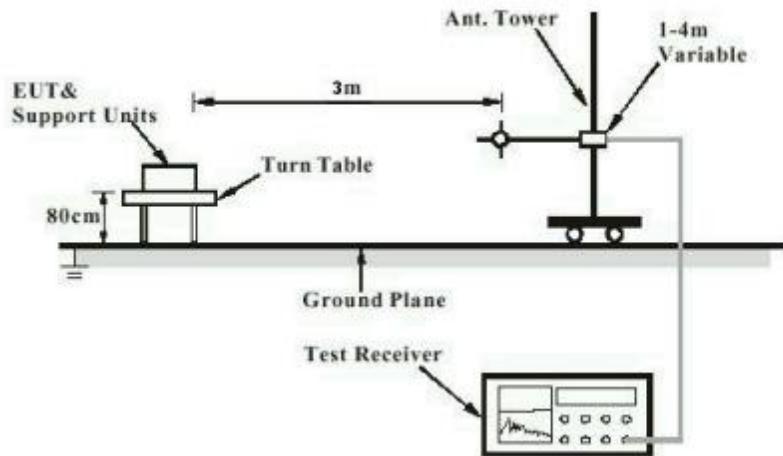
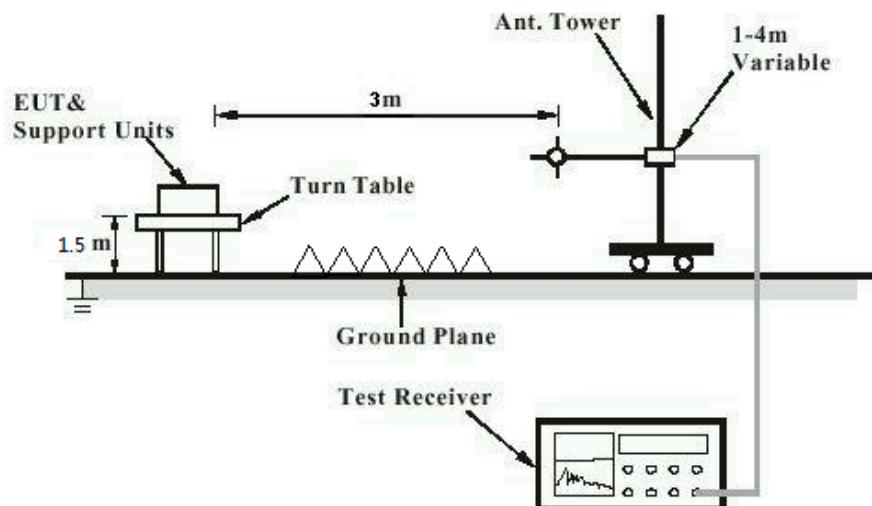


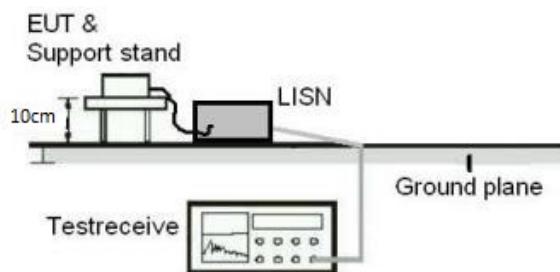
Diagram of Measurement Configuration for Radiation Test (Above 1GHz)



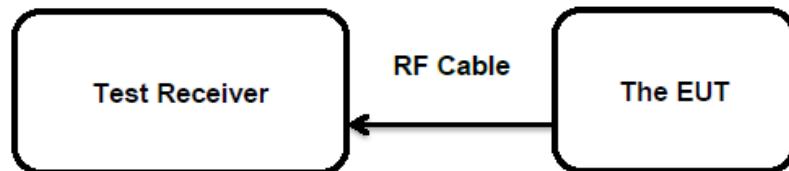

According to the manufacturer declared, the EUT has a External glue stick antenna, the directional gain of antenna is -1.09 dBi, and the antenna connector is designed with permanent attachment and no consideration of replacement.

Therefore the EUT is considered sufficient to comply with the provision.
