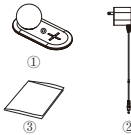

1. Qi-enabled smartphones charge up to 5W.
2. Any Qi-compatible smartphones.



LED Indicator	Status
Blue light on for 3 seconds	Connected to power
Off	Stand by for charging
Blue light on continuously	Charging device
Blue light (flashing)	Foreign object detected (Remove it before charging)

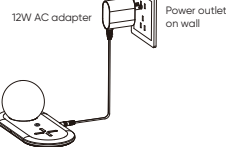
◆ How to charge your devices.

Connect 12W AC Adapter with Night Light.
Insert power barrel connector to the connecting port of the charging pad

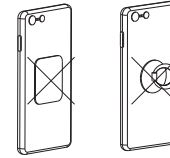


Connect to Power Supply

Plug in 12W AC adapter into power outlet for power supply.

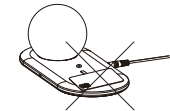


- ◆ Begin to charge
- ◆ Remove any foreign object (if any)
Example: Magnet or holder



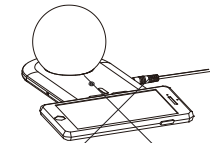
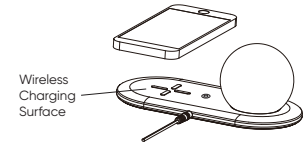
If there is any foreign object detected, LED indicator will be flashing.

**Thick protective case ≥ 5 mm or a case includes magnet or metallic material, may not allow proper charging function.



Do not place any credit card on the charging device.

Place your smartphone(s) or any Qi-enabled device on the center of the charging surface, make sure to cover



LED indicator will be on continuously while charging.

◆ Caution

- Avoid dropping
- No metal objects between devices and wireless charging pad
- Thick protective case ≥ 5 mm or a case includes magnet or metallic material, may not allow proper charging function.
- Keep wireless charging pad away from any liquids or moisture
- The maximum ambient temperature during use of this product must not exceed 45°C. Do not place device in fire or other excessively hot environments.
- Only use dry cloth or brush to clean this product.
- Do not use if visible defects are observed on the wireless charging pad.
