
Note 3: Emissions between 100 kHz to 300 kHz should be assessed versus the limits at 300 kHz in Table 1 of Section 1.1310: 614 V/m and 1.63 A/m. A KDB inquiry is required to determine the applicable exposure limits below 100 kHz.



4. TEST PROCEDURE

a. For devices designed for typical desktop applications, such a wireless charging pads, RF exposure evaluation should be conducted assuming a user separation distance of (H-field & E- field strengths for all sides is 15cm, H-field strengths of top side is 20cm). E and H field strength measurements or numerical modeling may be used to demonstrate compliance. Measurements should be made from all sides and the top of the primary/client pair, with the 15 cm measured from the center of the probe(s) to the edge of the device.

Remark: According KDB 680106 D01 RF Exposure Wireless Charging App v03, section 5, b). The aggregate H-field strengths at 15 cm surrounding the device and 20 cm above the top surface from all simultaneous transmitting coils are demonstrated to be less than 50% of the MPE limit. The E- field evaluation conducted assuming a user separation distance of 15 cm according to the KDB 680106 D01 RF Exposure Wireless Charging App v03 section 3, c).

Result: The device comply with the RF exposure requirement according to KDB 680106 D01 v03, section 5, b):

- (1) The operating frequency is 125kHz, is less than 1MHz.
- (2) The max Output power for each primary coil is 5W, less than or equal to 15W.
- (3) The transfer system includes only single primary and secondary coils.
- (4) Client device is placed directly in contact with the transmitter.
- (5) Mobile exposure conditions only (portable exposure conditions are not covered by this exclusion).
- (6) The aggregate H-field strengths at 15 cm surrounding the device and 20 cm above the top surface from all simultaneous transmitting coils are demonstrated to be less than 50% of the MPE limit.
