

The EUT pre-scanned in reader mode with NFC tag (four NFC type A, F) and without reading tag. Based on the highest field strength of fundamental and spurious emissions, the worst case type (type F) was recorded in this report.

The measured emission level of the EUT was maximized by rotating the EUT on a turntable, adjusting the orientation of the EUT and EUT antenna in three orthogonal axis (X: flat, Y: portrait, Z: landscape), and adjusting the measurement antenna orientation, following C63.10 exploratory test procedures and find Y plane as worst plane.

Remark: For Radiated Test Cases, the tests were performed with Sample 3.

2.4 EUT Operation Test Setup

The EUT is programmed to be in continuously transmitting mode.

The ancillary equipment, NFC watch, is used to make the EUT (NFC) continuously transmitting signal (Power Level: Default) at 13.56MHz and is placed around 0 cm gap to the EUT.

The RF test items, utility "Tera Term" was installed in Notebook which was programmed in order to make the EUT get into the engineering modes to provide channel selection, power level, data rate and the application type and for continuous transmitting signals.



- The spectrum analyzer connected via a receive antenna placed near the EUT in peak Max Hold Mode.
- 2. The resolution bandwidth of 1 kHz and the video bandwidth of 3 kHz were used.
- 3. Measured the spectrum width with power higher than 20 dB below carrier.
- 4. Measured the 99% OBW.

3.2 Frequency Stability Measurement

3.2.1 Limit

The frequency tolerance of the carrier signal shall be maintained within +/- 0.01% (100ppm) of the operating frequency over a temperature variation of -20 degrees to +50 degrees C at normal supply voltage, and for a variation in the primary supply voltage from 85% to 115% of the rated supply voltage at a temperature of 20 degrees C. For battery operated equipment, the equipment tests shall be performed by using a new battery.



- 2. EUT has transmitted signal and fixed channelize.
- 3. Set the spectrum analyzer span to view the entire emissions bandwidth.
- 4. Set RBW = 1 kHz, VBW = 3 kHz with peak detector and maxhold settings.
- 5. The fc is declaring of channel frequency. Then the frequency error formula is $(fc-f)/fc \times 10^6$ ppm and the limit is less than ± 100 ppm.
- 6. Extreme temperature rule is -20°C~50°C.



- 2. Power on the EUT and all the supporting units. The turntable is rotated by 360 degrees to determine the position of the highest radiation.
- The height of the broadband receiving antenna is varied between one meter and four meters above ground to find the maximum emissions field strength of both horizontal and vertical polarization.
- 4. For each suspected emissions, the antenna tower is scanned (from 1 M to 4 M) and then the turntable is rotated (from 0 degree to 360 degrees) to find the maximum reading.
- Set the test-receiver system to Peak or CISPR quasi-peak Detect Function with specified bandwidth under Maximum Hold Mode.
- 6. When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds. - In case the emission is lower than 30 MHz, loop antenna has to be used for measurement and the recorded data shall be QP measured by receiver.

When there is no suspected emission found and the emission level is with at least 6 dB margin against QP limit line, the position is marked as "-".

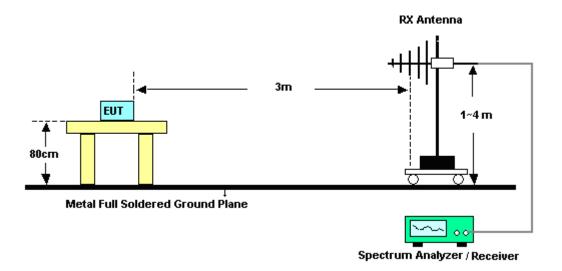






B3. Results of Radiated Spurious Emissions (30MHz~1GHz)
