

### 4.7 RADIATED EMISSION MEASUREMENT

#### 4.7.1 LIMITS OF RADIATED EMISSION MEASUREMENT

Field strength limits are at the distance of 3 meters, emissions radiated outside of the specified bands, shall be according to the general radiated limits in 15.209 as following:

- 1. The lower limit shall apply at the transition frequencies.
- 2. Emission level  $(dBuV/m) = 20 \log Emission level (uV/m)$ .
- 3. As shown in 15.35(b), for frequencies above 1000MHz, the field strength limits are based on average detector, however, the peak field strength of any emission shall not exceed the maximum permitted average limits, specified above by more than 20dB under any condition of modulation.


#### 4.7.3 TEST PROCEDURES

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 10 meter open area test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be retested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

- 1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120kHz for Peak detection (PK) and Quasi-peak detection (QP) at frequency below 1GHz.
- 2. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1 MHz for Peak detection at frequency above 1GHz.
- 3. The resolution bandwidth of test receiver/spectrum analyzer is 1 MHz and the video bandwidth is 300 Hz for Average detection (AV) at frequency above 1GHz.

#### 4.8.3 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer via a low lose cable. Set both RBW and VBW of spectrum analyzer to 100 kHz with suitable frequency span including 100 kHz bandwidth from band edge. The band edges was measured and recorded.



#### 4.8.4 EUT OPERATING CONDITION


The software provided by client enabled the EUT to transmit and receive data at lowest, middle and highest channel frequencies individually.

#### 4.8.5 TEST RESULTS


The spectrum plots are attached on the following 2 pages. D2 line indicates the highest level, D1 line indicates the 20dB offset below D2. It shows compliance with the requirement in part 15.247(C).

**NOTE:** The band edge emission plot on the following 2 pages shows 44.22dB delta between carrier maximum power and local maximum emission in restrict band (2.4836GHz). The emission of carrier strength list in the test result of channel 78 at the item 4.7.6 (Page 51) is 79.6dBuV/m, so the maximum field strength in restrict band is 79.6-44.22=35.38 dBuV/m which is under 54 dBuV/m limit.











### 4.9 ANTENNA REQUIREMENT

#### 4.9.1 STANDARD APPLICABLE

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.


And according to FCC 47 CFR Section 15.247 (b), if transmitting antennas of directional gain greater than 6 dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

### 4.9.2 ANTENNA CONNECTED CONSTRUCTION

The antenna used in this product is PIFA Antenna. There is no antenna connector. The maximum Gain of this antenna is only 1dBi.


