② Buttons / ボタン



- ① When turned on, BT-ANC will automatically connect to the last connected device if available. If not, BT-ANC will enter pairing mode. 接続させる際に、曾てイヤホンを一度接続した事があるデバイスには自動的に繋げます。
- 1 **To pair a different device,** first disable Bluetooth on the connected device then repeat the pairing steps.




接続設定において、トラブルが発生した場合はどうしますか?
Remove BT-ANC from your device's Bluetooth records or restart your BT-ANC, ensure it's less than 3 feet away, then try pairing again. お使いになるデバイスのブルートゥースの接続履歴を削除し、ブルートゥースを再度オンにして、3フィート(約1m) 範囲内にて接続を再設定させます。

- ① What's if the phonecall or music lagging or connection breaks? 電話や音楽の接続が遅れたり、途中に停止したりすると、どうしますか?
 - 1) The earphones out of battery. 電源を切ります。
 - 2) The connection distance over 10m between phone and earphone. 接続範囲を大幅に超えさせます。
 - 3) There is obstacle between phone and speaker to block the signal, e.g. wall. 電話とイヤホンの間に障害物があり、信号をなくさせます。

3 Bluetooth/ブルートゥース



- 1.A LED indicator flashing for paring when Earphone turned on. イヤホンをオンにする際にLEDライトを点滅させます。
- 2.Turn on the Bluetooth on your device. デバイスのブルートゥースをオンにします。
- 3.Search and choose "BT-ANC " to pair.

- ① Why the voice is not clear when speaking through the mic? なぜマイクからの通話音声が不快なのか?
 - 1) Too long distance between your mouth and the earphone mic to talk. Suggest wear the earphone properly then talk through mic. 通話際に、マイクとの距離を離れすぎないようにしてください。
 - 2) Jam in the mic of earphone, carefully clean it with a cotton swab damp. 線棒でイヤホンのマイクを拭いてください。

■Wearing Earphone / イヤホンをつける

① Wearing long time earphone may caused a swelling pain on auricle and ear canal? The earphone includes three sizes of eartips and earhooks with S, M, L size. Adjust each earhook until it fits flush in your auricle and the eartip seals in the ear canal. 付属品のイヤーフックとイヤーピースが3種のサイズ(S, M, L) があり、耳に適合なサイズを選んでください。
