





AUDIO FREQUENCY REPSONSE PLOT





MODULATION LIMITING PLOT (300 Hz)





MODULATION LIMITING PLOT (1000 Hz)





AUDIO LOW PASS FILTER PLOT




Frequency Response of the Audio Low Pass Filter (150mVrms INPUT)



Occupied BW Test Equipment Setup





OCCUPIED BANDWIDTH PLOT






