






#### 4. METHOD OF MEASUREMENT

### 4.1 Applicable Standard

## 4.4 Test procedure

- a) The RF exposure test was performed on 360 degree turn table in anechoic chamber.
- b) The measurement probe was placed at test distance (15cm) which is between the edge of the charger and the geometric centre of probe.
- c) The turn table was rotated 360d degree to search of highest strength.
- d) The highest emission level was recorded and compared with limit as soon as measurement of each points (A, B, C, D, E) were completed.
- e) The EUT were measured according to the dictates of KDB 680106D01v03.

#### 4.5 Equipment Approval Considerations




