

#### 5.9.1 TEST DESCRIPTION

The Equipment Under Test (EUT) was set up to perform the dwell time measurement.

The dwell time is independent of the modulation pattern.

The EUT is set to its maximum dwell time.

The dwell time is measured by spectrum analyser and power meter in parallel. The spectrum analyser video output is connected to the power meter allowing the power meter to measure transmission time only when the EUT is actively transmitting on the measured channel.
