		 The EUT was placed on the top of a rotating table 1.5 meters aborground at a 3 meter camber. The table was rotated 360 degrees to determine the position of the highest radiation. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height anter tower. The antenna height is varied from one meter to four meters above ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make measurement. For each suspected emission, the EUT was arranged to its worst of and then the antenna was tuned to heights from 1 meter to 4 meter and the rota table was turned from 0 degrees to 360 degrees to fir maximum reading. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode. 
