











7. Maximum Peak Conducted Output Power

7.1 Standard and Limit

According to 15.247(b)(3). For systems using digital modulation in the 902–928 MHz, 2400–2483.5 MHz, and 5725–5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. - 2) Set the spectrum analyzer to any one measured frequency within its operating range.
- 3) Set RBW = 2MHz, VBW = 6MHz, Sweep = Auto, Detector = Peak.
- 4) Measure the highest amplitude appearing on spectral display and mark the value.
- 5) Repeat the above procedures until all frequencies measured were complete.

8. Occupied Bandwidth

8.1 Standard and Limit

According to 15.247(a)(2), Systems using digital modulation techniques may operate in the 902–928 MHz, 2400–2483.5 MHz, and 5725–5850 MHz bands. The minimum 6 dB bandwidth shall be at least 500 kHz.

8.2 Test Procedure

According to the ANSI 63.10-2013, section 6.9, the emission bandwidth test method as follows.

- 1) Remove the antenna from the EUT and connect to the spectrum analyzer via a low loss RF cable.
- 2) Set the spectrum analyzer to any one measured frequency within its operating range.
- 3) Set RBW = 100kHz, VBW = 300kHz, Sweep = Auto.
- 4) Set a reference level on the measuring instrument equal to the highest peak value.
- 5) Measure the frequency difference of two frequencies that were attenuated 6dB from the reference level. Record the frequency difference as the emission bandwidth.
- 6) Repeat the above procedures until all frequencies measured were complete.

9. Maximum Power Spectral Density


9.1 Standard and Limit

According to FCC 15.247(e), For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8dBm in any 3 kHz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.

10. Band-edge Emission(Conducted)




Test Setup Block Diagram


