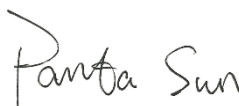



Frequency hopping spread spectrum systems are not required to employ all available hopping channels during each transmission. 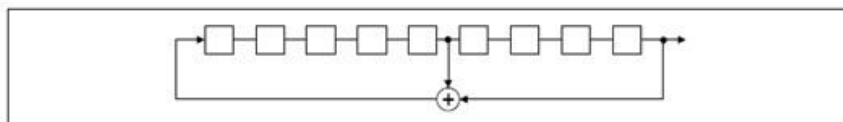

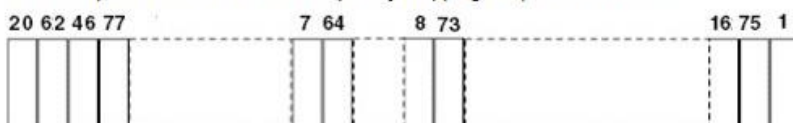
Linear Feedback Shift Register for Generation of the PRBS sequence

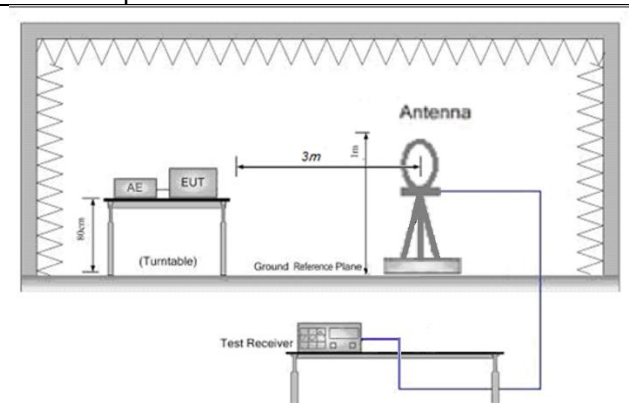


Figure 1. Below 30MHz

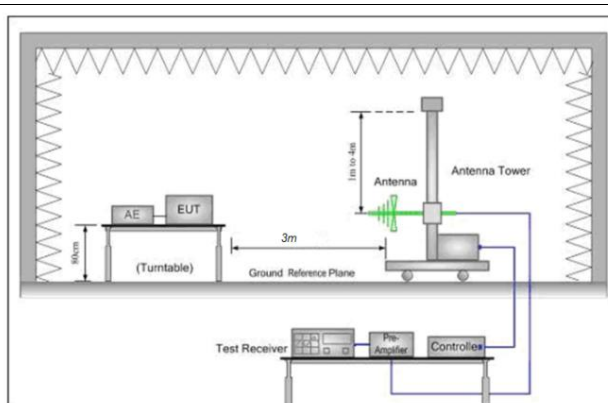


Figure 2. 30MHz to 1GHz

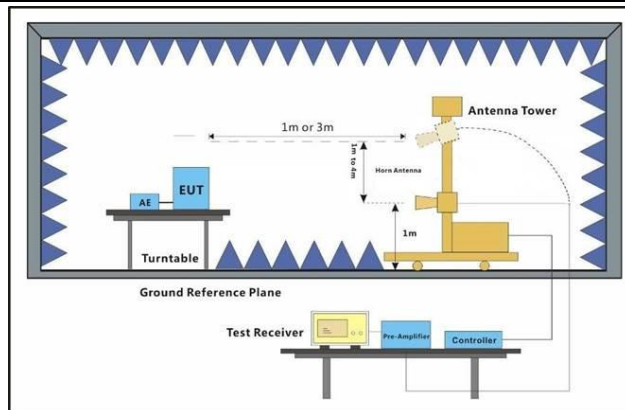


Figure 3. Above 1 GHz

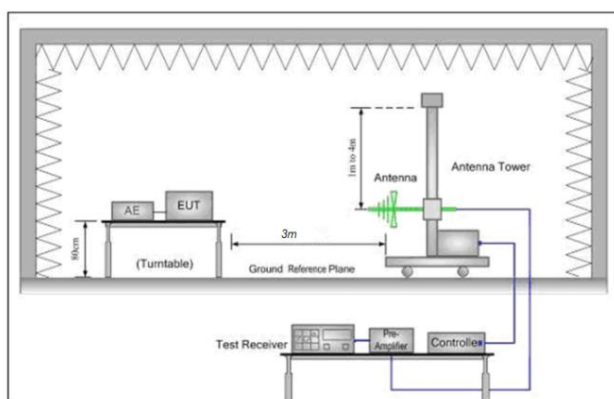


Figure 1. 30MHz to 1GHz

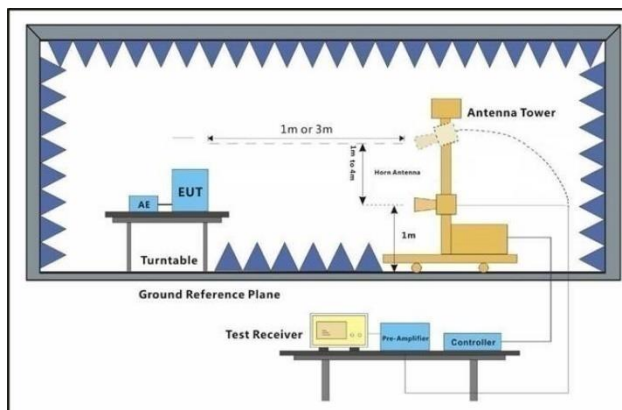


Figure 2. Above 1 GHz
