Calculation Formula: $Pd = (Pout*G)/(4*pi*r^2)$

Where

Pd = power density in mW/cm²

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

r = distance between observation point and center of the radiator in cm

Pd is the limit of MPE, 1mW/cm². If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

Therefore, the Max Power Density at R (20 cm) = $0.0013 \text{mW/cm}^2 < 0.6016 \text{mW/cm}^2$. So the EUT complies with the requirement.
