Introduction

The VC80x is a rugged vehicle mount computer that is designed to maximize productivity in harsh environments. The VC80x is intended for use in commercial and industrial applications with a focus on real time wireless data transactions which options suit materials handling applications in warehouses, manufacturing facilities, ports, yards, and freezers.

The VC80x's compact design improves visibility and reduces safety concerns while retaining a large screen size (10.4"). Its 802.11 a/b/g/n/ac WLAN provides real-time information that improves decision making, reduces errors, and enhances productivity.

Unpacking

The following items are contained in the box:

- VC80x vehicle computer
- VC80x Quick Start Guide.

Carefully remove all protective material from around the device and save the shipping container for later storage and shipping.

Removing Protective Film from Display

The front display of the VC80x is protected during transport by a transparent film. This film should remain on the front display during assembly to avoid damage to the front display surface. Only remove the film once all of the assembly work has been completed.

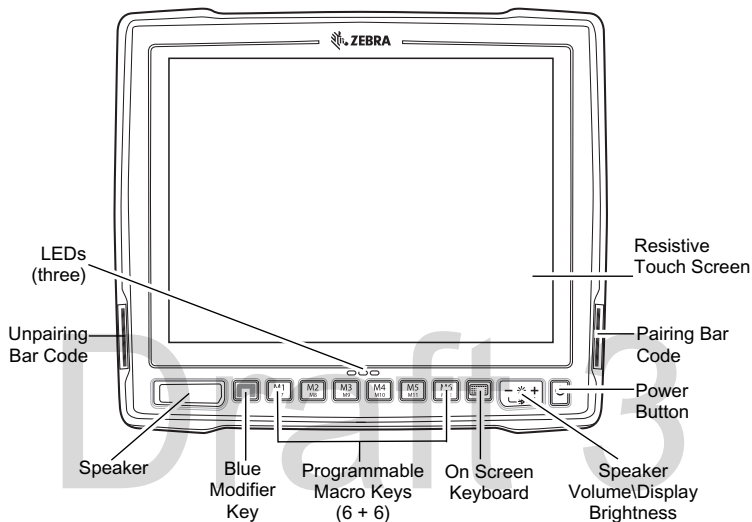

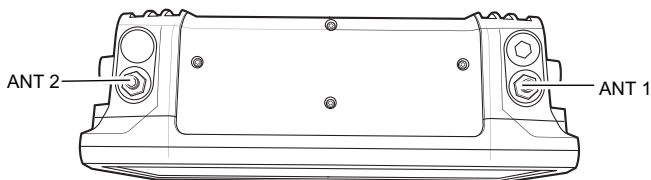

ANT 2 - Reverse Polarity Jack (WLAN) External Aux Antenna

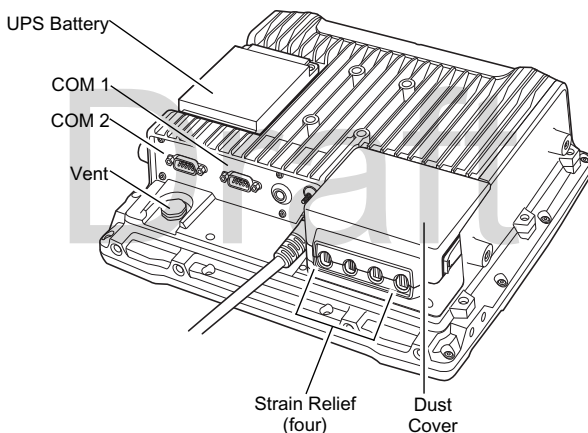

VC80x can be switched between internal and external antenna.

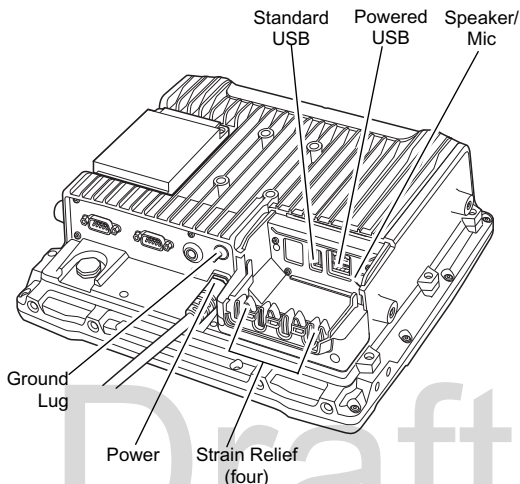

Setting up the Software on VC80x

To set up the VC80x software:

1. Connect the VC80x to an external power source.
2. Press and hold the **Power** button to turn on the VC80x (see Front View on page 4).
3. On VC80x with GMS software, following the Google Setup Wizard to set up a Google account.
4. If required, manually set the date and time.
 - a. Touch **Settings > Date & Time**.
 - b. Touch **Automatic date & time** switch to disable automatic date and time configuration.
 - c. Touch **Set Date** to set the current date.
 - d. Touch **Set Time** to set the current time.
 - e. Touch **Select time zone** to set the location time zone.

- f. Touch the Home button.
5. Connect the VC80x to a WLAN (see Wireless Network Configuration on page 7).
6. Select language settings:
 - a. Touch **Settings > Languages & input > Languages**.
 - b. Touch **Add Language** and select a language.
 - c. Drag the desired language to the top of the language list. The system language changes.
 - d. Touch Home button.

Wireless Network Configuration

To connect to the WLAN:

1. Touch **Settings > Wi-Fi**.
2. Scroll through the list and select the desired WLAN network.
3. For open networks, touch the profile once or touch and hold and then select **Connect to network** or for secure networks enter the required password or other credentials then touch **Connect**. See the system administrator for more information.
4. The VC80x obtains a network address and other required information from the network using the dynamic host configuration protocol (DHCP) protocol. To configure the VC80x with a fixed internet protocol (IP) address, Refer to the VC80x User Guide for Android Version 7.1.2.
5. In the Wi-Fi setting field, **Connected** appears indicating that the VC80x is connected to the WLAN.

Bluetooth

Power

Installation



CAUTION Do not install the vehicle computer in a location that affects vehicle safety, visibility, or ability to drive.

If mounted above head height, it is recommended to also use a safety strap with the mount bracket.

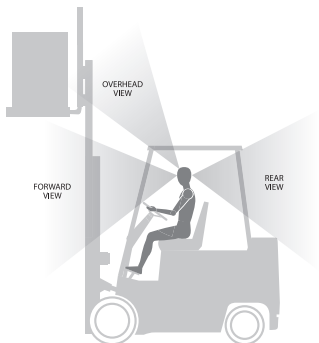
Installing the VC80x on a Forklift



IMPORTANT The vehicle front end connected fuse must meet UL 275.

1. Attach the desired mount to the VC80x. Refer to the VC80x User Guide for Android Version 7.1.2 at www.zebra.com/support for detailed mounting options and instructions.
2. Attach the mounted VC80x to the vehicle and position in a location that does not obstruct the operator's view.

3. If using an external antenna, connect antenna in a vertical position to the VC80x.



CAUTION Tighten peripherals with thumbscrews by hand only. Do not use tools for tightening thumbscrews.



NOTE If installing peripherals, allow enough space when selecting a mounting location.

4. Connect peripherals to the VC80x. Place the cables in the strain relief brackets inside the dust cover and replace the dust cover (see Back View on page 5).
5. Connect the VC80x to the vehicle DC supply.
6. Press the Power button to turn the device On or Off (see Front View on page 4).

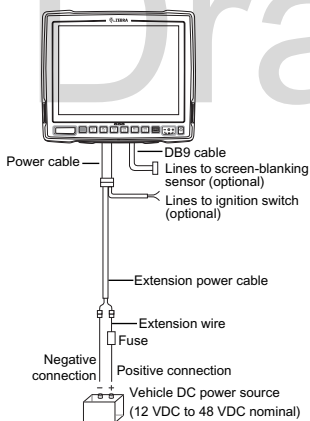

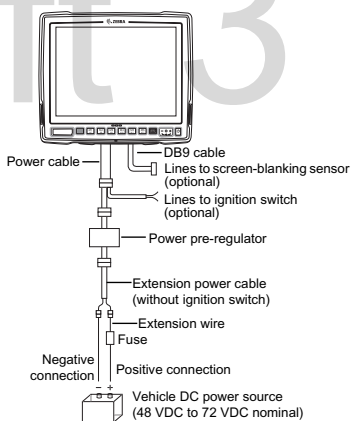
Without Power Pre-regulator

For vehicles with DC power greater than 48V



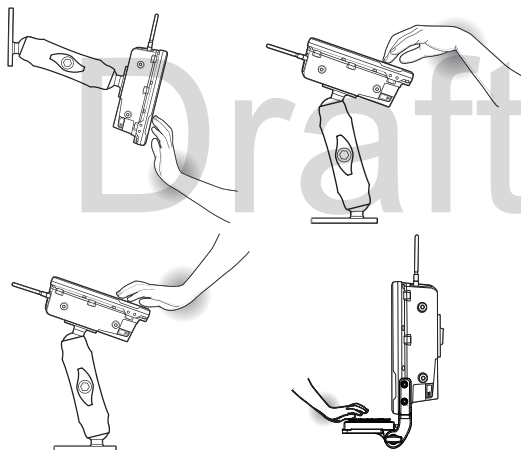

Mounting Safety

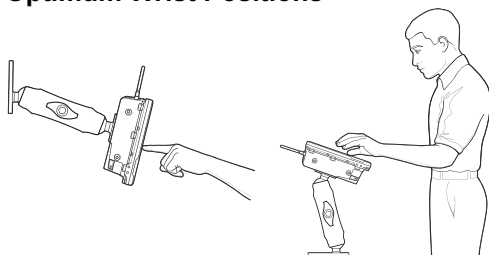

For Safe installation

- Do not cover an airbag.

Safety on the Road

Do not take notes or use the device while driving. Jotting down a 'to do' list or flipping through your address book takes attention away from your primary responsibility; driving safely.

When driving a car, driving is your first responsibility - Give your full attention to driving. Check the laws and regulations on the use of wireless devices in the areas where you drive. Always obey them.

When using a wireless device behind the wheel of a car, practice good common sense and remember the following tips:

1. Get to know your wireless device and any features such as speed dial and redial. If available, these features help you to place your call without taking your attention off the road.
2. When available, use a hands free device.
3. Let the person you are speaking with know you are driving; if necessary, suspend the call in heavy traffic or hazardous weather conditions. Rain, sleet, snow, ice, and even heavy traffic can be hazardous.
4. Dial sensibly and assess the traffic; if possible, place calls when you are not moving or before pulling into traffic. Try to plan calls when your car will be stationary. If you need to make a call while moving, dial only a few numbers, check the road and your mirrors, then continue.
5. Do not engage in stressful or emotional conversations that may be distracting. Make people you are talking with aware you are driving and suspend conversations that have the potential to divert your attention from the road.
6. Use your wireless phone to call for help. Dial the Emergency services, (9-1-1 in the US, and 1-1-2 in Europe) or other local emergency number in the case of fire, traffic accident, or medical emergencies. Remember, it is a free call on your wireless phone! The call can be made regardless of any security codes and depending on a network; with or without a SIM card inserted.
7. Use your wireless phone to help others in emergencies. If you see an auto accident, crime in progress, or other serious emergency where lives are in danger, call the Emergency Services (9-1-1 in the US, and 1-1-2 in Europe) or other local emergency number as you would want others to do for you.

8. Call roadside assistance or a special non-emergency wireless assistance number when necessary. If you see a broken-down vehicle posing no serious hazard, a broken traffic signal, a minor traffic accident where no one appears injured, or a vehicle you know to be stolen, call roadside assistance or other special non-emergency wireless number.

Use only Zebra approved batteries. Accessories which have battery charging capability are approved for use with the following battery models:

Part Number BT000254A01 (12.6 VDC, 2000 mAh).

Zebra approved rechargeable battery packs are designed and constructed to the highest standards within the industry.

However, there are limitations as to how long a battery can operate or be stored before needing replacement. Many factors affect the actual life cycle of a battery pack such as heat, cold, harsh environmental conditions, and severe drops.

When batteries are stored over six months, some irreversible deterioration in overall battery quality may occur. Store batteries at half of full charge in a dry, cool place, removed from the equipment to prevent loss of capacity, rusting of metallic parts, and electrolyte leakage. When storing batteries for one year or longer, the charge level should be verified at least once a year and charged to half of full charge.

Replace the battery when a significant loss of run time is detected.

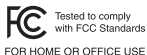

Battery Safety Guidelines

The area in which the units are charged should be clear of debris and combustible materials or chemicals. Particular care should be taken where the device is charged in a non-commercial environment.

- Follow battery usage, storage, and charging guidelines found in the user's guide.
- Improper battery use may result in a fire, explosion, or other hazard.
- To charge the mobile device battery, the battery and charger temperatures must be between +32°F and +104°F (0°C and +40°C).
