FAQ (Frequently Asked Questions)

1) Why does my R/C Vehicle not start?

Make sure that the car and transmitter are turned on.

Make sure the battery pack is fully charged and the battery is full.

Make sure the batteries are installed per polarity indicators.

Make sure all 4 wheels are not obstructed by any foreign objects.

Follow steps 1 and 2 in the "How to play" section to be sure that the automatic frequency matching is completed.

2) Why does my R/C Vehicle make unusual noises?

Check to make sure the battery pack is fully charged and the battery is full.

Check to make sure all 4 wheels are not obstructed by any foreign objects.

3) What if I'm still having a problem?

Check the FAQ and make sure all attempts have been made to make the unit work.

Check your purchase receipt date and make sure it's within the 30 days warranty period at the time you intend to send it back

Contact Maisto (see below), and tell us the model that you have, the problem(s) you are having, your daytime phone number, and any other information that might be helpful for us to resolve the problem. If Maisto cannot solve your problem by mail, email or telephone, we will issue a return authorization number so you can return the unit to us for repair or replacement. No returns will be accepted without a return authorization (RA) number issued by Maisto clearly marked on the outside of the package. Pack the unit back in its original box or another box with sufficient protective material, include a copy of your dated store receipt and a description of the problem then send it freight prepaid to the address which we will provide when we issue the RA number.



Charging the built-in rechargeable battery for the RC vehicle: (Refer to Diagram 1)

- 1. Use screwdriver to loosen the screw on the USB charging plug compartment cover and to open the cover. (Screwdriver is not included)
- 2. Take out the USB plug.
- 3. Make sure the switch is in the OFF/CHARGE position.
- 4. Locate a USB certified port from any of the devices shows below.
- 5. Plug in the USB charging plug to vehicle and USB certified port. 6. The LED indicator will start lighting in red to show it is charging.
- 7. Once the LED indicator turns off, the vehicle is fully charged.
- 8. Take out the USB plug from vehicle and USB certified port, then put it
- into the plug compartment and install the cover.

Battery installation for the controller: (Refer to Diagram 2)

- 1. Switch the power OFF.
- 2. Open the battery cover.
- 3. Install 2 new 1.5V "AA" LR6/R6 battery with correct polarity (+/-) as shown inside the battery compartment.
- 4. Install the battery cover.

How to play: (Refer to Diagram 3 & 4)


- Set the "Power Switch" on the controller and vehicle to ON position, the "Power LED" on both the controller and vehicle will flash less than 3 seconds then stay on, meaning the automatic frequency matching between the controller and the vehicle is completed.
- 2. If the "Power LED" of the controller or the "Power LED" of the vehicle flash more than 3 seconds, switch off both the vehicle and controller, then turn them on again.
- 3. Pull the trigger in the transmitter half way to drive the vehicle forward. Pull the trigger full way to obtain extra speed. Push the trigger in the transmitter to drive the vehicle backward.
- 4. Turn the steering knob in the transmitter to steer the vehicle to right or left. 5. If the vehicle went too far and out of control, switch off both the vehicle and
- controller, then turn them on again 6. If the vehicle does not run in a straight line, adjust the wheel alignment
- under the chassis
- 7. The "Power LED" on the vehicle will not flash nor stay on if the rechargeable battery has run out power.
- 8. Turn the switch of the controller and vehicle to OFF position when not in play.


Performance Tips:


- 1. Do not drive the vehicle on grass, sand or go through water.
- 2. Do not drive the vehicle in windy or rainy weather.
- 3. Do not drive the vehicle into any hard object.
- 4. Always switch the power to OFF on the transmitter and vehicle when you are done playing.
- 5. Keep fingers, hair and loose clothing away from the vehicle.
- 6. The operating range can be affected by a variety of factors:
 - a) Weak controller or vehicle batteries. b) Interference from other items that emit radio frequency signals such as another R/C item on the same frequency, CB radios, cordless phones, high voltage transmitter, etc.
- 7. Outdoor usage is recommended in order to get optimal control range. (132 feet or 40 meters) 8. Remove the package, take out all accessories and assemble the product before giving it to children to play.

Cautions:

- 1. The Built-in rechargeable battery must be charged before use.
- 2. Do not overcharge the Battery. Do not charge for more than 1.5 hours except for the initial two charges.
- 3. Do not charge the Battery if it shows leakage, corrosion, or has loose or exposed wires or other damage.
- 4. Do not cover the vehicle with any sort of material while charging.
- 5. Do not touch the vehicle when it is hot. Wait until the vehicle cools before recharging.
- 6. Do not dispose of the Battery in fire.









7. Do not dismantle the Battery or USB, and do not cut the Battery or USB cables.

- 8. The Battery will be warm after charging, and hot after use in a Vehicle.
- 9. The supply terminals are not to be short-circuited.
- 10. Rechargeable Batteries are not to be removed from the toy before being charged
- 11. Rechargeable batteries are only to be charged by an adult!
- 12.Battery change must only be made by adults! 13. The USB is not a toy.
- 14. Note that the 1.5V "AA" Battery is non-rechargeable and is not to be recharged. Only Batteries of the same or equivalent type as recommended are to be used. It will need replacement when transmission is poor. Alkaline AA batteries are recommended to be used for the transmitter. Do not mix alkaline, standard or rechargeable batteries. Do not mix old and new batteries or different type of batteries. Be sure to insert batteries with correct polarities and always follow the battery manufacturer's instructions
- 15.Exhausted batteries must be removed from the product.
