Power_Spectral_Density_NVNT_ANT1_2460



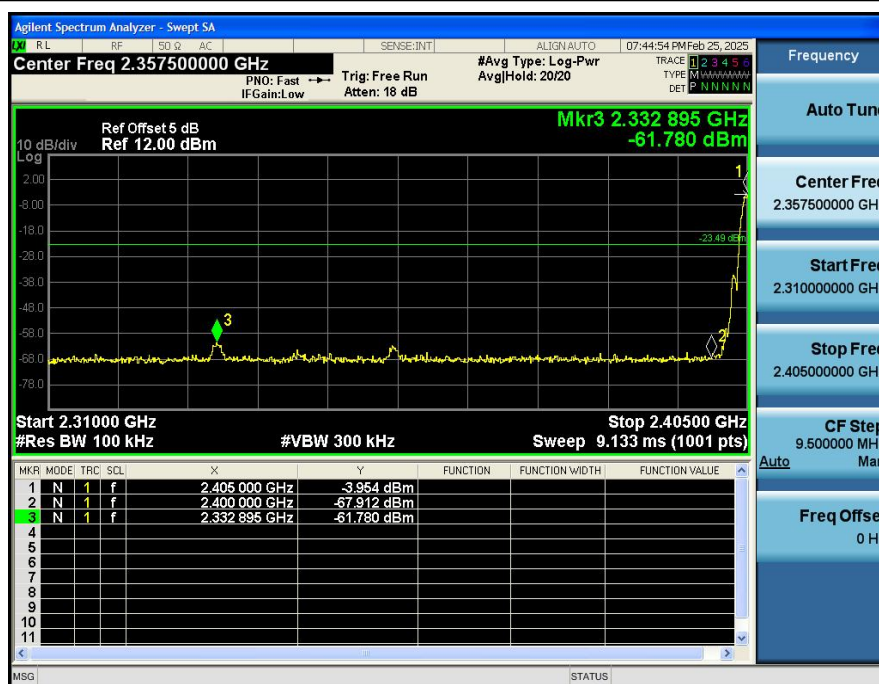
