


3.2 Test Procedure


- 1. Setup with frequency 3600-3620MHz and power level 17dBm/MHz
- 2. Enable AP service from Ruckus Cloud management
- 3. Check EUD Tx Frequency and power
- 4. Disable AP service from Ruckus Cloud management
 - a. Check EUD stops transmission within 10 seconds.
- 5. Setup with 3670-3690MHz & power level 7dBm/MHz
- 6. Enable AP service from Ruckus Cloud management
- 7. Check EUD Tx Frequency and power
- 8. Disable AP service from Ruckus Cloud management
 - a. Check EUD stops transmission within 10 seconds.




