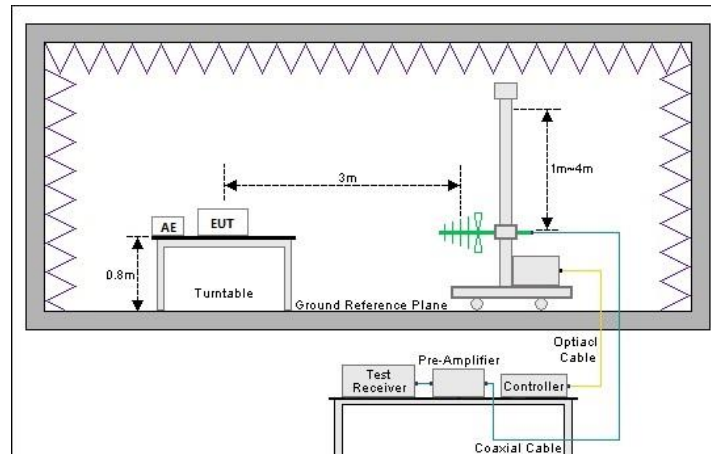

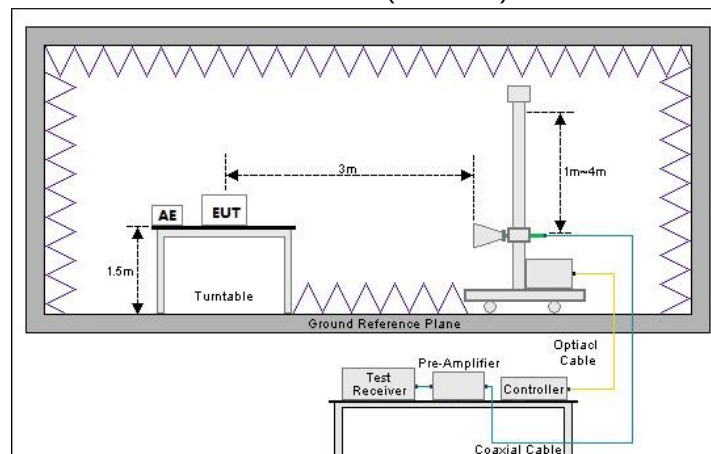

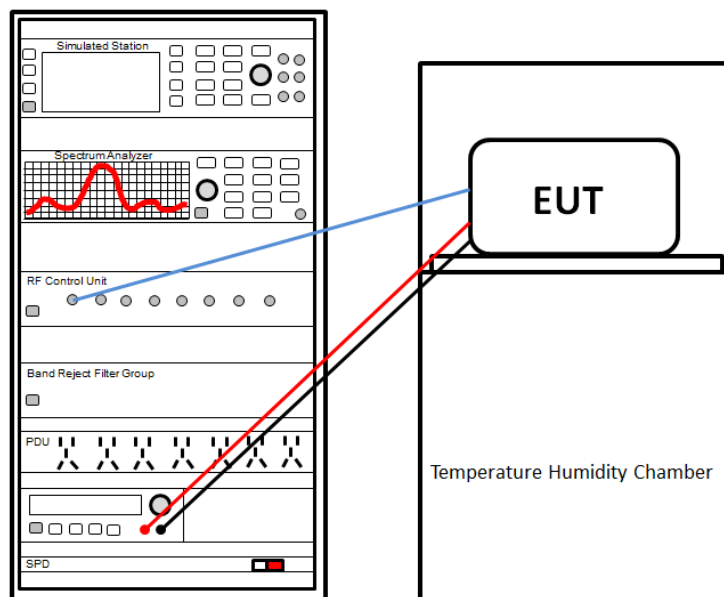


Above 1GHz (3m FAR)
