



RF EXPOSURE EVALUATION METHOD

Applicable standard :

In accordance with FCC 47 CFR part 2 (2.1093) this device has been defined as a portable device which is defined as a transmitting device designed to be used so that the radiating structure(s) of the device is/are within 20 centimeters of the body of the user.

Portable devices must be evaluated using the specified in FCC 47 CFR part 2 (2.1093) and ANSI/IEEEC95.1-1992. and had been tested in accordance with the measurement methods and procedures specified in IEEE 1528-2003.

Per FCC KDB 447498 D01 v06, the 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

SAR Test Exclusion Thresholds for 100 MHz – 6 GHz and ≤ 50 mm

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

$[(\text{max. power of channel, including tune-up tolerance, mW})/(\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}] \leq 3.0$ for 1-g SAR and ≤ 7.5 for 10-g extremity SAR, where $f(\text{GHz})$ is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation

The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion.

-0.68dBi logarithmic terms convert to numeric result is nearly 0.855

2dBm=1.58mW

2402MHz

$$\frac{[(\text{max. power of channel, including tune-up tolerance, mW})/(\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}]}{1.58/5} = 1.58/5 \cdot \sqrt{2.402} = 0.49 \leq 3.0$$

Threshold at which no SAR required is 10mw and ≤ 3.0 for 1-g SAR, Separation distance is 5mm.

2441MHz

$$\frac{[(\text{max. power of channel, including tune-up tolerance, mW})/(\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}]}{1.58/5} = 1.58/5 \cdot \sqrt{2.441} = 0.494 \leq 3.0$$

Threshold at which no SAR required is 10mw and ≤ 3.0 for 1-g SAR, Separation distance is 5mm.

2480MHz

$$\frac{[(\text{max. power of channel, including tune-up tolerance, mW})/(\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}]}{1.58/5} = 1.58/5 \cdot \sqrt{2.48} = 0.498 \leq 3.0$$

Threshold at which no SAR required is 10mw and ≤ 3.0 for 1-g SAR, Separation distance is 5mm.

Conclusion: No SAR is required.
