### CARRY

Wireless Charging Power Bank

Power On Press and hold the button for I second to power on your CARRY.



#### **Charge Wirelessly**

Place your wireless charging device on the CARRY to charge.

Note: Improper alignment may impact connection. You may also charge your device using a USB-C cable.

### Re-Charge, Wirelessly

Place your CARRY on a compatible wireless charger to re-charge.

Note: All Courant charging trays are compatible. CATCH:I shown below. You may also re-charge your CARRY using the provided USB-A to USB-C cable.



Wireless In, Wireless Out Your CARRY can charge a device and be re-charged wirelessly, at the same time. Note: Charging speeds may be affected.



### Battery Check Tap button to check battery level.





Power Off Press and hold the button for I second to power down your CARRY.



### USB-C Input & Output

CARRY is compatible with USB-C, allowing you to charge both in  $\ensuremath{\widetilde{\Delta}}$  out at 18W Power Delivery.

Note: only "USB-C to USB-A" cable included in the box.
