GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The *Sky Phone LLC's* product, model number: Platinum M4 (FC*C ID: 2ABOSSKYPLATM4*) or the "EUT" in this report was a *3G Smart Phone*, which was measured approximately: $12.5 \text{ cm } (L) \times 6.5 \text{ cm } (W) \times 1.1 \text{ cm } (H)$, rated with input voltage: DC 3.7 V battery or DC 5V from adapter. All measurements contained in this report were conducted with ANSI C63.4-2014, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.





Maximizing procedure was performed on the six (6) highest emissions of the EUT.



AC 120V/60 Hz, Line







Test Procedure

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detector mode from 30 MHz to 1 GHz and PK and average detector modes for frequencies above 1 GHz.

Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Factor + Cable Loss - Amplifier Gain

The "Margin" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7 dB means the emission is 7 dB below the limit. The equation for margin calculation is as follows:

Margin = Limit – Corrected Amplitude


Vertical - Peak




Horizontal - Average









Vertical - Average
