


Mesh Front Clip BT Speaker

Instructions:

Be sure to fully charge the speaker before using for the first time.

Charging the Speaker:

Connect the provided charging cable to a power source and to the Type C port on the speaker (3).
The LED indicator light will glow red when charging and turn to blue when fully charged.

Bluetooth Setup:

Press and hold On/Off button, LED Indicator will then flash Blue and Red
Turn on the Bluetooth function on the mobile device, Select "25265" pairing name.
Speaker will automatically pair if the mobile device has been paired before.
Press and hold On/Off button to turn off the device.

Incoming Calls:

If receiving an incoming call, audio will automatically pause and will begin to play again when call ends.
Press the On/Off button for 2s to reject the call.

Safety Precautions:

WARNING-When using this product, basic precautions should always be followed:
1.Read all the instructions before use.
2.Never store or use this product in temperatures below 32°F(0°C) or above 115°F(45°C).
3.The unit's full performance is achieved only after 2 or 3 completed charge and discharge cycles.
