The antenna is a **3216 Chip Antenna** which permanently attached, and the best case gain of the antenna is **3.25dBi**. It complies with the standard requirement.













6. Channel Separation

Test Limit:	Refer to 47 CFR 15.247(a)(1), Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater.
