

During testing channel & power controlling software provided by the customer was used to control the operating channel as well as the output power level. The RF output power selection is for the setting of RF output power expected by the customer and is going to be fixed on the firmware of the final end product.

- 2. For radiated emission, 3 axis were chosen for testing for each applicable mode.
- 3. The EUT used fully charge battery when tested.
- 4. During the test, the dutycycle>98%, the test voltage was tuned from 85% to 115% of the

Nominal rate supply votage, and found that the worst case was the nominal rated supply condition, So the report just shows that condition's data

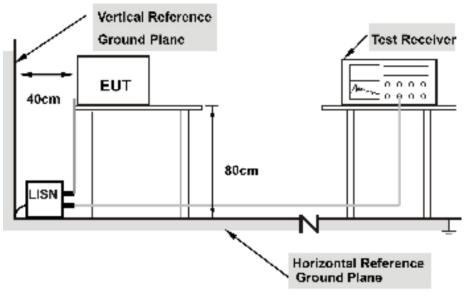

The EUT was 0.8 meters from the horizontal ground plane and 0.4 meters from the vertical ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipments powered from additional LISN(s). The LISN provide 50 Ohm/ 50uH of coupling impedance for the measuring instrument.

7. POWER SPECTRAL DENSITY

7.1 LIMIT

For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8dBm in any 3 kHz band during any time interval of continuous transmission.

7.2 TEST PROCEDURE

(1) Connect EUT's antenna output to spectrum analyzer by RF cable.



8.2 TEST PROCEDURE

- a. The measuring distance of at 3 m shall be used for measurements at frequency 0.009MHz up to 1GHz,and above 1GHz.
- b. The EUT was placed on the top of a rotating table 0.8 meters (above 1GHz is 1.5 m) above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- c. The height of the equipment shall be 0.8 m(above 1GHz is 1.5 m); the height of the test antenna shall vary between 1 m to 4 m. horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. The initial step in collecting conducted emission data is a spectrum analyzer peak detector mode pre-scanning the measurement frequency range. Significant peaks are then marked and then QuasiPeak detector mode re-measured.
- e. If the Peak Mode measured value compliance with and lower than Quasi Peak Mode Limit, the EUT shall be deemed to meet QP Limits and then no additional QP Mode measurement performed.

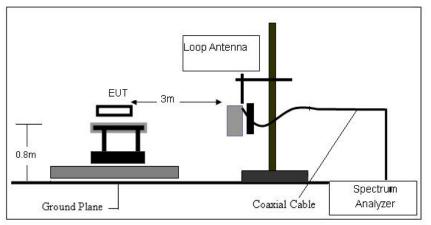

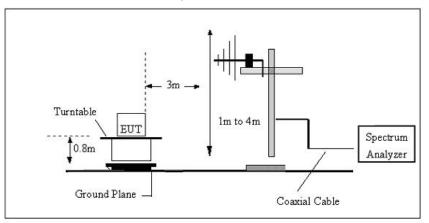


(A) Radiated Emission Test-Up Frequency Below 30MHz




