# Section 1 Evaluation summary

## 1.1 SAR exemption for standalone transmission

## 1.1.1 References, definitions and limits

#### FCC §2.1093

Jemkc

(2) The SAR limits for general population/uncontrolled exposure are 0.08 W/kg, as averaged over the whole body, and a peak spatial-average SAR of 1.6 W/kg, averaged over any 1 gram of tissue (defined as a tissue volume in the shape of a cube). Exceptions are the parts of the human body treated as extremities, such as hands, wrists, feet, ankles, and pinnae, where the peak spatial-average SAR limit is 4 W/kg, averaged over any 10 grams of tissue (defined as a tissue volume in the shape of a cube). Exceptions are the period not to exceed 30 minutes to determine compliance with general population/uncontrolled SAR limits.

4.3.1 Standalone SAR test exclusion considerations

During normal operation, user extremities can come within 20 cm of the internal antenna and therefore product is considered as "Portable".

The 1-g head or body and 10-g extremity SAR test exclusion thresholds for 100 MHz to 6 GHz at Test separation distances  $\leq$  50 mm are determined by:

[(max. power of channel, including tune-up tolerance, mW) ÷ (min. test separation distance, mm)] ×

 $[v(F_{(GHz)})] \le 3.0$  for 1-g head or body SAR, and  $\le 7.5$  for 10-g extremity SAR, where

- $F_{(\text{GHz})}$  is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation

The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is  $\leq$  50 mm, and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm according to section 4.1(f) is applied to determine SAR test exclusion
