
















Fig.3 Right Head Section / Cheek-Touch Position






Fig.4 Right Head Section / Ear-Tilt Position(15°)






Fig.5 Left Head Section / Cheek-Touch Position






Fig.6 Left Head Section / Ear-Tilt Position(15°)






Fig.7 EUT Back side to flat phantom




Fig.8 EUT front side to flat phantom






Fig.9 EUT back side to flat phantom






Fig.10 EUT bottom side to flat phantom




Fig.12 EUT right to flat phantom






Fig.13 EUT left to flat phantom




Fig.16 Antenna position of EUT
