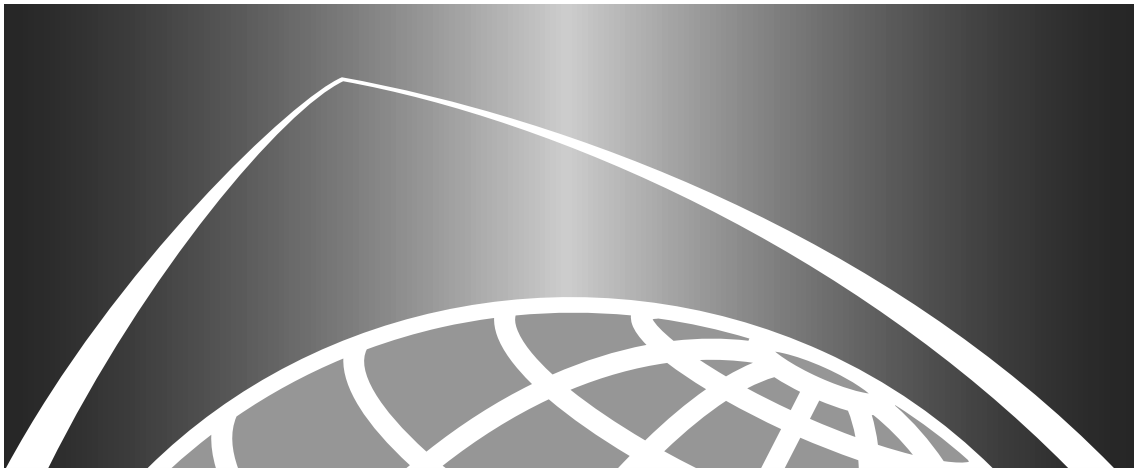

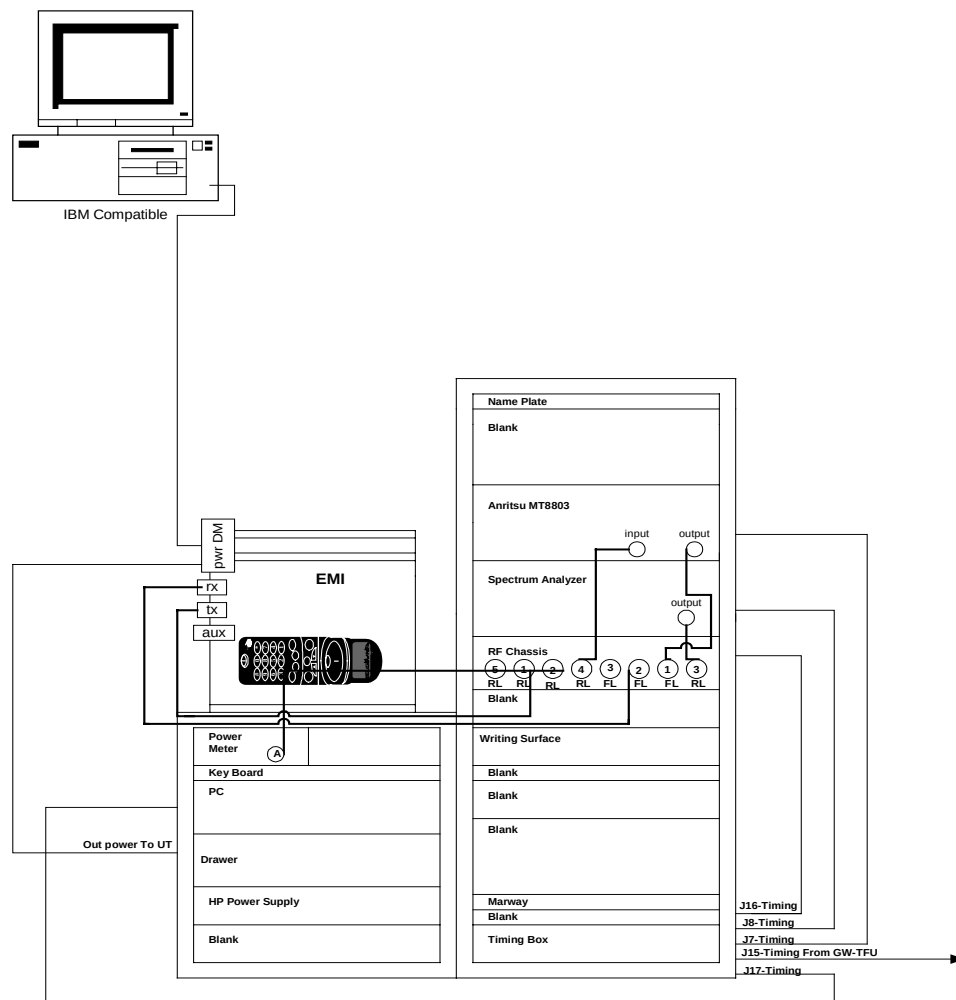


Figure 3-1 GS Reverse Link Test Rack

4. Procedures

4.1 General

4.1.1 Measurement Notes

The MT8803G and FSEM20 are controlled by buttons, and “softkeys” that appear as the user selects various “screens” of the instruments. To reach a specific function, the user has to select down through several screens until the final function required is available using the softkeys on the right-hand and bottom borders of the screen. This procedure assumes that user is familiar with the instrument, and it does not attempt to describe the process of paging through the various screens for each selection made in each test. Only when the test is sequence specific does this procedure specify the process of selecting the appropriate function.

4.1.2 Calibration

4.1.2.1 Before beginning the procedural elements of the test, ensure the Globalstar Reverse Link Test Rack has been calibrated according to the Appendix.

4.1.3 Test Sequences

4.1.3.1 It is impossible to set up a single call and perform all tests, tearing a call down, and shifting to the next channel to repeat the process. Where tests begin from common call parameters (service option, data rate, etc.) tests may be grouped together to avoid unnecessary multiple call set up/tear down sequences.

4.1.3.2 Unless otherwise specified herein, required TX channels are 1, 3, 6, 9, & 13. In some cases, multiple call set up / tear downs are required on the same frequency channel.

4.1.3.3 In the test report, highlight any signal levels or conditions that fail the identified criteria.

4.2 Access Probe Power Time Response

4.2.1 Definition

This test measures the pulse shape of the Access Probe transmitted on the Access Channel during a call set up

4.2.3 Setup

4.2.3.1 From the defaults:

4.2.3.2 Set the MT8803G Access Probes according to the following table:

8 **4.2.4 Measurement Method**

4.2.4.1 If the User Terminal is not currently “IDLE Register”ed, or terminated from an earlier successful “Call”, turn the power to the User Terminal Off and then On. Wait for the MT8803G state to go to “IDLE Register”.

4.2.4.2 Set the level of the Video Level Trigger on the spectrum analyzer to a level of - 25 dBm.

4.2.4.3 Test 1: Access Probe Pulse Width.

4.2.4.4 Select the Measurement Window of the MT8803 to “Access Probe Power”, press “Start”.

4.2.4.5 Scan the spectrum Analyzer marker from left to right recording all values of power for each step of the marker.

4.2.4.6 Moving from left to right, find the first marker where the power level exceeds the first marker level by at least 55 dB. Count in by 5 marker positions and record the time position of this marker. This will be designated M_1 .

4.2.4.7 Continuing to the right find the next marker time position where the power level value is at least 10 dB less than the marker whose time position was recorded. Count back by 5 marker positions and record the time position of this marker as M_2 .

4.2.4.8 Find the average power level P_{avg} of the sample values between the two identified marker positions, M_1 , M_2 .

4.2.4.9 Using the marker positive and negative peak feature, rescan the spectrum analyzer display and find the maximum positive and negative power peaks in between the two time positions M_1 , M_2 . Ensure these values do not exceed ± 1.5 dB from the average power value calculated.

4.2.4.10 From the recorded values, find the first marker position to the left of M_1 , that has a value less than 1.5 dB below the average power value calculated. Record this marker as time position M_{12} .

4.2.4.11 Then find the first marker position to the right of the second marker, M_2 , where the power level is less than 1.5 dB below the average power value calculated. Record this marker as time position M_{22} .

4.2.4.11.1 Calculate the total time between M_{21} and M_{22} , T_{M21-22} .

4.2.4.12 Test 2: Access Probe Rise Time

4.2.4.12.1 Clear the spectrum analyzer display and ready a single sweep.

4.2.4.12.2 Set the span time of the spectrum analyzer for 7 microseconds.

4.2.4.13 Set the Pre Trigger to "0" (Zero).

4.2.4.13.1 Press "start" on the MT8803G.

4.2.4.13.2 Test the spectrum analyzer to acknowledge the spectrum analyzer triggered.

4.2.4.13.3 Scan the spectrum Analyzer marker from left to right recording all values of power for each step of the marker.

4.2.4.13.4 Moving from left to right, find the first marker where the power is within ± 1.5 dB of the average pulse power level, P_{avg} , in test 1. This is position M_3 .

4.2.4.13.5 Find the first marker to the left of M_3 where the power level is at least 20 dB down from the average pulse power level, M_4 .

4.2.4.13.6 Find the time difference between M_3 and M_4 , T_{M3-4} .

4.2.4.14 Test 3:

4.2.4.14.1 Clear the spectrum analyzer display.

4.2.4.14.2 Set the trigger of the spectrum analyzer to be negative going.

4.2.4.14.3 Press “start” on the MT8803G.

4.2.4.14.4 Scan the spectrum Analyzer marker from left to right recording all values of power for each step of the marker.

4.2.4.14.5 Moving from left to right, find the last marker where the power is within ± 1.5 dB of the average pulse power level, P_{avg} , in test 1. This is position M_5 .

4.2.4.14.6 Find the first marker to the right of M_5 where the power level is at least 20 dB down from the average pulse power level, M_6 .

4.2.4.14.7 Find the time difference between M_5 and M_6 , T_{M5-6} .

1 4.2.5 Criteria

4.2.5.1.1 The power of the Access Probe shall be within the range of 23.0 ± 0.5 dB.

4.2.5.1.2 Ensure the value of T_{M21-22} is within $20 \times X$ milliseconds ± 12.0 microseconds.

4.2.5.1.3 Ensure the value of T_{M3-4} is < 6.0 microseconds.

4.2.5.1.4 Ensure the value of T_{M5-6} is < 6.0 microseconds.

2 4.2.6 Test Report

4.2.6.1 Tabulate the average power level in test 1.

4.2.6.2 Tabulate the time of the pulse, T_{M21-22} .

4.2.6.3 Draw the waveform created from the samples in test 2, showing the power level on the Y axis with respect to time on the X axis, and limit lines.

4.2.6.4 Tabulate the rise time of the pulse, T_{M3-4} .

4.2.6.5 Draw the waveform created from the samples in test 1, showing the power level on the Y axis with respect to time on the X axis, and limit lines.

4.2.6.6 Tabulate the fall time of the pulse, T_{M5-6} .

4.2.6.7 Draw the waveform created from the samples in test 3, showing the power level on the Y axis with respect to time on the X axis, and limit lines.

4.3 Access Channel Waveform Quality, Timing, and Frequency Accuracy

4.3.1 Definition

This test will verify the Access Channel waveform quality, timing error, and frequency error requirement.

4.3.2 Reference

4.3.2.1 80-70129-1, 3.3.2

4.3.3 Setup

4.3.3.1 Set the MT8803G MAX_REQ_SEQ = 3

4.3.3.2 Set the MT8803G to the Reverse Link Frequency equal to the appropriate CDMA Channel.

4.3.3.3 Invoke the Modulation Parameters Screen on the MT8803G.

4.3.3.4 Invoke the Access Channel Parameters Screen on the MT8803G.

4.3.3.5 Power on the UT and wait for the UT to register.

4.3.4 Measurement Method

4.3.4.1 Invoke a continuous flow of measurements followed by “Start” on the MT8803G in the Call processing screen.

4.3.4.2 Collect the Rho measurements made by the MT8803G.

4.3.4.3 Collect the Frequency Error Measurements made by the MT8803G.

4.3.4.4 Collect the Timing Error Measurements made by the MT8803G.

4.3.4.5 Repeat the measurements for a 95% confidence level.

4.3.5 Criteria:

4.3.5.1 The Access Channel values for Rho must meet the requirements of the Minimum Performance Standard Section 3.3.1.1.

4.3.5.2 The Access Channel values for TX Frequency variation must meet the requirements of the Minimum Performance Standard Section 3.3.1.1.

4.3.5.3 The Access Channel values for Timing error must meet the requirements of the Minimum Performance Standard Section 3.3.1.1.

1 **4.3.6 Test Report**

4.3.6.1 Tabulate the maximum, minimum, and standard deviation for the Rho measurement data for each channel tested.

4.3.6.2 Tabulate the maximum, minimum, and standard deviation for the TX Frequency variation measurement data for each channel tested.

4.3.6.3 Tabulate the maximum, minimum, and standard deviation for the Timing Error measurement data for each channel tested.

2 **4.4 Minimum Controlled Output Power**

3 **4.4.1 Definition**

4 This test demonstrates that the User Terminal can sustain the minimum output
5 power conditions at a sustained minimum data rate. The test equipment is used to
6 synthesize the GW control functions (Power Control Bits).

8 **4.4.3 Setup**

4.4.3.1 Defaults

9 **4.4.4 Measurement Method**

4.4.4.1 If the User Terminal is not currently "IDLE Register"ed, or terminated from an earlier successful "Call", turn the power to the User Terminal Off and then On. Wait for the MT8803G state to go to "IDLE Register".

4.4.4.2 Set up an SO2001 Loopback call at 2400 bps.

4.4.4.3 Perform NW Originate and wait for the User Terminal to advance to the “Conversation” state as observed on the MT8803G.

4.4.4.4 Measure the User Terminal output channel power on the Spectrum Analyzer.

4.4.4.5 Send 1's power control bits to the User Terminal on the Forward Channel until the calibrated channel power on the spectrum analyzer consistently reads < 10.0 dBm/1.23 Mhz, then send alternating 1's and 0's power control bits.

4.4.4.6 Sustain the call for at least 30 seconds.

4.4.4.7 Terminate the “Call” and repeat for all channels 1, 3, 6, 9, and 13.

1 **4.4.5 Criteria**

4.4.5.1 The User Terminal must be able to sustain the “Call” at a level less than 10 dBm/1.23 MHz.

2 **4.4.6 Test Report**

4.4.6.1 Tabulate the Minimum Controlled Output Power value sustained.

4.4.6.2 If the call drops before the 30 seconds has elapsed, indicate “Call Dropped” and “Fail”

3 **4.5.4 Measurement Method**

4.5.4.1 If the User Terminal is not currently “IDLE Register”ed, or terminated from an earlier successful “Call”, turn the power to the User Terminal Off and then On. Wait for the MT8803G state to go to “IDLE Register”.

4.5.4.2 Test 1: Select the Measurement Window of the MT8803 to “Access Probe Power”, press “Start” and wait for the MT8803G to display the measurement results.

4.5.4.3 Record the values of power for each probe.

4.5.4.4 Record the total number of probes.

4.5.4.5 Record the values of Standby Power between each probe.

4.5.4.6 Terminate the “Call” and repeat the test for channels 1, 3, 6, 9, and 13.

4.5.4.7 Test 2: Select the Measurement Window of the MT8803 to Access Probe Power and wait for the MT8803G to display the measurement results.

4.5.4.8 Record the values of power for each probe.

4.5.4.9 Record the total number of probes.

4.5.4.10 Record the values of Standby Power between each probe.

5.1 Appendix A Test Set Calibration Procedures

5.1.1 Minimum calibration requirements

5.1.1.1 All test equipment shall have been powered up at stabilized at the ambient room temperature for at least 24 Hours prior to performing the calibration.

5.1.1.2 Calibration Intervals:

5.1.1.2.1 The Gigatronix Power Meter shall be calibrated on an interval of no less than 6 months.

5.1.1.2.2 All other instruments shall be maintained on a calibration interval consistent with standards set by the test equipment support organization.

5.1.1.2.3 Calibration of the test system shall occur at the beginning of the test sequence for each individual User Terminal Tested. Calibration of the test system shall occur no less than every 48 hours of use thereafter.

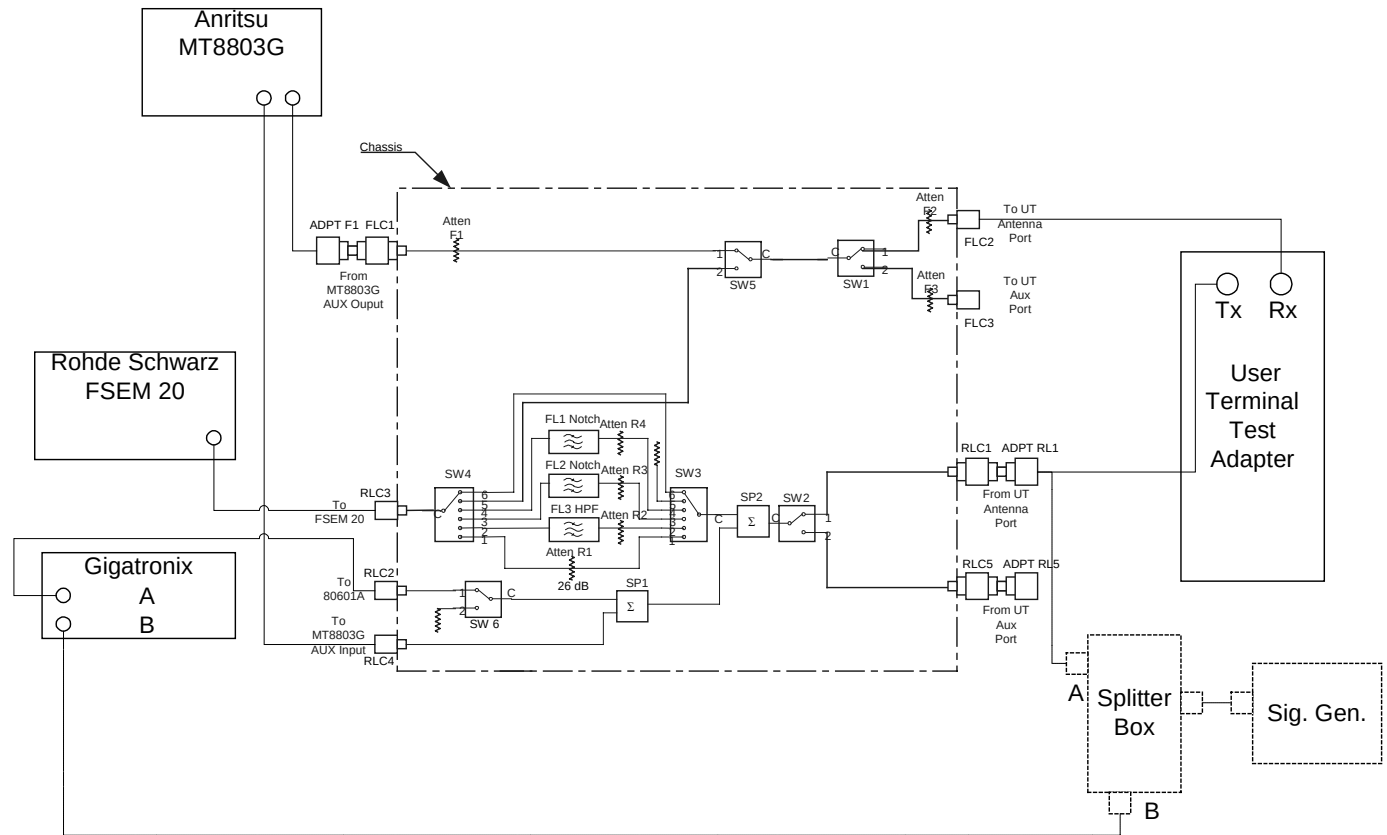


Figure 5-1 Tester Block Diagram

5.1.2 Power Meter Calibration

Prior to performing calibration on the test system, the Power Meter must be calibrated to the reference.

5.1.2.1 Power Head "A".

5.1.2.1.1 Attach power head "A" to the calibrator output of the Power Meter.

5.1.2.1.2 Set the frequency of operation for 1618.11 Mhz.

5.1.2.1.3 Set the "Mode" for "Modulation".

5.1.2.1.4 Press the "Zero" key and wait for the display to indicate the calibration complete.

5.1.2.1.5 Remove the power head from the calibrator and install a 50 ohm termination.

5.1.2.1.6 Again press the “Zero” key and wait for the display to indicate the process to be complete. Remove the termination.

5.1.2.2 Power Head “B”.

5.1.2.2.1 For Power Head “B”, repeat the same process as for “A”.

5.1.3 Test Rack Calibration

All power level measurement criteria in the Procedures section of this document are with respect to the antenna connectors of the User Terminal, unless otherwise specified herein. Connectivity between the User Terminal Under Test and the instrumentation necessitates:

- User Terminal to test set test adapter and cable
- RF Conditioning Matrix to separate, switch, and filter signals appropriately
- Cabling between the instrumentation & RF Matrix

Because the measurements necessitate the use of cables, switches and other conditioning equipment in the measurement path(s), the effects of these elements parasitically influence the indicators on the instruments used, and must be calibrated out of the final measurements.

In every measurement of the procedure, the final criteria assumes that the measurement result has been corrected for these parasitic influences, and include:

- The Instrument reading(s) corrected relative to power head A of the Gigatronix Power Meter
- The Gain (negative for a loss) of the Test Adapter and Cable
- The Gain (negative for a loss) of the RF Matrix path to the instrument
- The Gain (negative for a loss) of the cable between instrument and RF Matrix.

This section provides the means to identify and measure the separate influences associated with the path between the User Terminal antenna connector and the measuring instrument.

5.1.4 UT-Specific XMT Test Adapter Calibration

5.1.4.1 The UT Test Adapter has a cable that mates with the UT Transmit connector on one end and a standard SMA Female to N Female adapter/connector on the other. It may also have an in-line attenuator with SMA connector. Remove the N to SMA adapter and Attenuator, a/r, and set them aside.

5.1.4.2 To perform this calibration, use a cable of exactly the same type and length as the Test Adapter cable, with the same SMA type connector on one end, and a mating connector of the type on the Test Adapter Cable connecting to the UT, on the other end. When connected together using the UT mating connectors, these 2 cables will provide a joined length of cable with same sex SMA connectors at both ends.

5.1.4.3 Obtain another cable of the same type as the Test Adapter Cable with SMA connectors of the same sex, and exactly the same total length + .05" as the combined cables above, but without the UT mating connectors.

5.1.4.4 Connect the signal generator to the Splitter Box. Set the signal generator level to produce an output power level of 0 dBm + 1 dB @ 1.62 GHz per the Gigatronix Power Meter. Run the full set of frequencies as in Calibration step #1, recording the difference (A-B) between the power heads as A'.

5.1.4.5 Connect the single piece cable through N to SMA adapters between the A output of the Splitter Box and the Power Meter Power Head A.

5.1.4.6 Run the full set of frequency steps logging the reading on the A & B power heads, and subtracting them from the values in the array for A', and temporarily store this one-dimensional array of values as X ($=B+A'-A$).

5.1.4.7 Replace the single piece cable and SMA connectors at the N adapters, with the combination Test Adapter cable and run the frequency steps again taking the readings at A & B ($=B+A'-A$) and storing as a Y array.

5.1.4.8 If an attenuator is used in the Test Adapter Cable, reconnect the attenuator in the cable as required, restoring all adapters. Run the full set of frequency steps again, and take the A & B power readings again and store as the Z array ($=B+A'-A$). Subtract the Z array from the Y array and replace the resultant values in the Z array. Otherwise, skip this step.

5.1.4.9 Subtract the Y array from the X array and divide the result of each element by 2 and replace in the Y array.

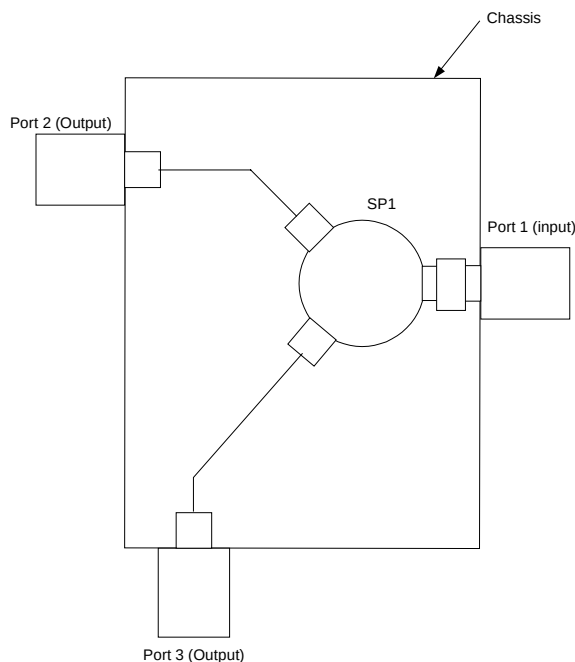
5.1.4.10 Divide the elements in the X array by 2 and replace in the X array.

5.1.4.11 Add the X, Y, and Z(if applicable) arrays together and replace element by element in the X array. Discard the A', Y, and Z arrays. The X array will be the table of insertion loss values for the Test Adapter. This value shall be added to the other calibration values set up for the various paths in the RF matrix, as required when making measurement.

1 5.1.5 RF Matrix Calibration:

5.1.5.1 Set up Reference Frequency and Power Source

5.1.5.1.1 Use the Splitter Calibration Box with the Frequency Source connected to it with a flexible cable.

5.1.5.1.2 The “B” power meter head should always be attached to the “B” N connector (bottom) of the Splitter Box. Once started, do not disconnect or re-torque this power head from the Splitter Box during calibration. Otherwise calibration shall have to be begun again.

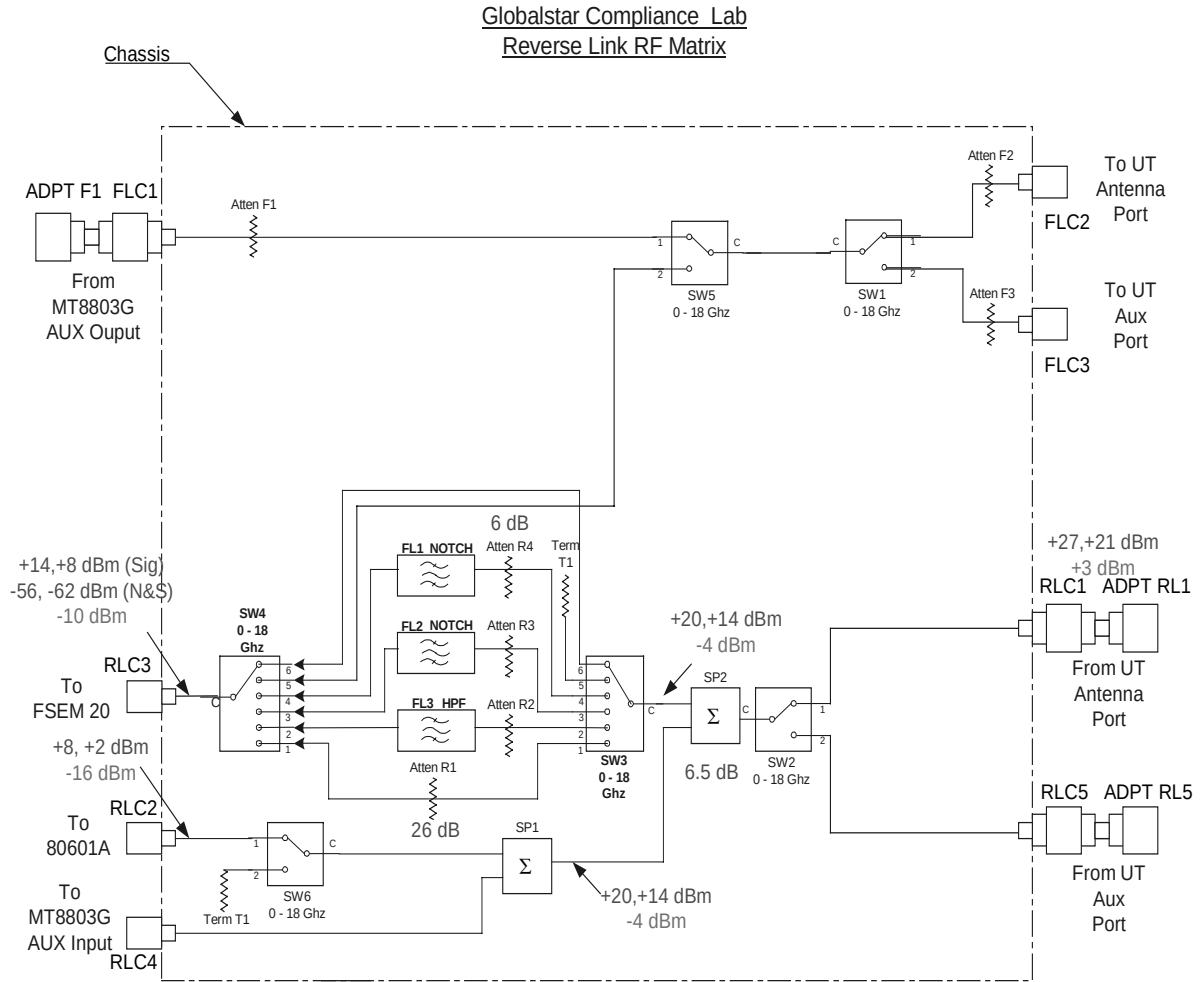


Figure 5-3 Reverse Link RF Matrix

5.1.5.1.3 Do not use adapters except as provided for by this procedure or by the design of the tester.

5.1.5.1.4 Before starting, ensure all associated instrumentation is connected to the RF connectors on the RF Matrix. In the case of the Spectrum Analyzer, temporarily connect a 50 dB precision attenuator between RLC3 and the Spectrum Analyzer input connector.

5.1.5.1.5 Frequency Span of Spectrum Analyzer must be set to 20% more than span of lowest and highest frequency in the sweep range.

5.1.5.1.6 When performing calibration steps, with the CW signal Generator set “Number of Averages” to 4 on the Spectrum Analyzer when using “Average” Mode detection. Allow for time to take the 4 averages before logging the level. For actual measurements, unless specified in the particular test step, use a minimum of 50 averages.

5.1.5.1.7 Set Spectrum Analyzer Attenuator to Zero for all calibrations and measurements.

5.1.5.1.8 Loss Values are expressed as algebraically positive numbers.

5.1.5.2 Receive Path Reference Power Level

5.1.5.2.1 With the Signal Generator and Power Meter A and B Power Heads connected to the Splitter Box, step the Signal Generator over the entire range of In-Band and Out of Band frequencies, according to the frequency table, at +10 dBm (into the splitter). Record the results as A' (=A-B).

5.1.5.3 RF Matrix Receive Path FLC1/FLC2/3 CW Path Loss

5.1.5.3.1 Disconnect Power Head A from the Splitter Box and reconnect to FLC2. Connect the Splitter Box A' output to FLC1 through adapter ADPT F1.

5.1.5.3.2 With RF Matrix SW5 and SW1 in the FLC2 path position, again step the Frequency Generator over the range of frequencies and record these values as FLC1/FLC2 Path Loss by taking the reading for B Power Head and adding it to the corresponding reading for A', then subtracting the corresponding reading for Power Head A. Formula: $\text{FLC1/FLC2 Path Loss} = (B_{\text{reading}} + (A'_{\text{recorded}})) - A_{\text{reading}}$.

5.1.5.3.3 Disconnect Power Head A from FLC2 and connect to FLC3. Repeat 5.1.5.3.2 for path FLC1/FLC3, and recording the Path Loss data.

5.1.5.3.4 Disconnect the Power Head A from FLC3.

5.1.5.4 RF Matrix Receive Path FLC2/RLC3 CW Path Loss

5.1.5.4.1 Set RF Matrix SW5 to position 2, SW1 to FLC2, and SW4 to Position 5.

5.1.5.4.2 Temporarily install an N Male to N Male adapter on FLC2. Attach the Splitter Box A' output to the adapter.

5.1.5.4.3 For each frequency band in the table, set the Spectrum Analyzer Range, RBW, VBW, and detector method, and frequency step the corresponding frequency range using the Signal Generator.

5.1.5.4.4 Record the FLC2/RLC3 Noise and Spurious Path Loss value for each frequency step by subtracting the measured value on the Spectrum Analyzer from the value for A' for the corresponding frequency. Formula: FLC2/RLC3 (N&S) Path Loss = $(B_{\text{reading}} + (A')_{\text{recorded}}) - SA_{\text{reading}}$.

5.1.5.4.5 Repeat 5.1.5.4.1 for path FLC3/RLC3.

5.1.5.4.6 Remove the Splitter Box and N to N Male Adapter.

5.1.5.5 Transmit Path Reference Power Level

5.1.5.5.1 With the Signal Generator and the Power Meter A and B power heads connected to the Calibration Splitter Box, step the Signal Generator frequency over the entire range of In-Band and Out of Band Frequencies at +10 dBm (into the splitter).

5.1.5.5.2 Record the results as A' (=A-B).

5.1.5.6 RF Matrix RLC1/RLC2 CW Path Loss

5.1.5.6.1 Disconnect Power Head A from the Splitter Box and reconnect to RLC2.

5.1.5.6.2 Connect the Splitter Box A' output to RLC1 ADPT RL1.

5.1.5.6.3 With RF Matrix SW2 in the RLC1 Input path position, again step the Frequency Generator over the range of frequencies and record these values as RLC1/RLC2 Path Loss by taking the reading for B power head and adding it to the corresponding reading for A', then subtracting the corresponding reading for Power Head A. Formula: RLC1/RLC2 Path Loss = $(B_{\text{reading}} + (A')_{\text{recorded}}) - A_{\text{reading}}$.

5.1.5.7 RF Matrix RLC1/RLC3 Noise and Spurious Path Loss

5.1.5.7.1 If not already in place, connect a 50 dB precision attenuator between RLC3 and the Spectrum Analyzer input connector cable.

5.1.5.7.2 For each required Band in TBR 041 table 2, set the Spectrum Analyzer Range, RBW, VBW, and detector method and frequency step the corresponding frequency range using the Signal Generator.

5.1.5.7.3 Record the RLC1/RLC3 Noise and Spurious Path Loss value for each frequency step by subtracting the measured value on the Spectrum Analyzer from the value of A' for the corresponding frequency. Formula: RLC1/RLC3 (N&S) Path Loss = $(B_{\text{reading}} + (A')_{\text{recorded}}) - SA_{\text{reading}}$.

5.1.5.7.4 Frequencies from .1 MHz to 1610 MHz should be recorded for both the FL1 and FL2 Notch Filter Paths.

5.1.5.7.5 Frequencies greater than 1628.5 should use the path with the High Pass Filter.

5.1.5.8 RF Matrix RLC1/RLC3 Thru Path Loss

5.1.5.8.1 Disconnect the 50 dB precision attenuator between RLC3 and the Spectrum Analyzer and reconnect the input connector cable to the RF Matrix N connector.

5.1.5.8.2 Set the RLC1/RLC3 path switches to the Normal thru path setting. Set the Spectrum Analyzer Reference level to –10 dBm, RBW = 1 MHz, VBW = 3 MHz, and detector Method to RMS.

5.1.5.8.3 Step the Signal Generator for frequencies 1610 to 1628.5 MHz, and record the RLC1/RLC3 Thru Path Loss value for each frequency step by subtracting the measured power value read on the Spectrum Analyzer from the value of A' for the corresponding frequency. Formula: $\text{RLC1/RLC3 (Thru) Path Loss} = (B_{\text{reading}} + (A')_{\text{recorded}}) - SA_{\text{reading}}$.

5.1.5.9 RF Matrix RLC1/RLC3 CDMA Path Loss

5.1.5.9.1 Set the RLC1/RLC3 path switches to the Normal thru path setting. Set the Spectrum Analyzer Reference level to –10 dBm, RBW = 1 MHz, VBW = 3 MHz, and detector Method to RMS.

5.1.5.9.2 Replace the Signal Generator and Splitter with a Portable G* UT at Maximum Power (27dBm) and no attenuator.

5.1.5.9.3 Make a call through the 8803 to the UT. Frequency step the corresponding frequency range using the G* UT channel settings set from the Anritsu 8803.

5.1.5.9.4 Record the value read on the Spectrum Analyzer (adjusted for 1.23 MHz BW) for path RLC1/RLC3 CDMA Path. At the same time, record the value read on the Power Meter A Channel.

5.1.5.9.5 Subtract the power values read on the frequency steps read on the Spectrum Analyzer from those read for the Power Meter, add the value of the RLC1/RLC3 Thru Path Loss and subtract the value of the RLC1/RLC2 CW Path Loss from the Total. Add this set of values algebraically to the RLC1/RLC3 Thru Path Loss table, creating the RLC1/RLC3 CDMA Path Loss table.

5.1.5.9.6 Formula: $\text{RLC1/RLC3 (CDMA) Path Loss} = (\text{RLC1/RLC3 (Thru) Path Loss}) + A_{\text{reading}} - A_{\text{ThruPLrecorded}} - SA_{\text{reading}} - SA_{\text{ThruPLrecorded}}$

5.1.5.9.7 Note: This step should be performed simultaneous with step 6.

5.1.5.10 RF Matrix RLC1/RLC4 CDMA Path Loss

5.1.5.10.1 Record the the RLC1/RLC4 CDMA Path Loss value for each frequency step by subtracting the measured value on the 8803 “DSP Power Meter” line from the value of the Power Meter A channel for the corresponding frequency.

5.1.5.10.2 Formula: $\text{RLC1/RLC2 (CDMA) Path Loss} = A_{\text{reading}} + \text{RLC1/RLC2 CW Path Loss}_{\text{recorded}} - 8803_{\text{reading}}$
