



(A) Radiated Emission Test-Up Frequency Below 30MHz




(B) Radiated Emission Test-Up Frequency 30MHz~1GHz



- 3. Detector = Peak.
- 4. Trace mode = max hold.
- 5. Sweep = auto couple.
- 6. Allow the trace to stabilize.
- 7. Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.

11.3 Test procedure

- 1. Remove the antenna from the EUT and then connect a low RF cable from the antenna port to the spectrum.
- 2. Set the spectrum analyzer: RBW = 2MHz. VBW = 6MHz. Sweep = auto; Detector Function = Peak.
- 3. Keep the EUT in transmitting at lowest, medium and highest channel individually. Record the max value.
