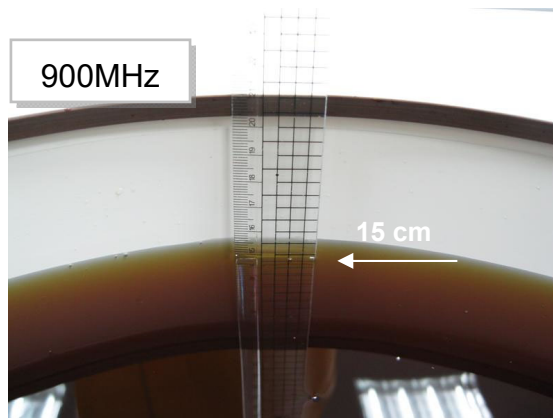

## Photograph of the tissue simulant fluid liquid depth

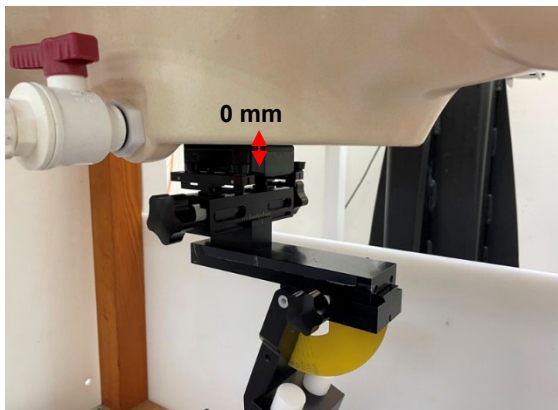

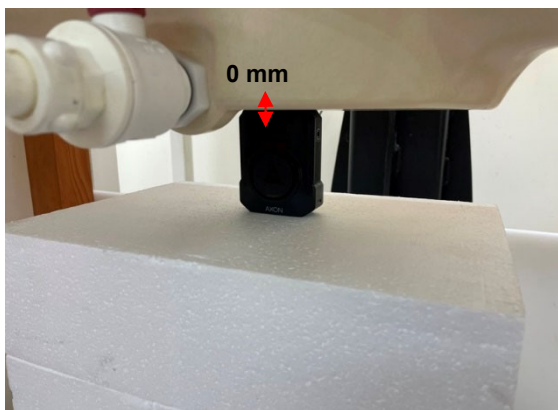

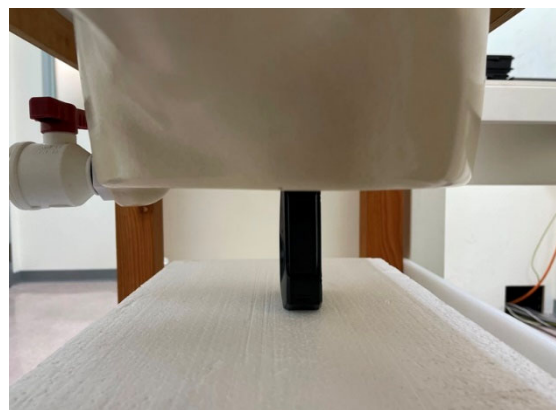
**Photograph 1. Body, Back Surface, 0mm**



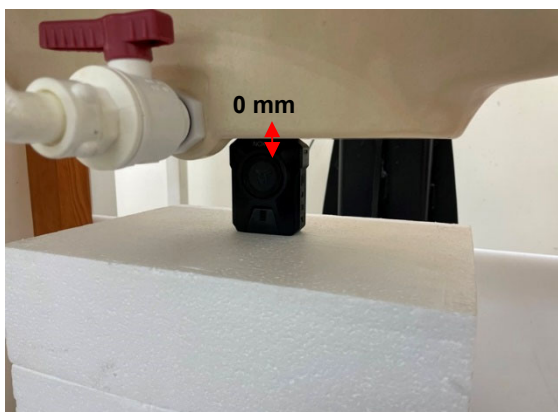
**Photograph 2. Body, Back Surface, 0mm**



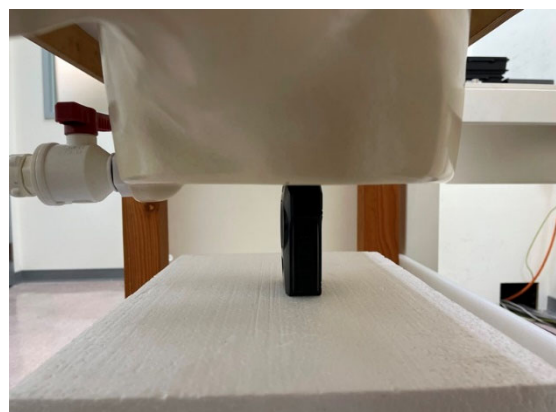
**Photograph 3. Body, Top Edge, 0mm**

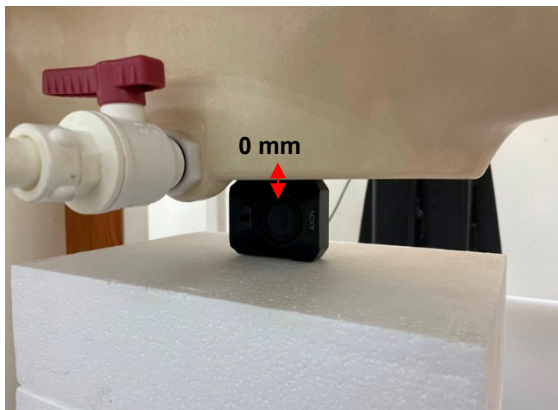

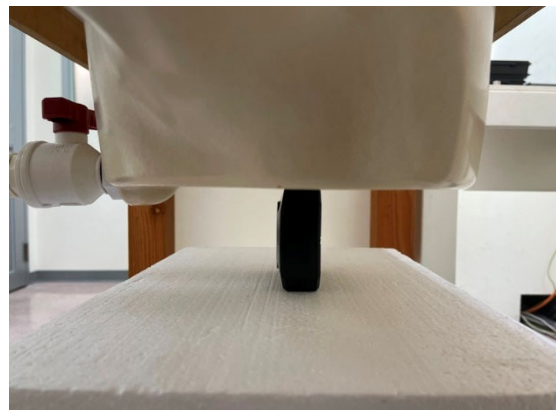

**Photograph 7. Body, Right Edge, 0mm**



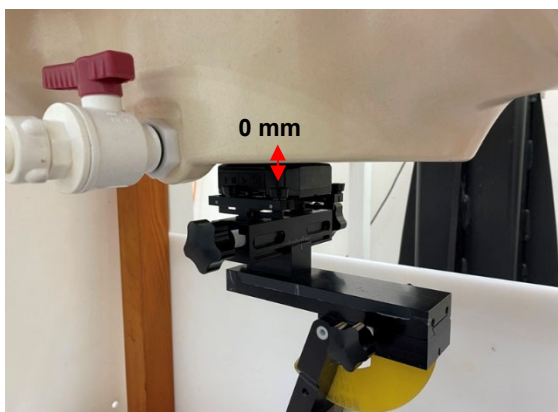
**Photograph 8. Body, Right Edge, 0mm**

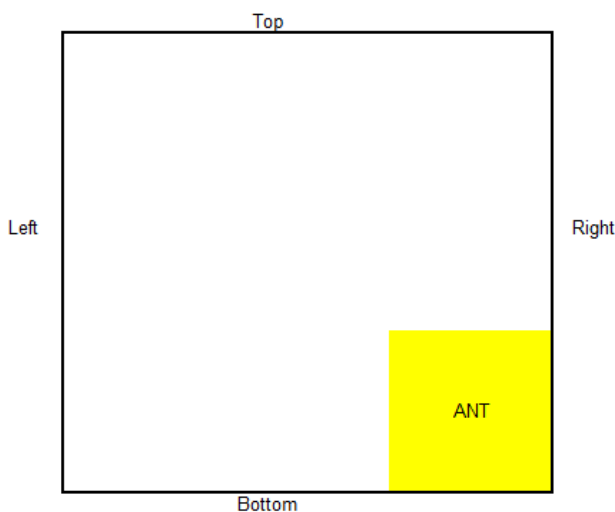
Photograph 13. Front view of EUT
