

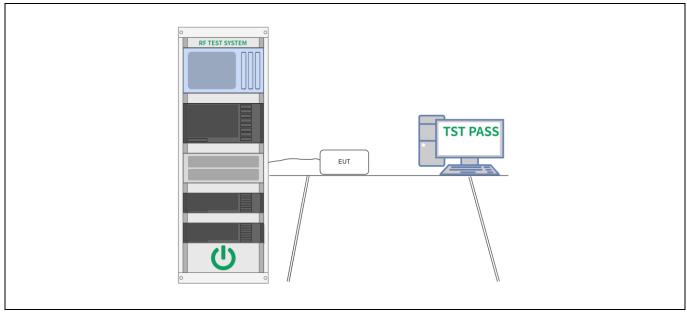
#### 6.2 Maximum Conducted Output Power

Test Requirement:	47 CFR 15.247(b)(3)

As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. 


#### 6.4 RF conducted spurious emissions and band edge measurement




## Appendix D: Band edge measurements




