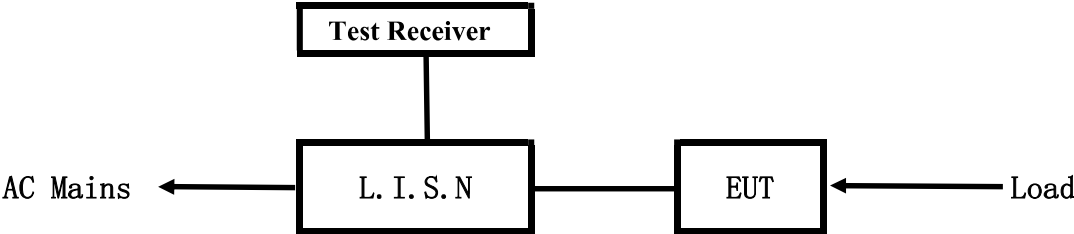

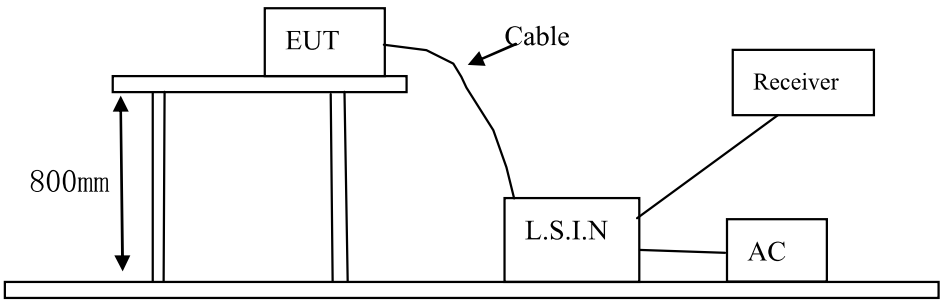

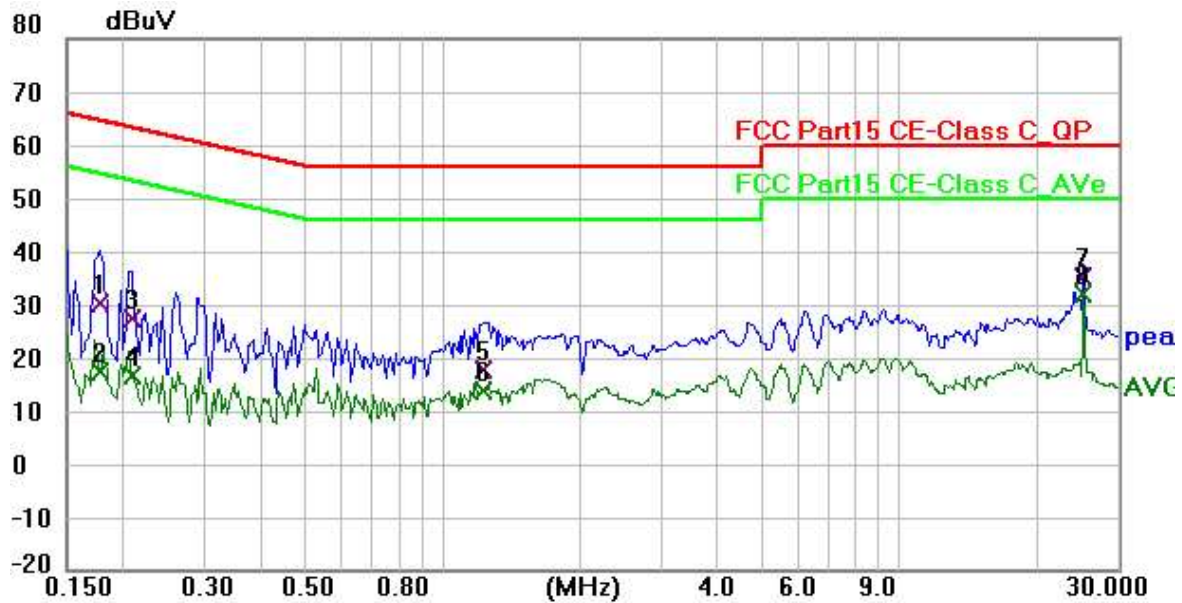

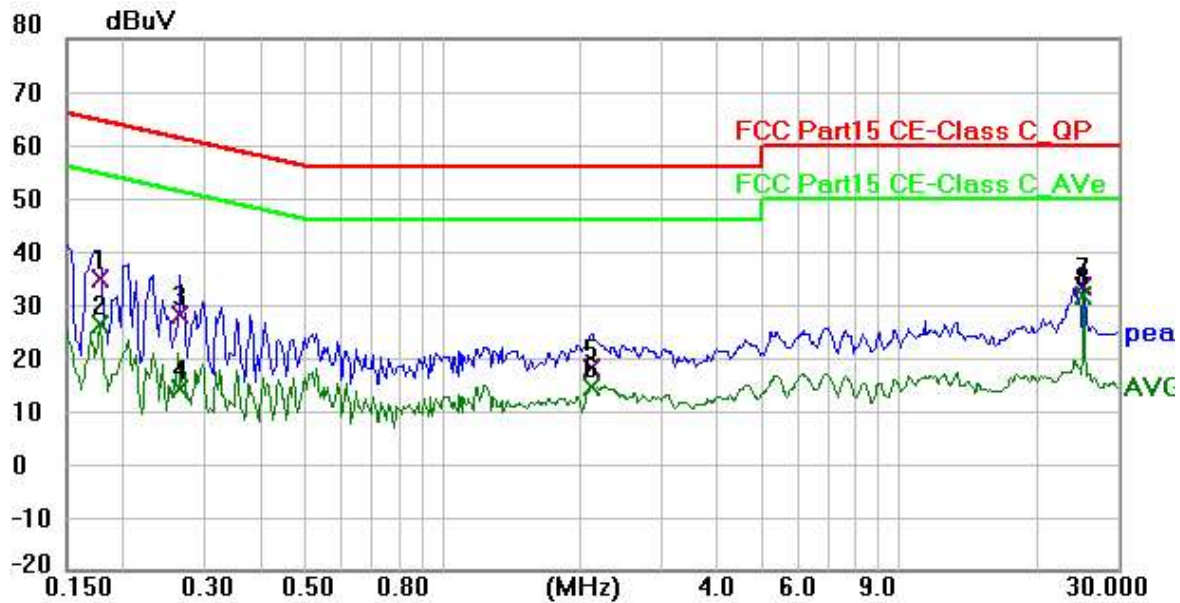

6 Radiated Emission Test

6.1 Test Method and test Procedure:

- (1) The EUT was tested according to ANSI C63.10-2013. The radiated test was performed at Timeway EMC Laboratory. This site is on file with the FCC laboratory division, Registration No. 744189
- (2) The EUT, peripherals were put on the turntable which table size is 1m x 1.5 m, table high 0.8 m. All set up is according to ANSI C63.10-2013.
- (3) The frequency spectrum from 9kHz to 25 GHz was investigated. The frequency spectrum is set as follows:

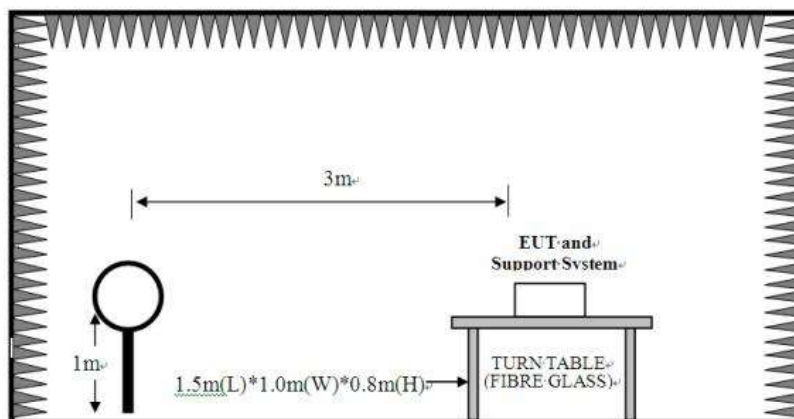

For radiated emissions from 9kHz to 30MHz



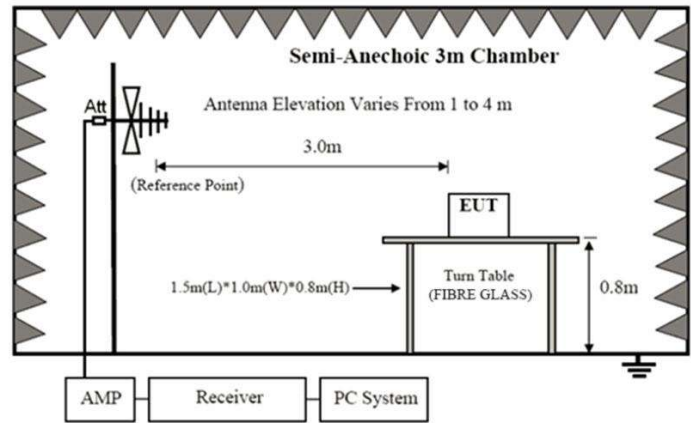

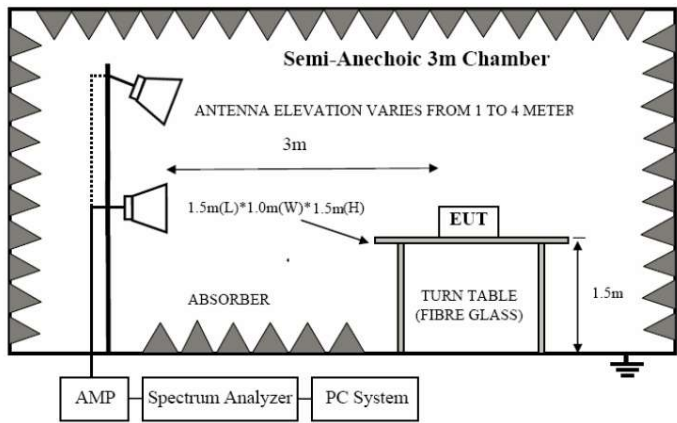

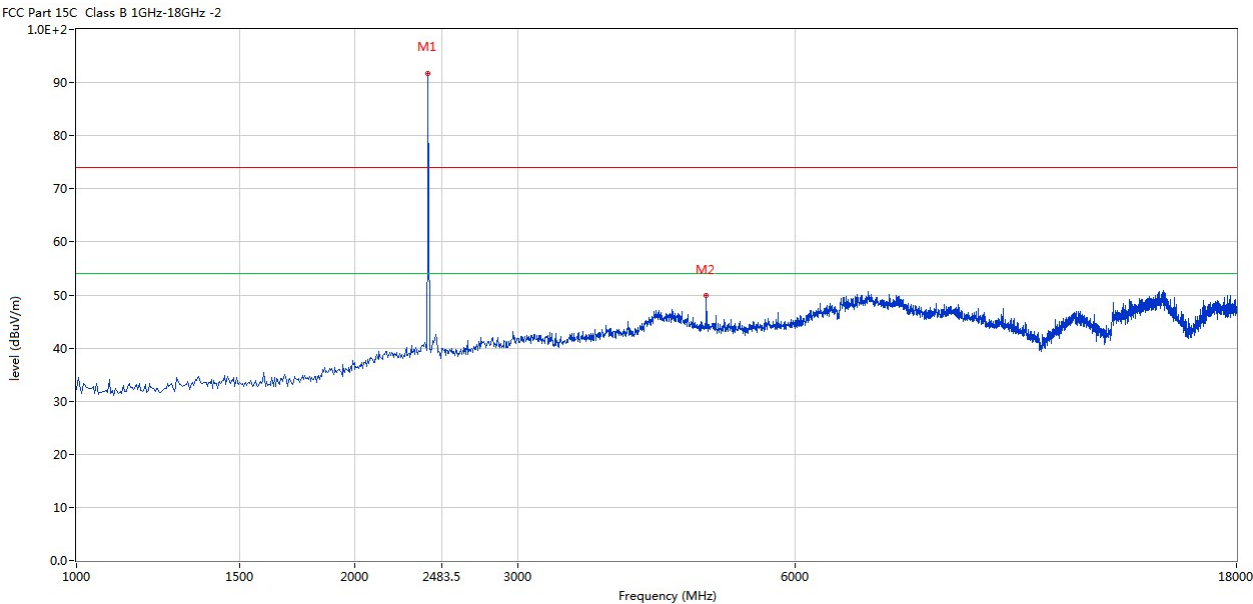

 4. All scanning using PK detector. And the final emission level was get using QP detector for frequency range from 30-1000MHz.As to 1G-25G, the final emission level got using PK. For fundamental measurement, PK detector used.
 5. The two modulation modes of GFSK, Pi/4D-QPSK were tested. And only the worst case was recorded in the test report. GFSK was the worst case.
 6. Battery was fully charged during test
