Test Graphs of Occupied Bandwidth

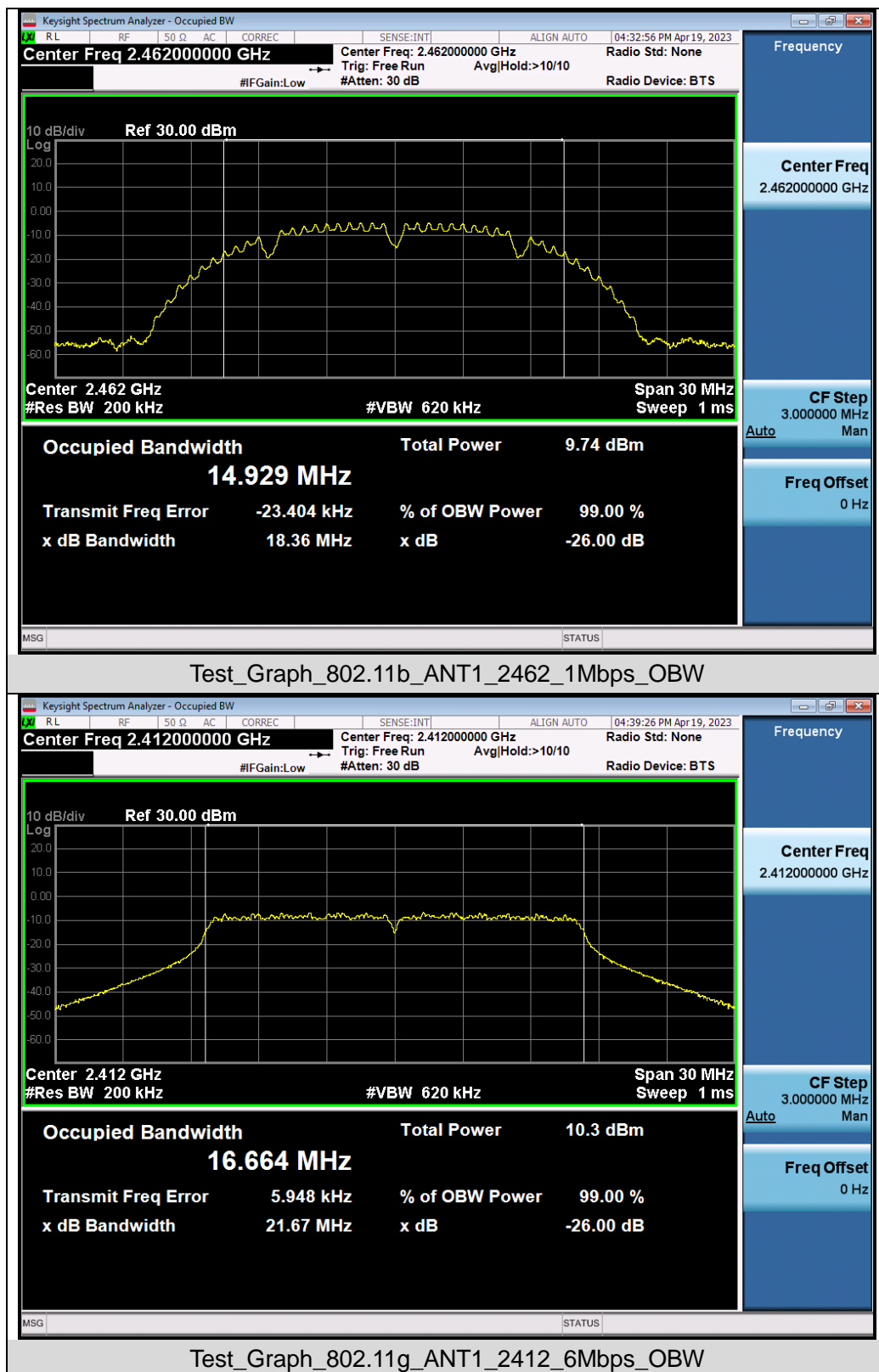


Test_Graph_802.11b_ANT1_2412_1Mbps_OBW

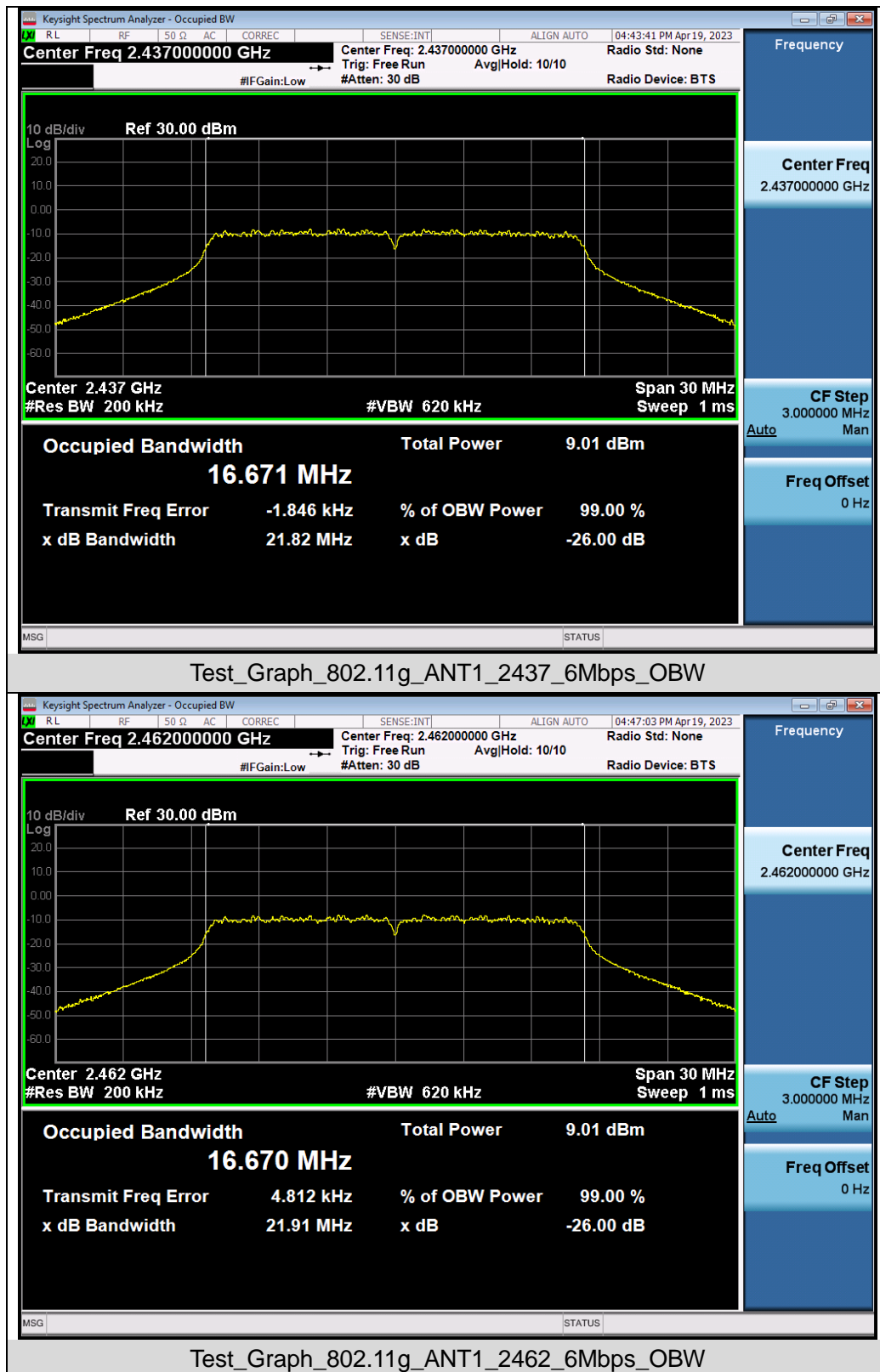

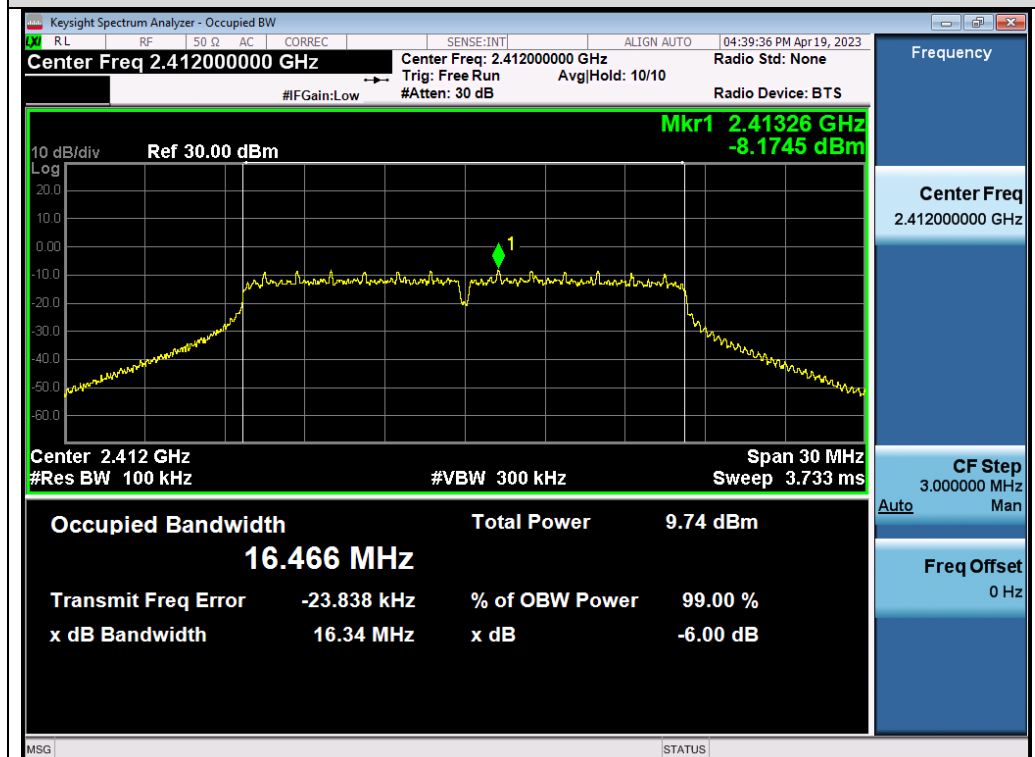
Test Graphs of DTS Bandwidth
