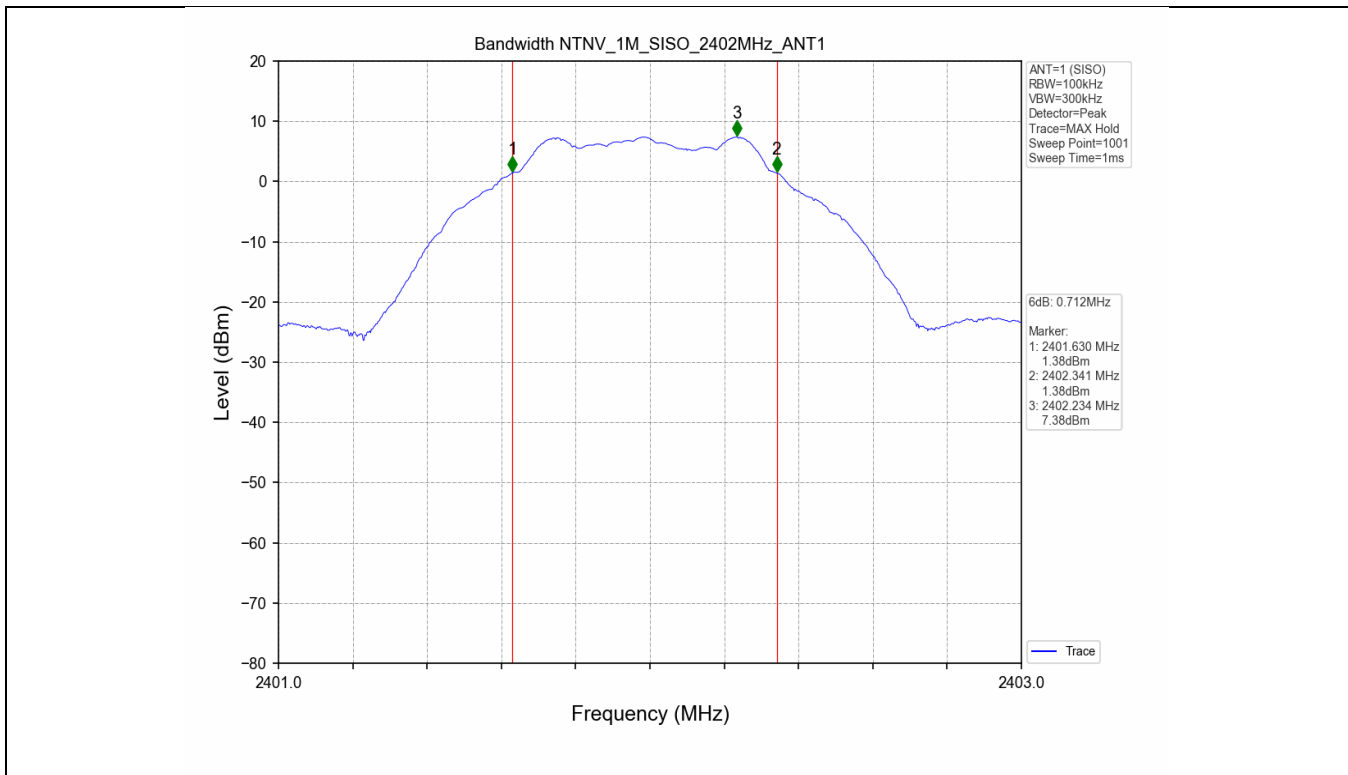

### 2.2 Test Graph - 6dB Bandwidth



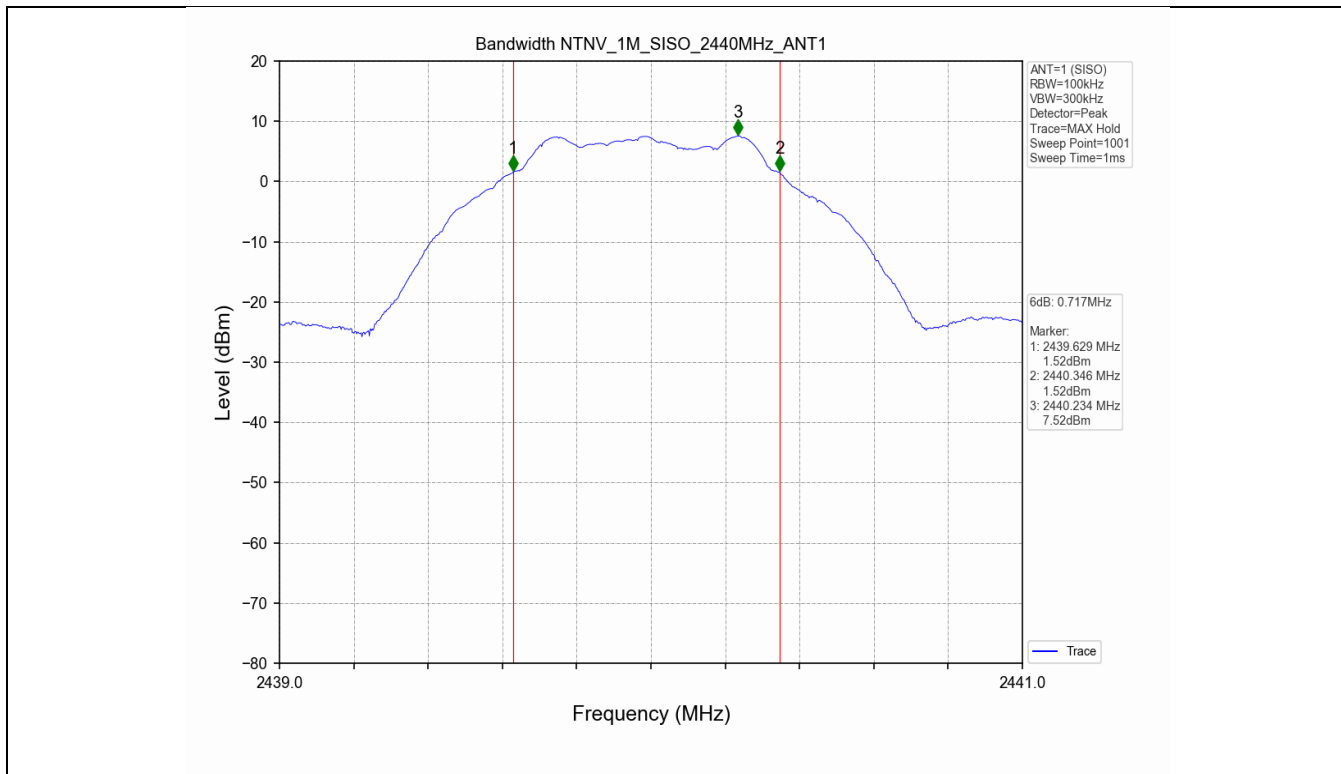

### 2.3 Test Graph - 99% Occupied Bandwidth



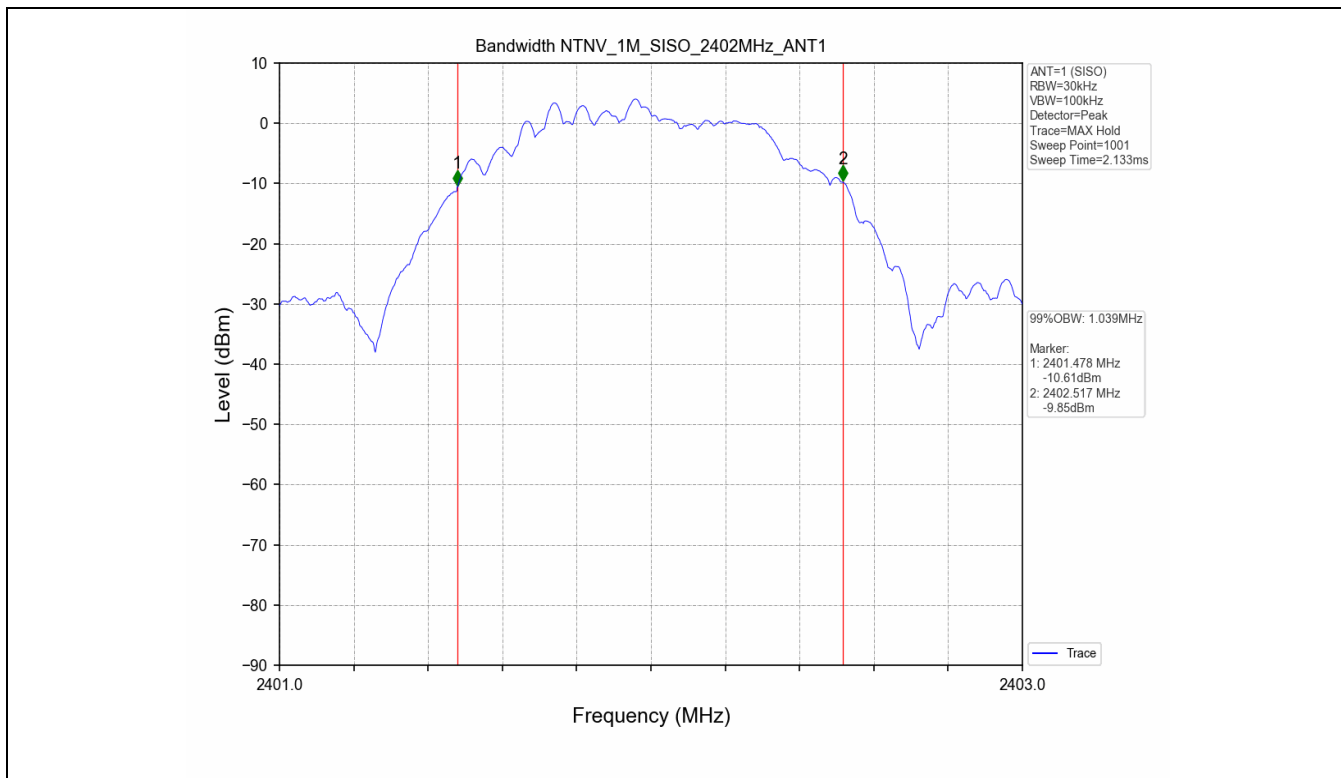
