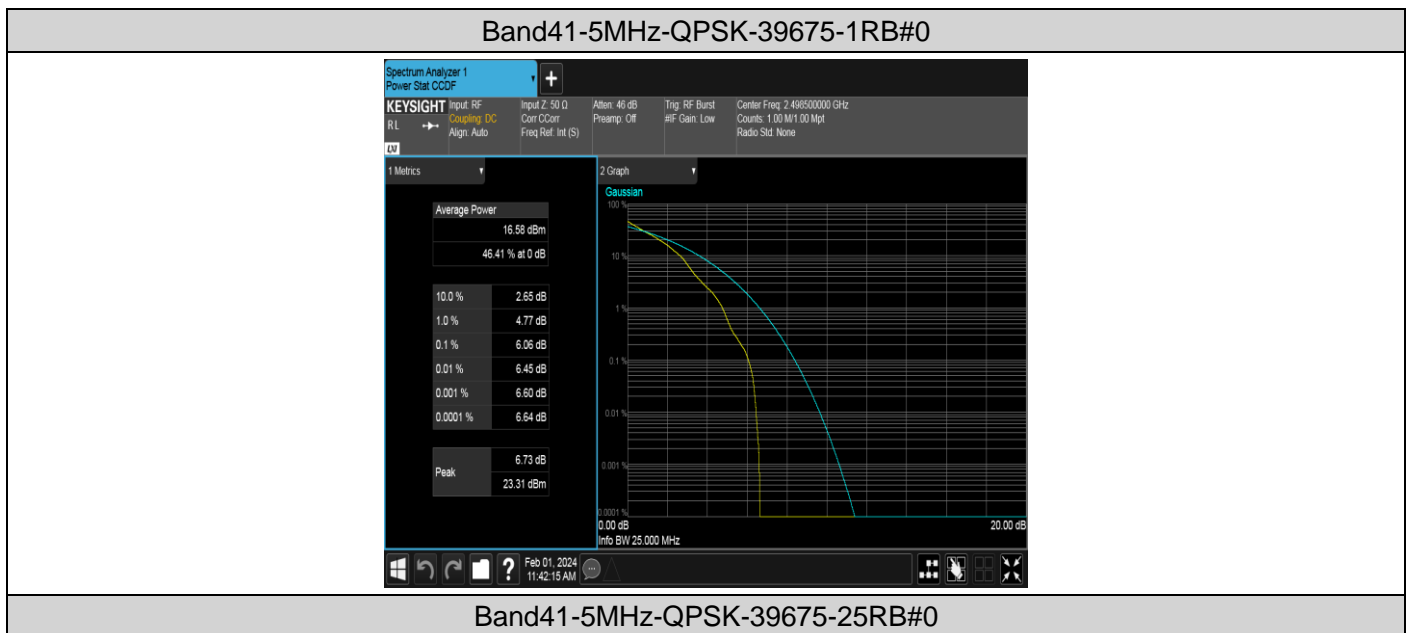

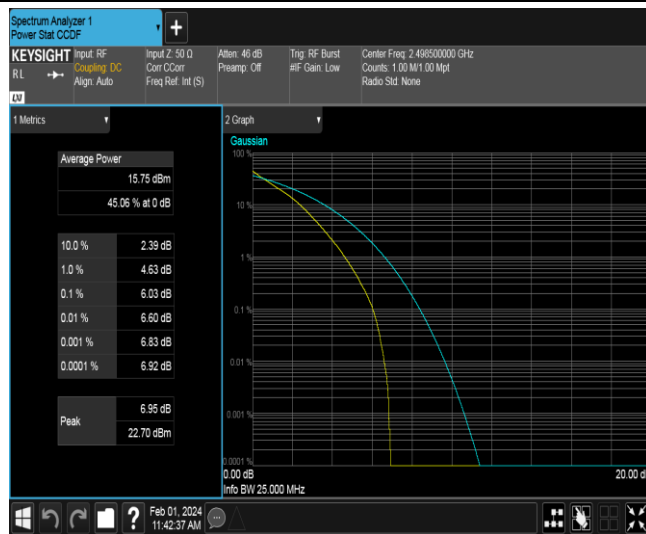

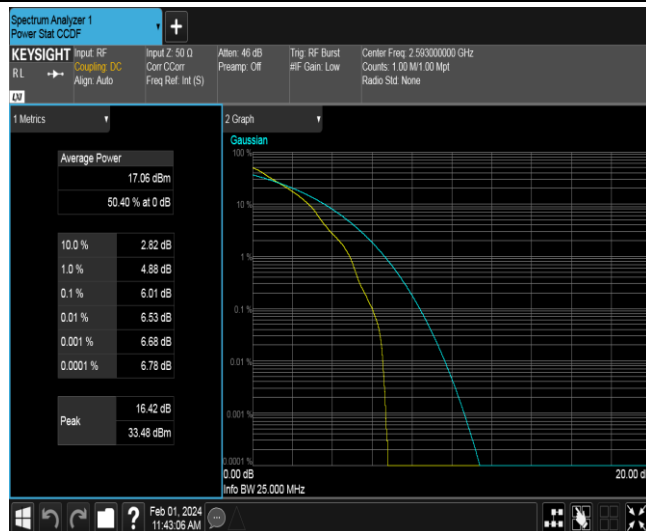

Band41-5MHz-QPSK-40620-1RB#0

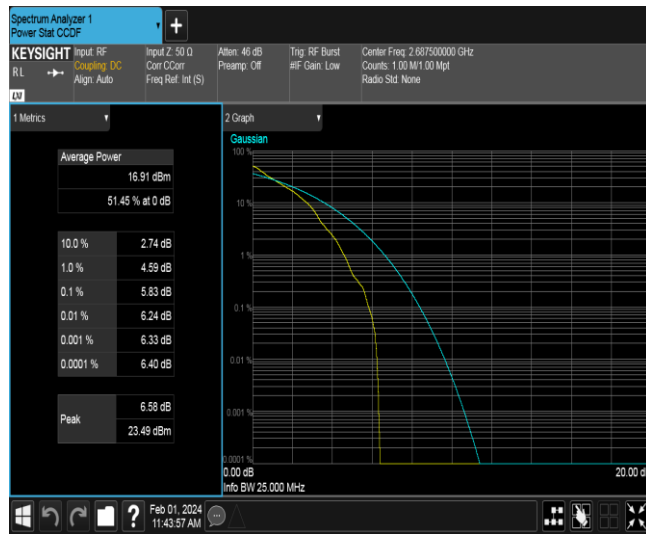


Band41-5MHz-QPSK-40620-25RB#0

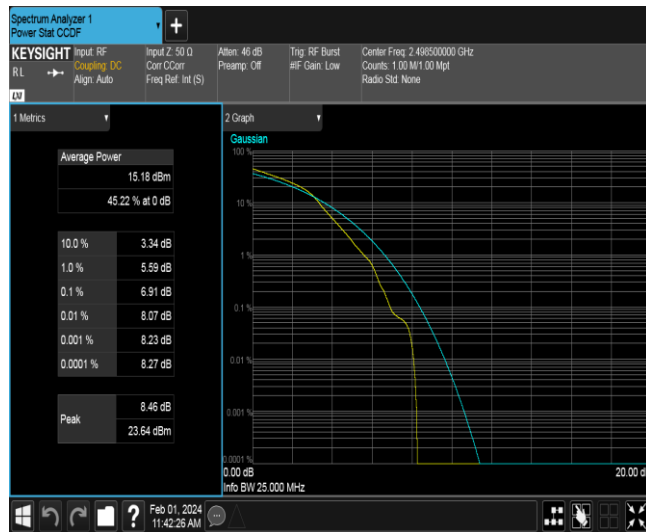


Band41-5MHz-QPSK-41565-25RB#0

Band41-10MHz-QPSK-39700-1RB#0

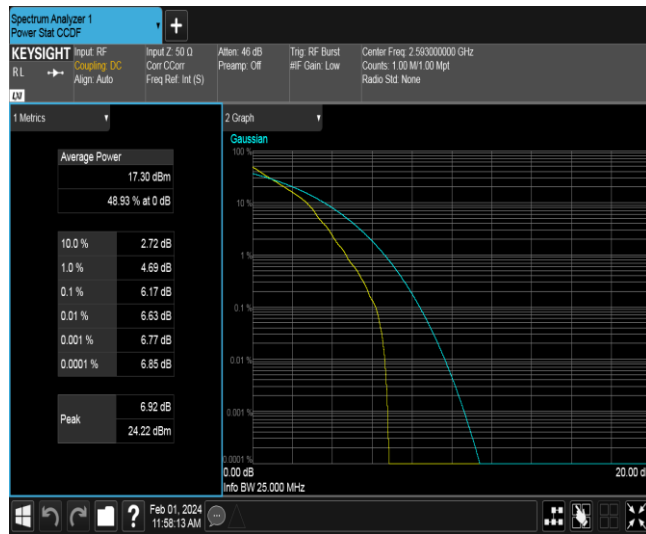


Band41-10MHz-QPSK-39700-50RB#0
