### 5.3 Test mode

Transmitting mode:	Keep the EUT in transmitting mode with worst case data rate.
Remark	GFSK (1 Mbps) is the worst case mode.

The sample was placed 0.8m above the ground plane of 3m chamber\*. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working with a fresh battery, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating the turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.

**EUT Pseudorandom Frequency Hopping Sequence**

*The pseudorandom sequence may be generated in a nine-stage shift register whose 5th and 9th stage outputs are added in a modulo-two addition stage. And the result is fed back to the input of the first stage. The sequence begins with the first ONE of 9 consecutive ONEs; i.e. the shift register is initialized with nine ones.*

- Longest sequence of zeros: 8 (non-inverted signal)
