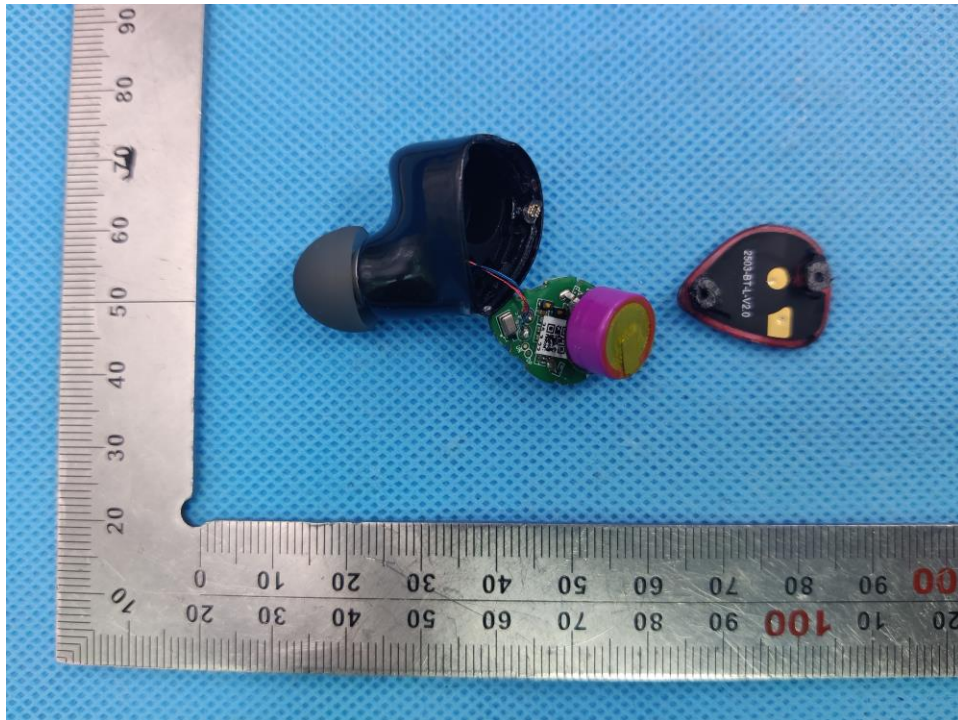
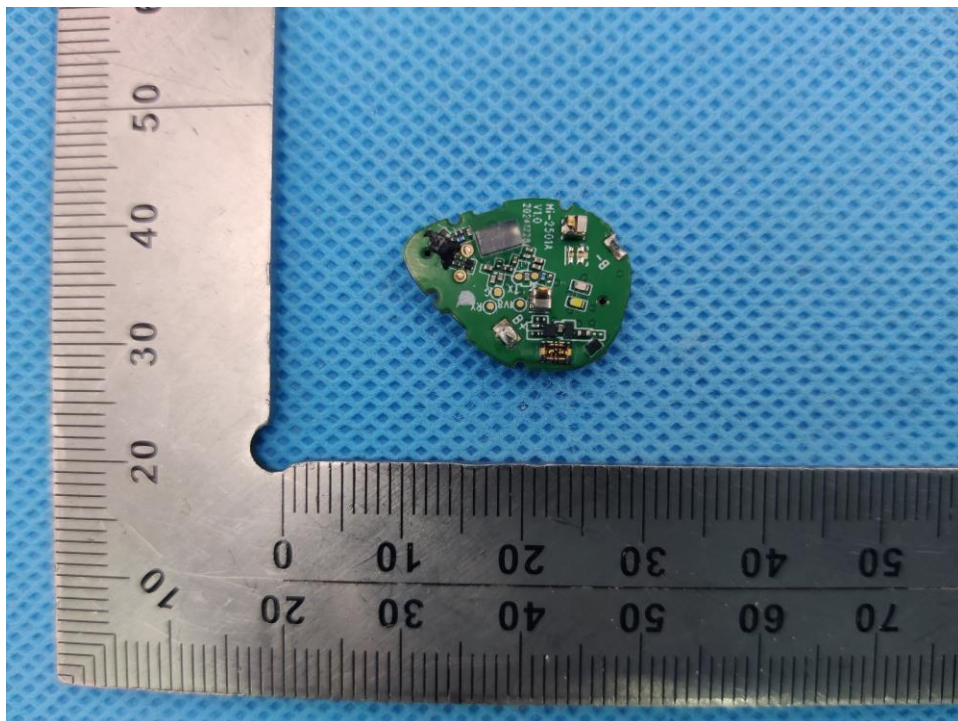

INTERNAL VIEW OF EUT - Left Earphone (FIGURE 1)

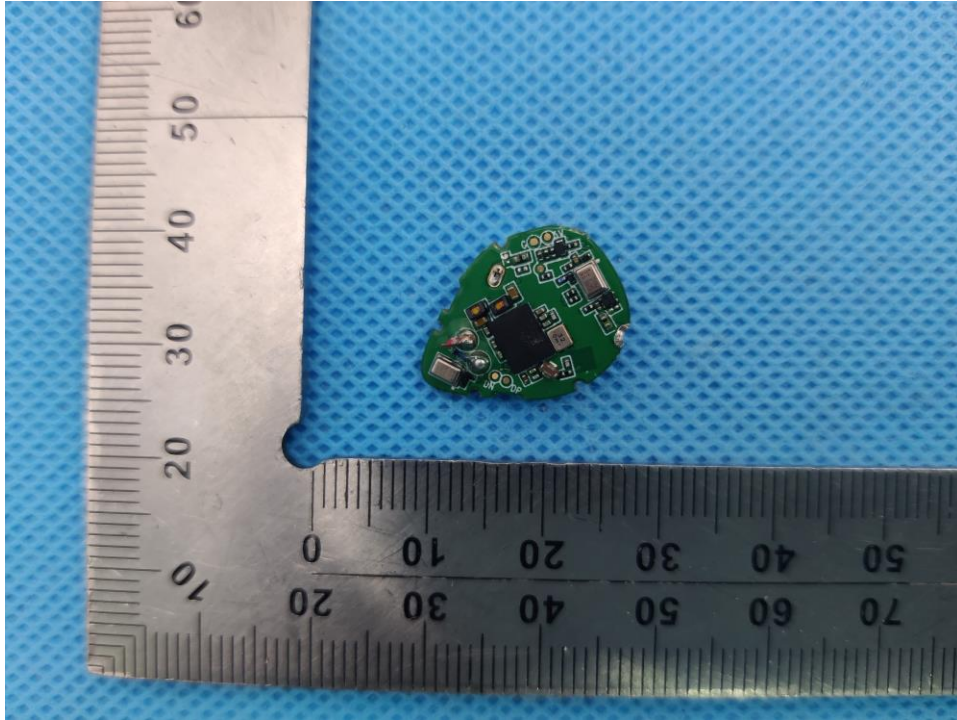

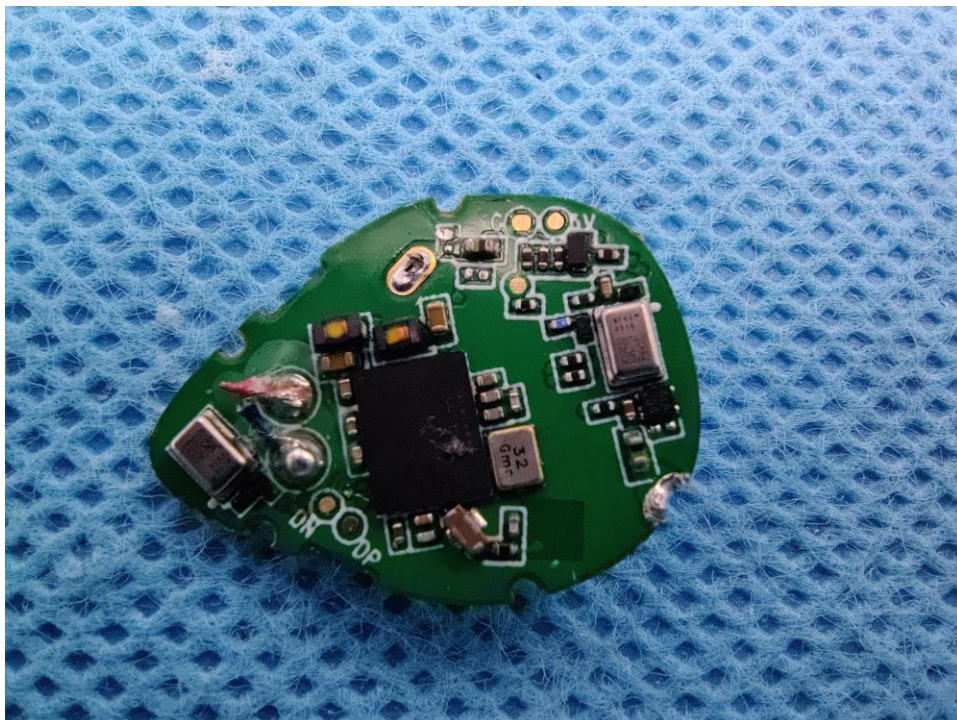

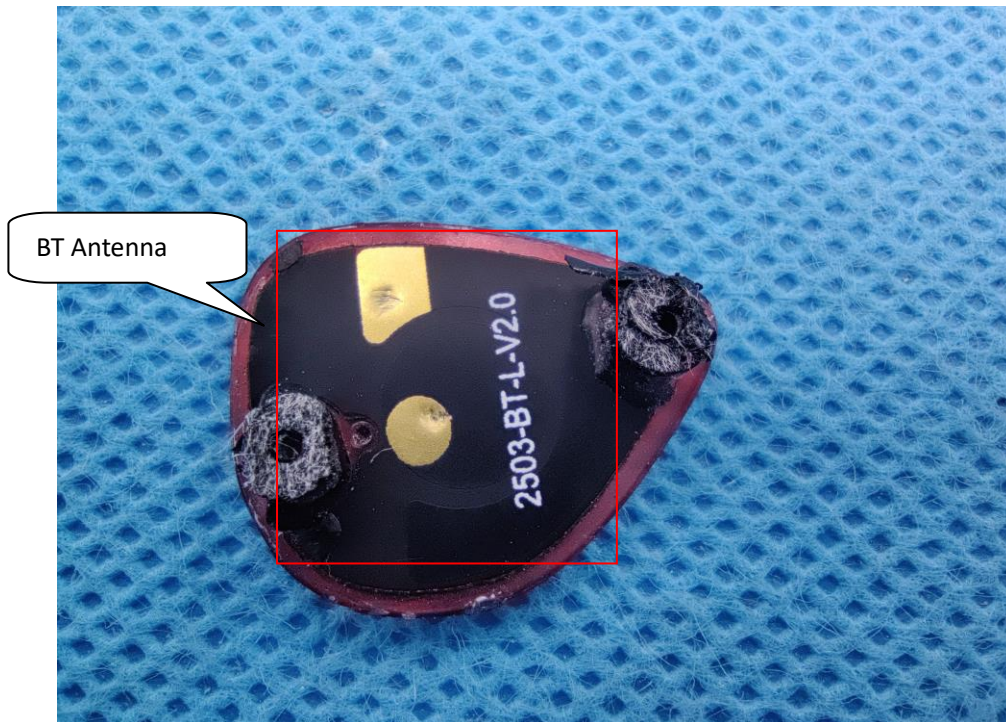

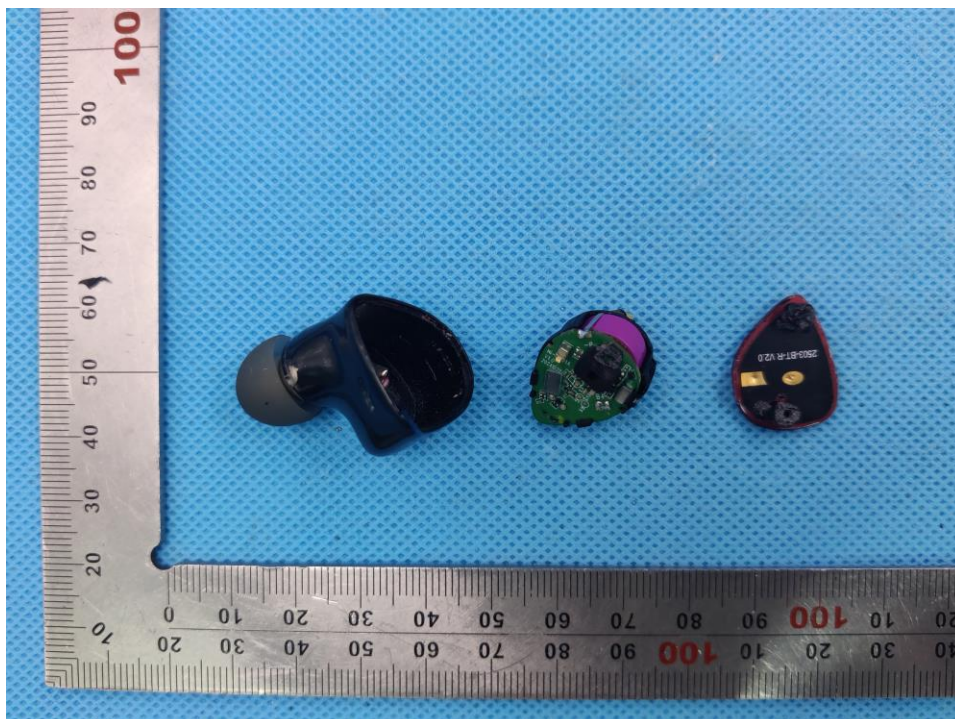

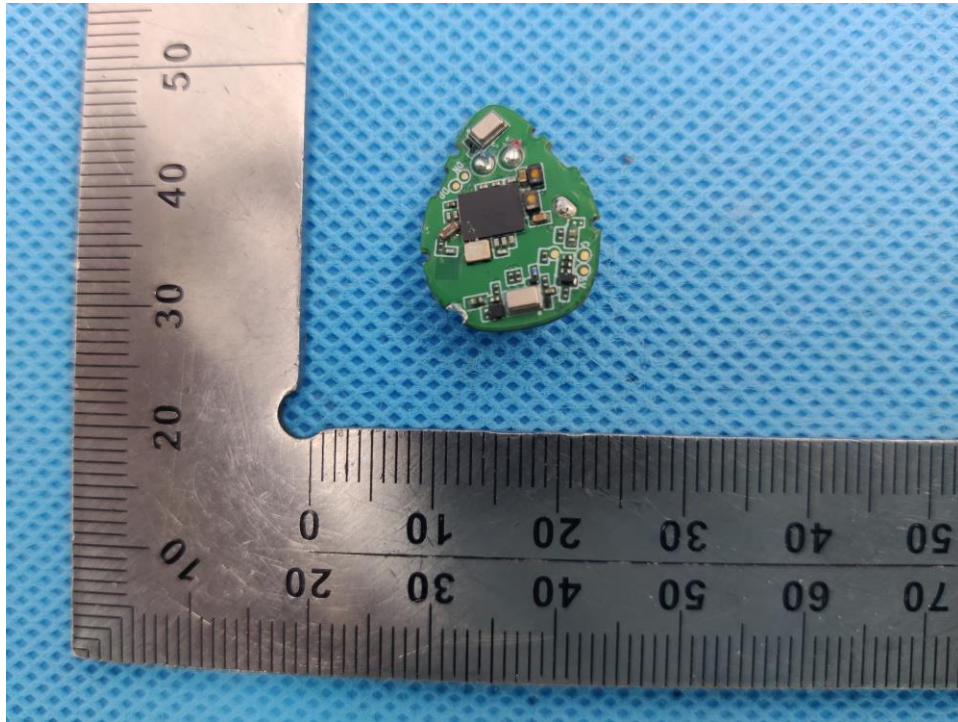

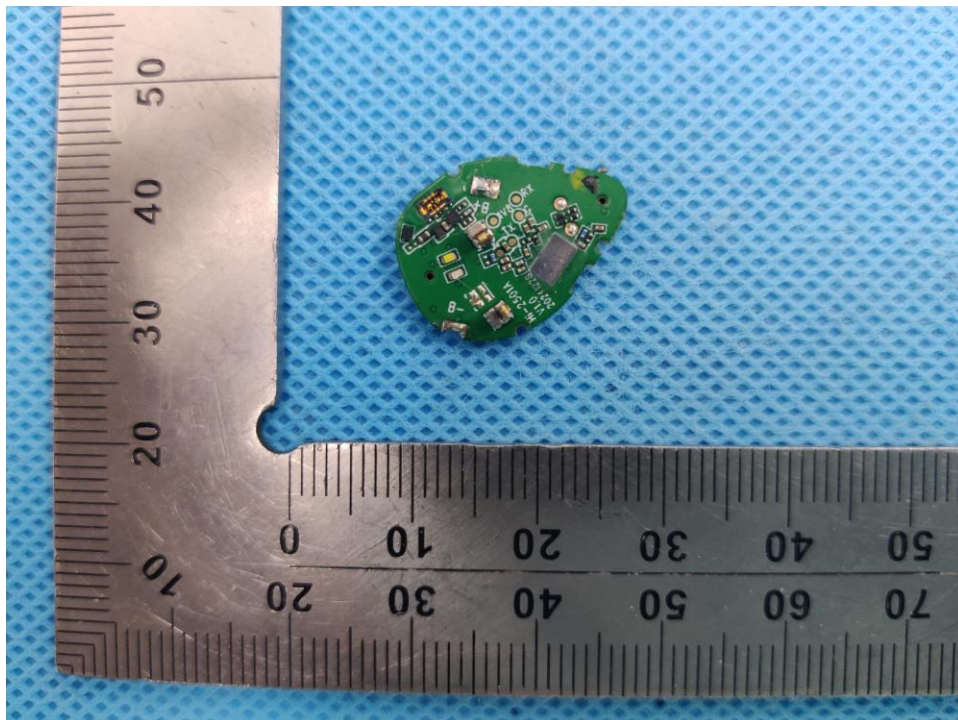

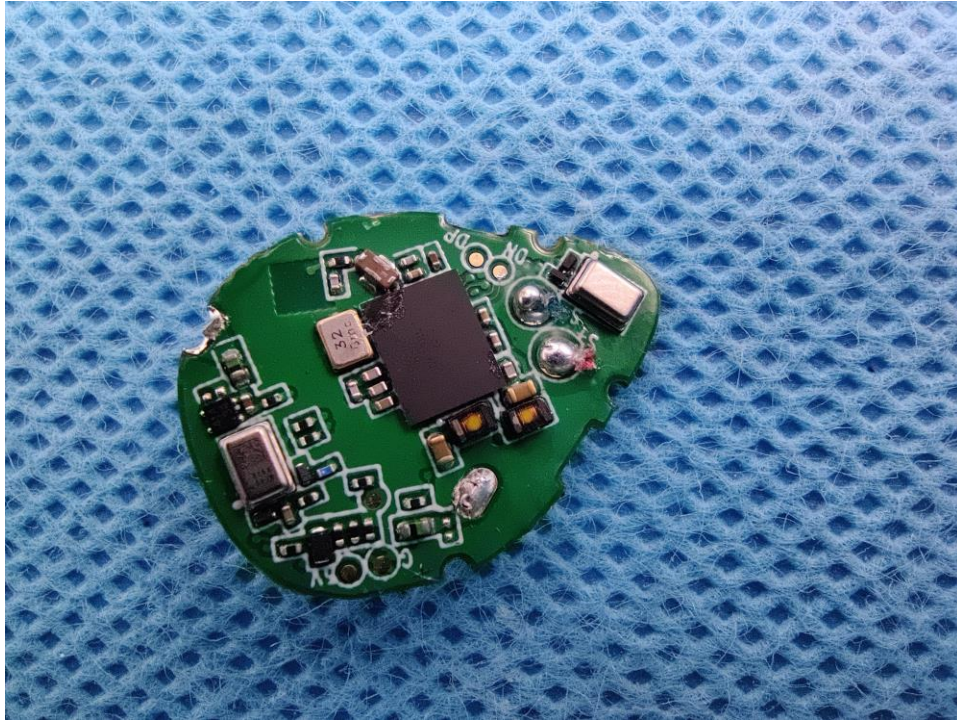

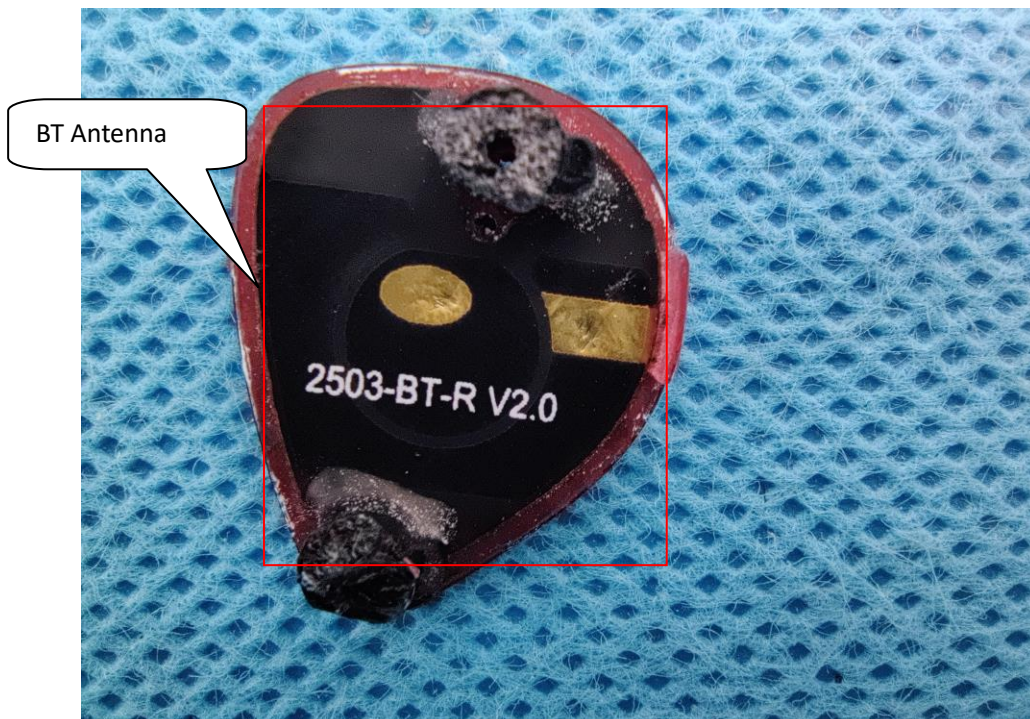

INTERNAL VIEW OF EUT -Right Earphone (FIGURE 3)

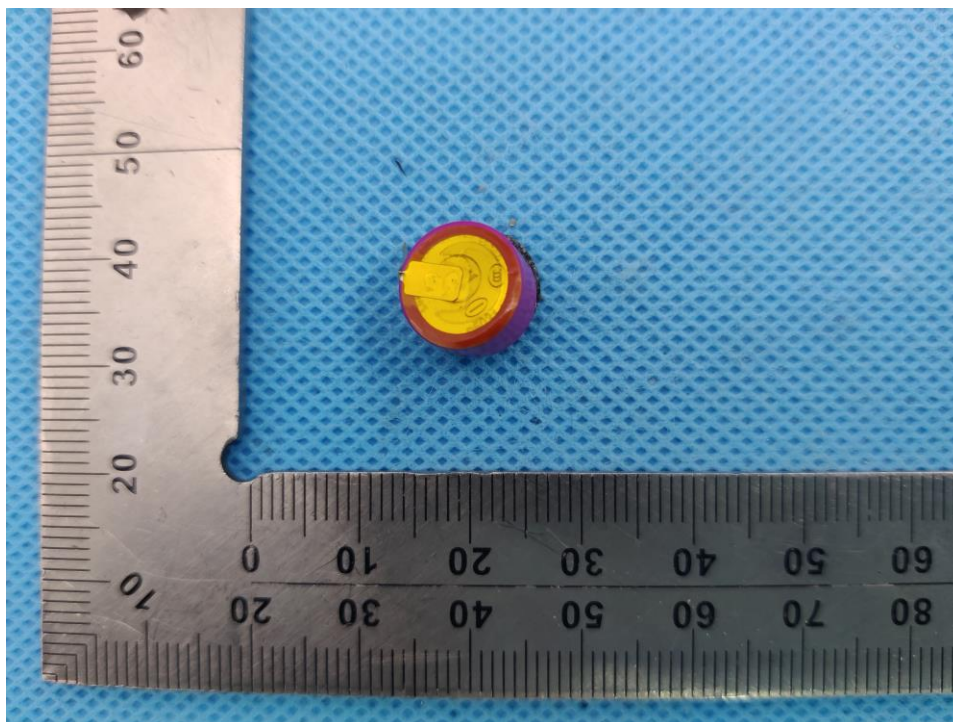


INTERNAL VIEW OF EUT - Right Earphone (FIGURE 4)
