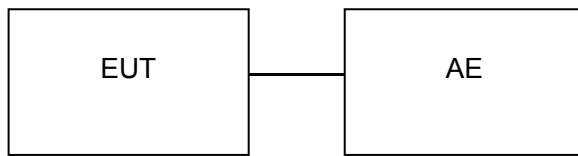



1. Only the result of the worst case was recorded in the report, if no other cases.

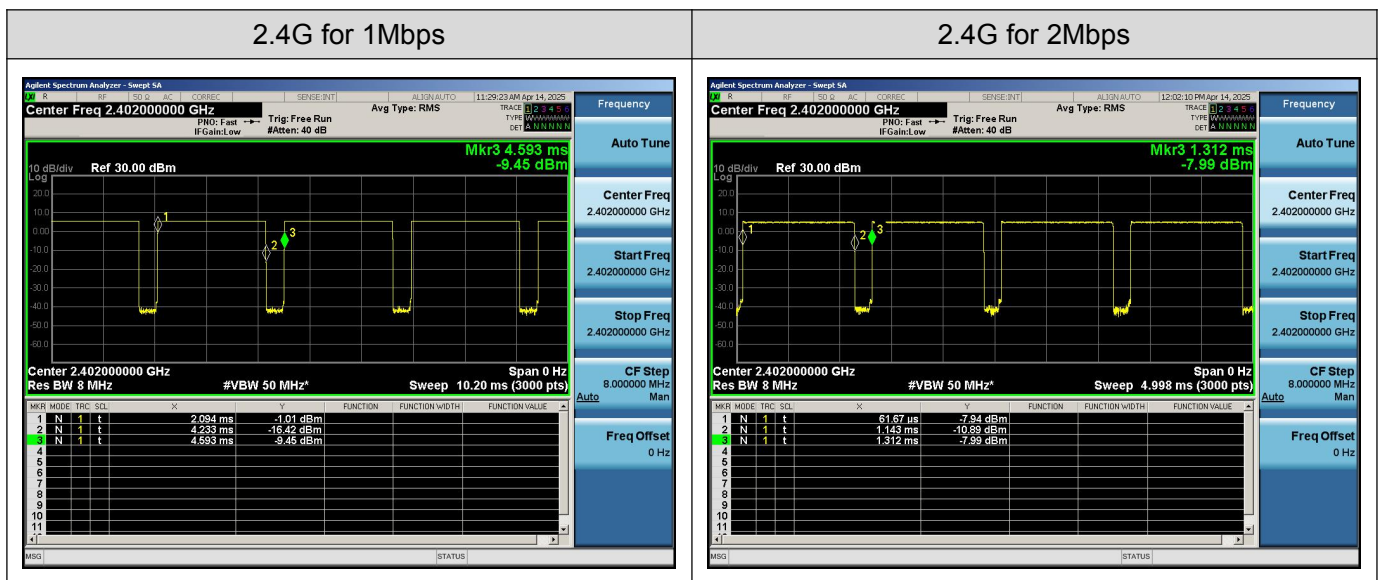

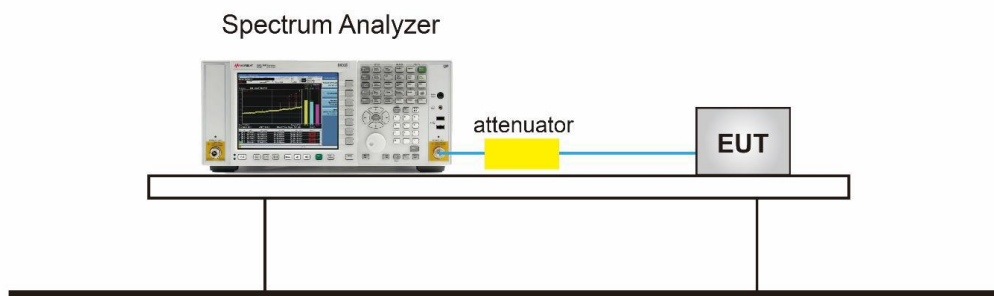

### Test Graphs of Occupied Bandwidth



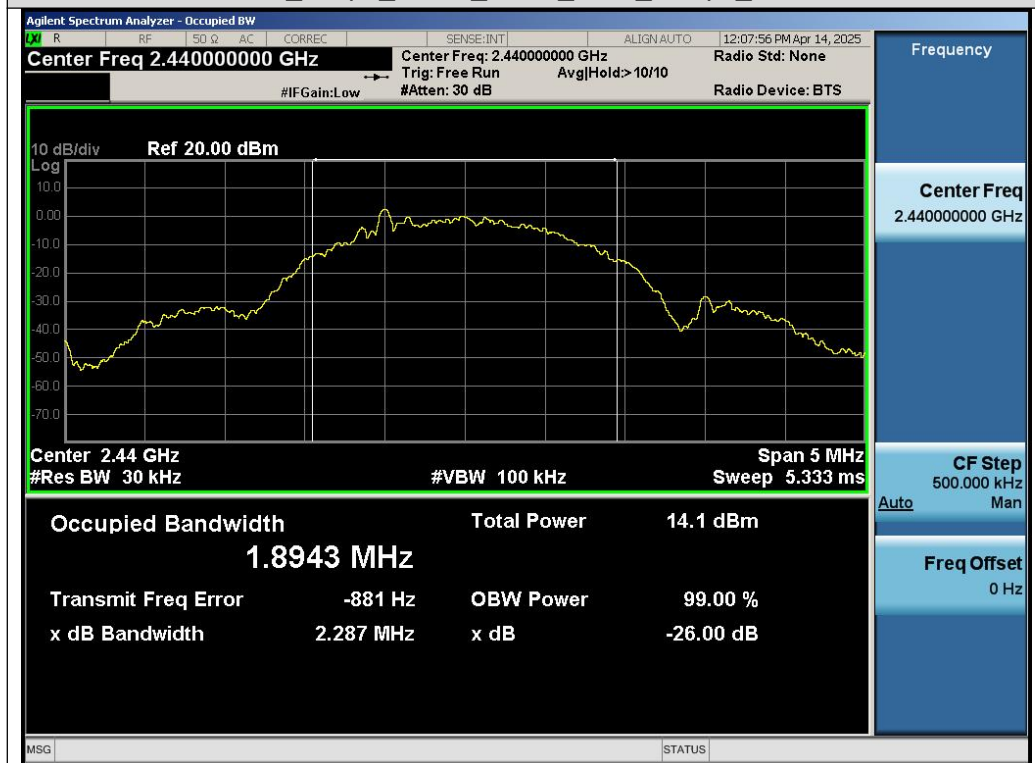

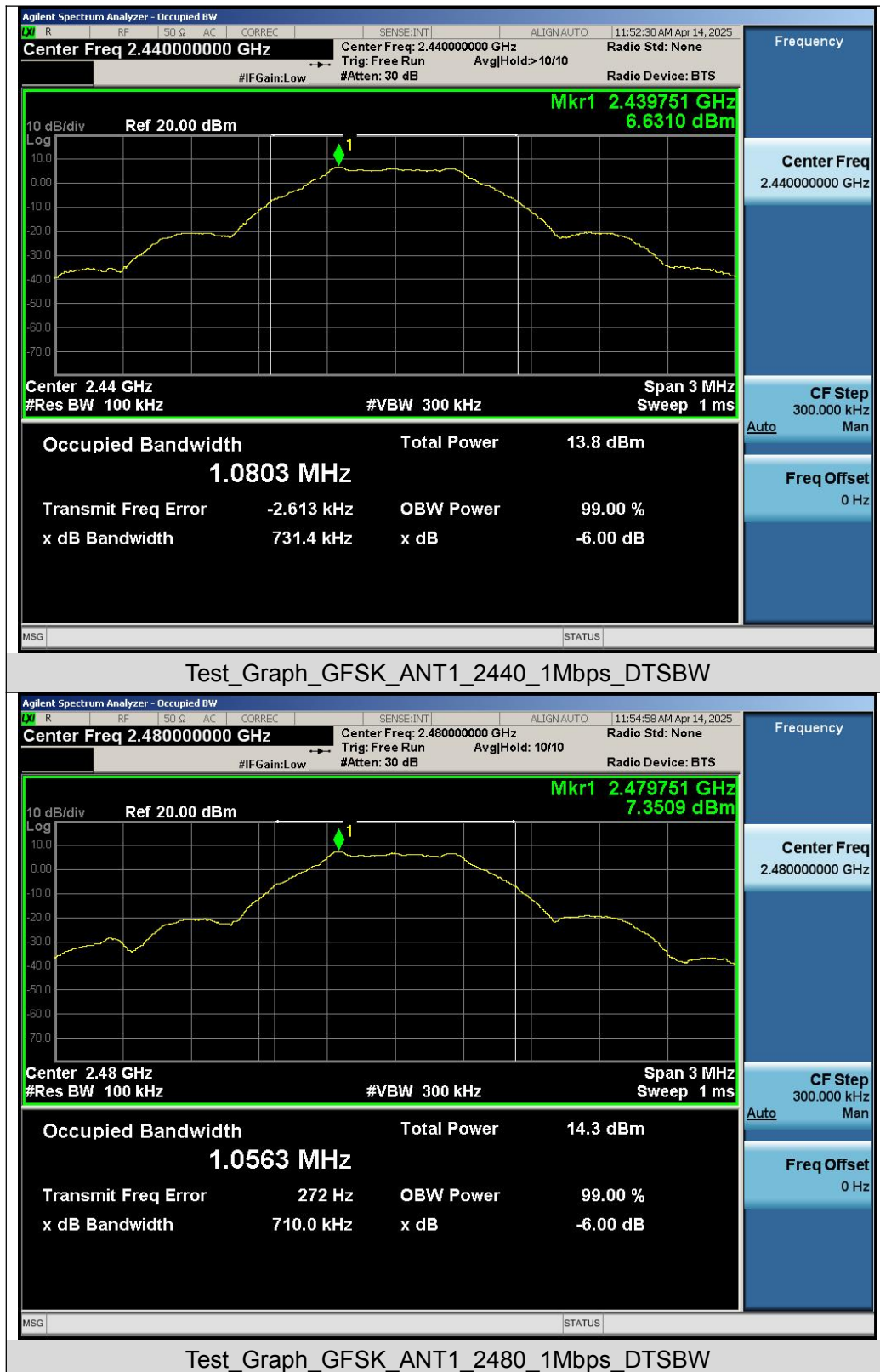


### Test Graphs of DTS Bandwidth



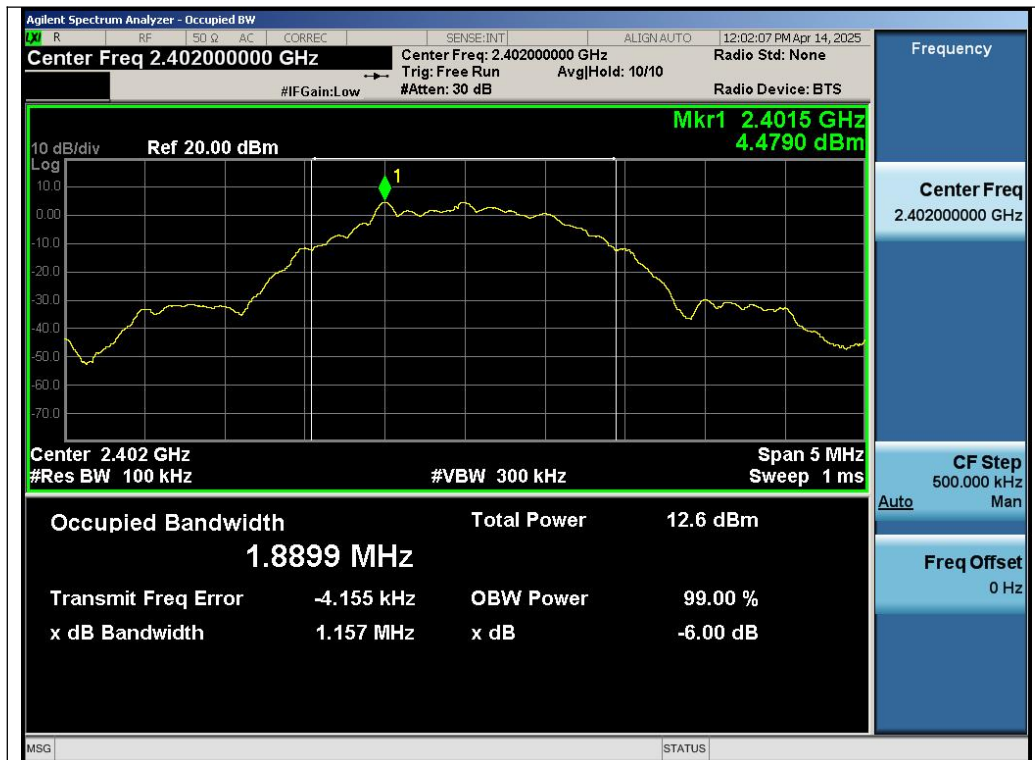

## Test Graphs of Conducted Output Power Spectral Density

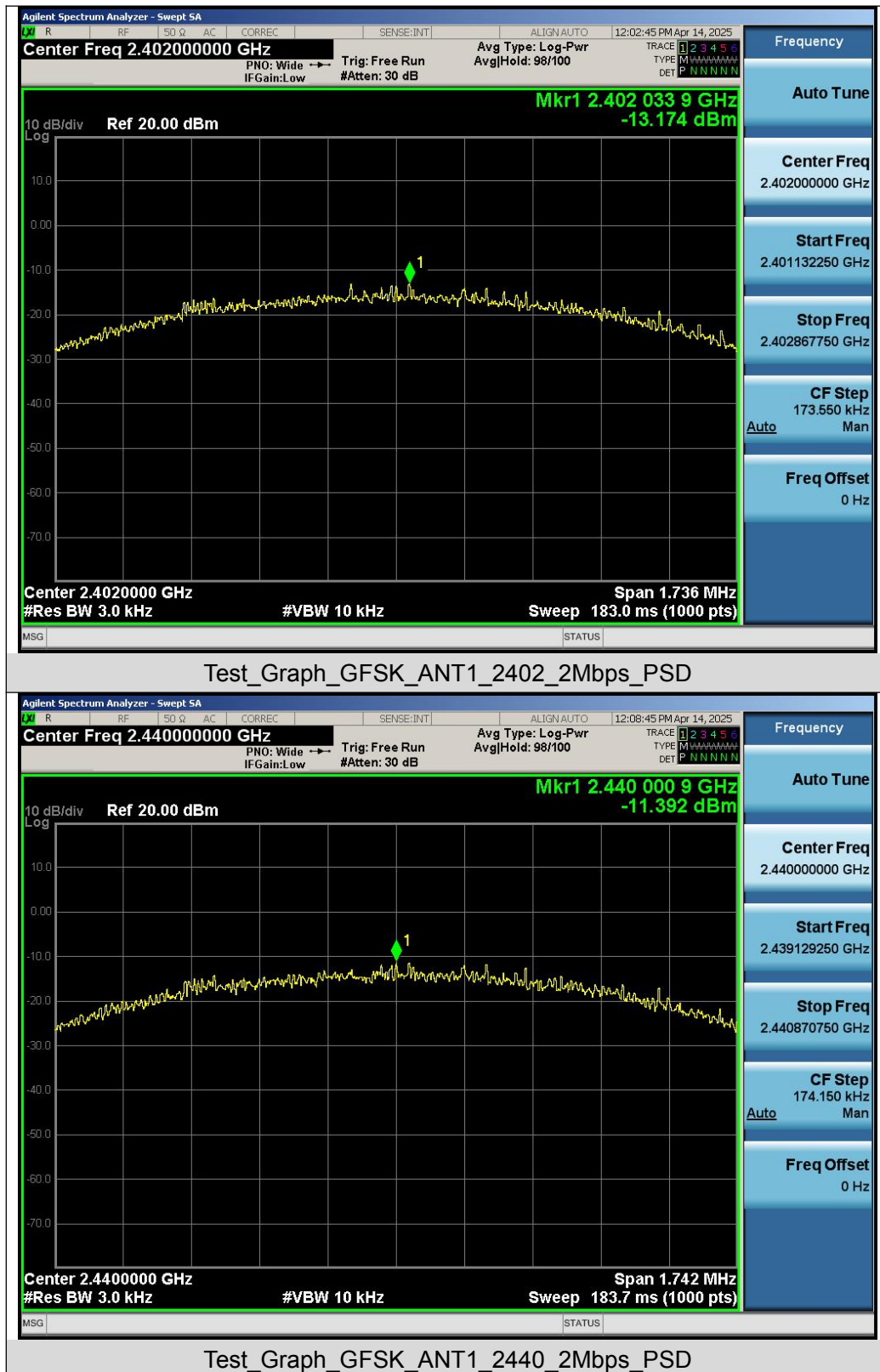

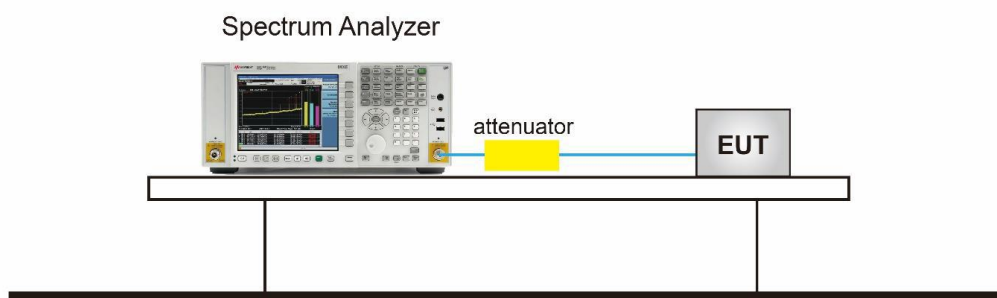

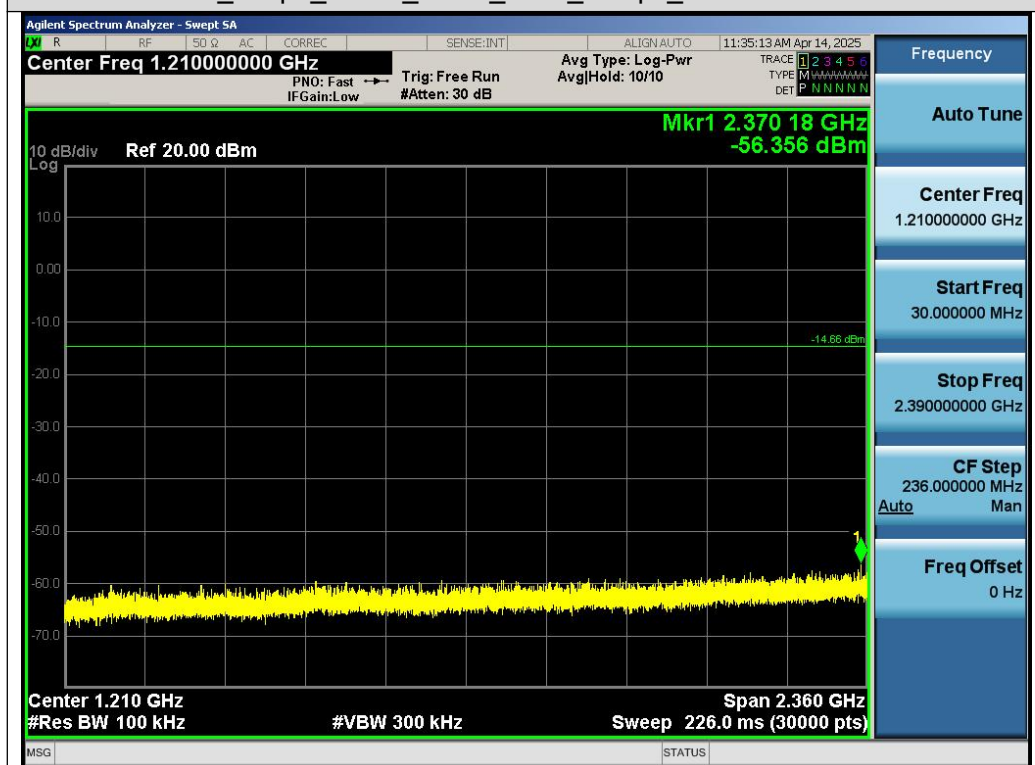

### Test Graphs of Spurious Emissions in Non-Restricted Frequency Bands

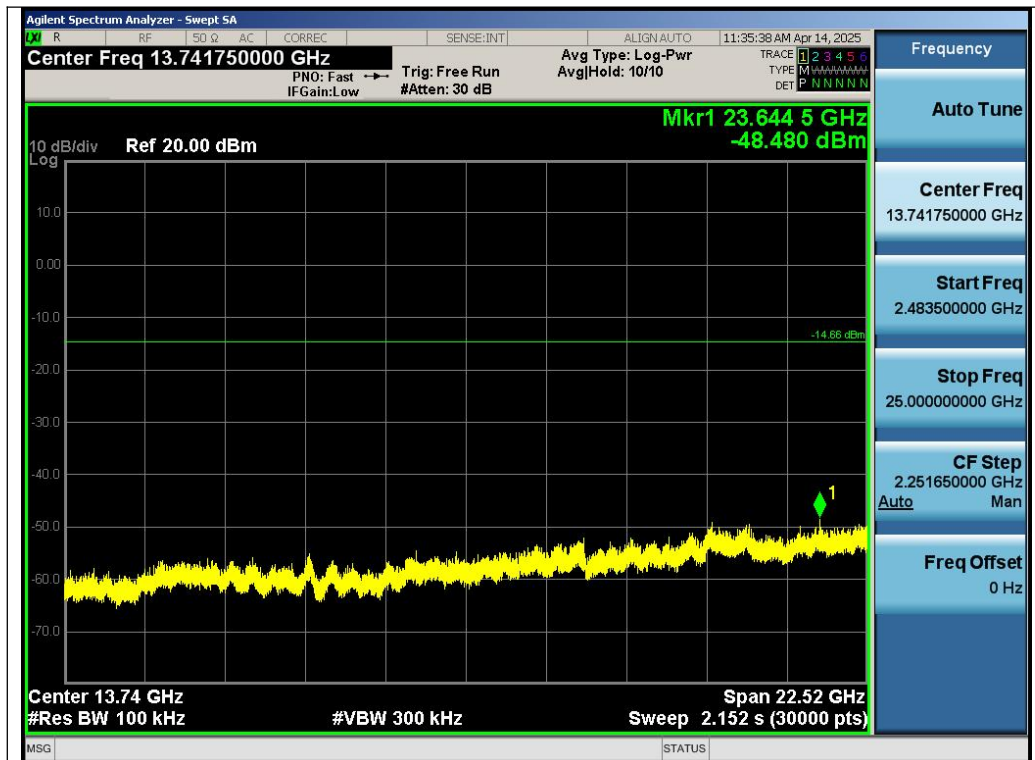

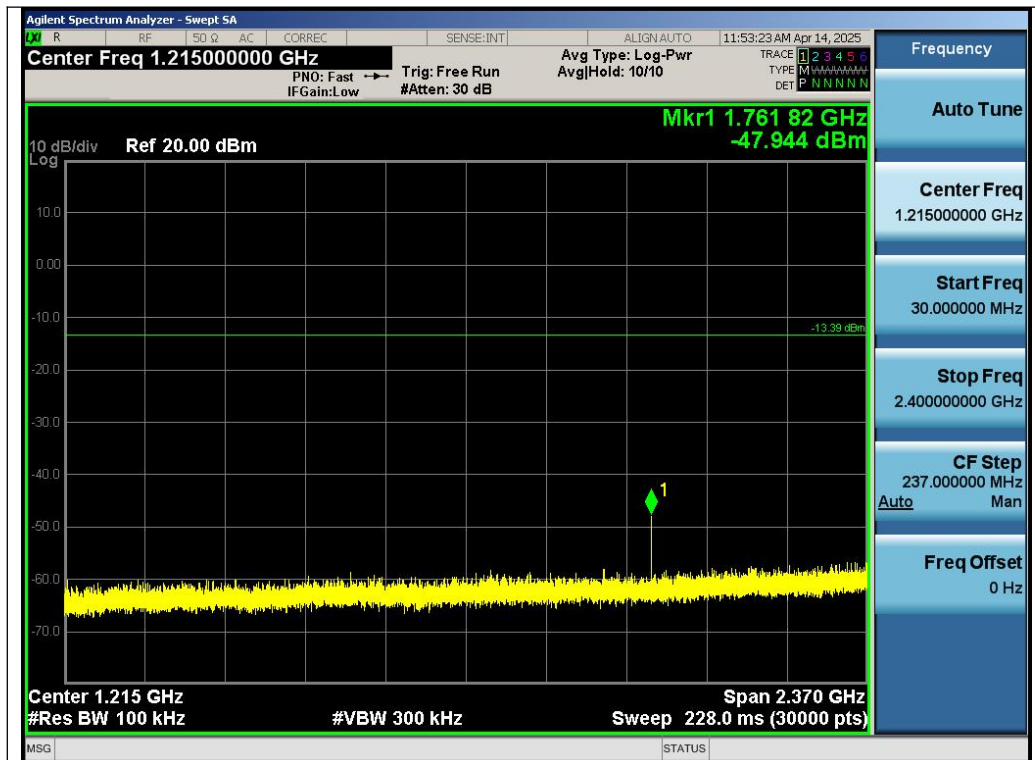


Test\_Graph\_GFSK\_ANT1\_2402\_1Mbps\_Higher Band Emissions

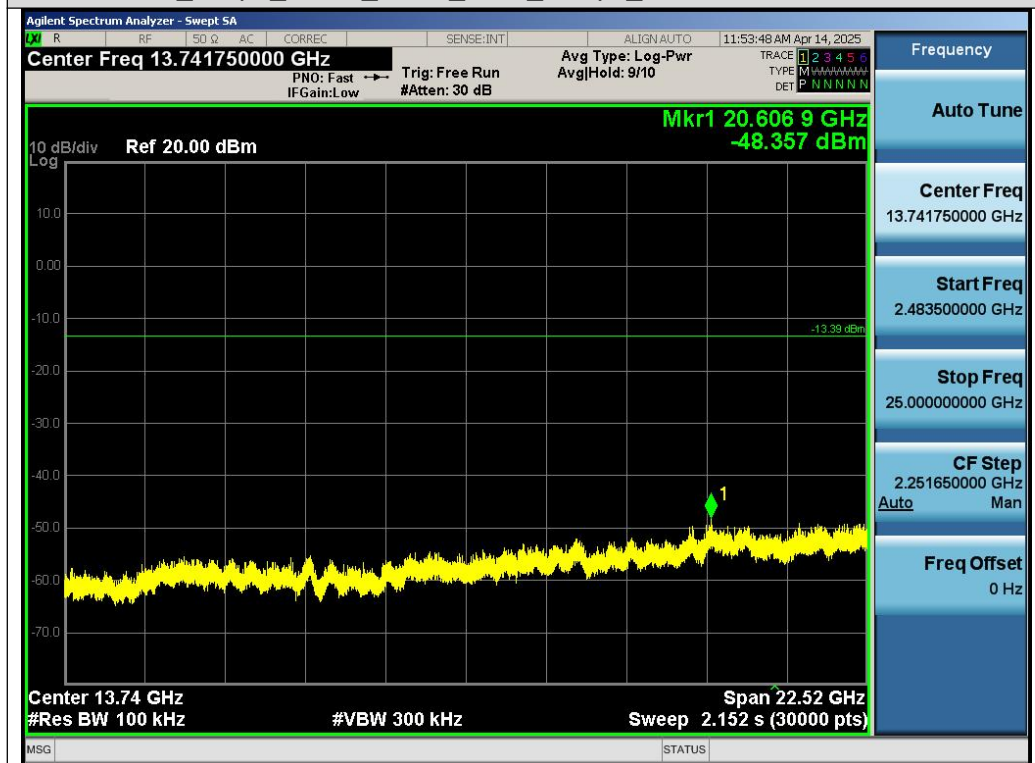

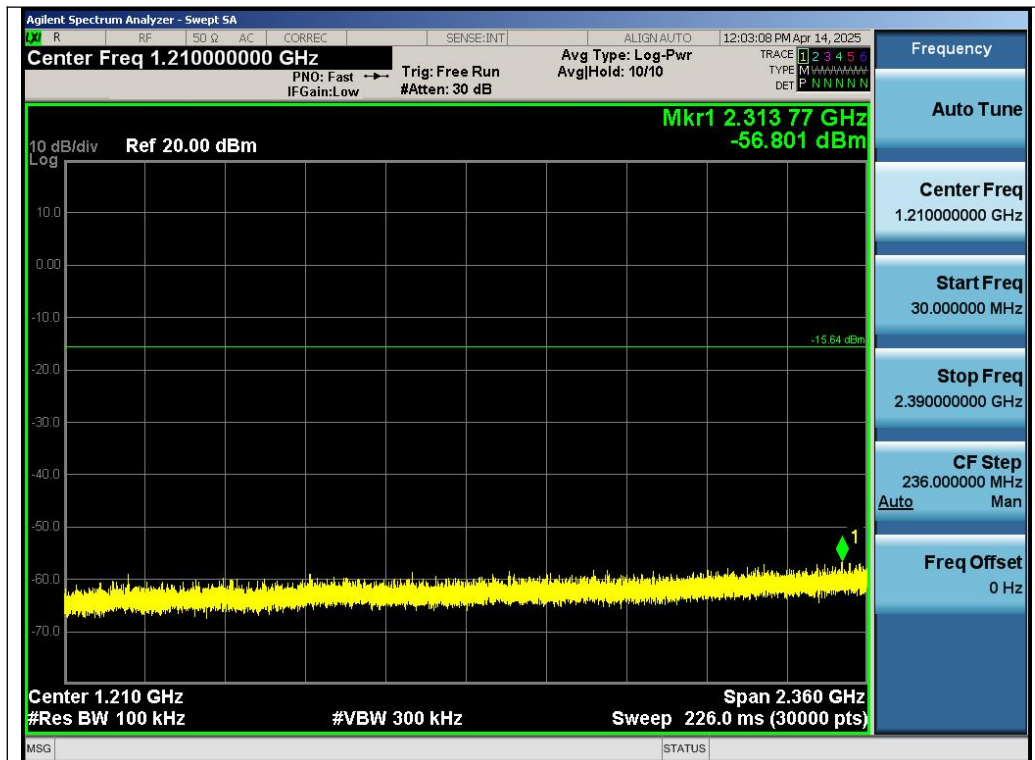


Test\_Graph\_GFSK\_ANT1\_2480\_1Mbps\_Higher Band Emissions
