Band25-20MHz-16QAM-26140-1RB#0-Range3:2000~20000MHz

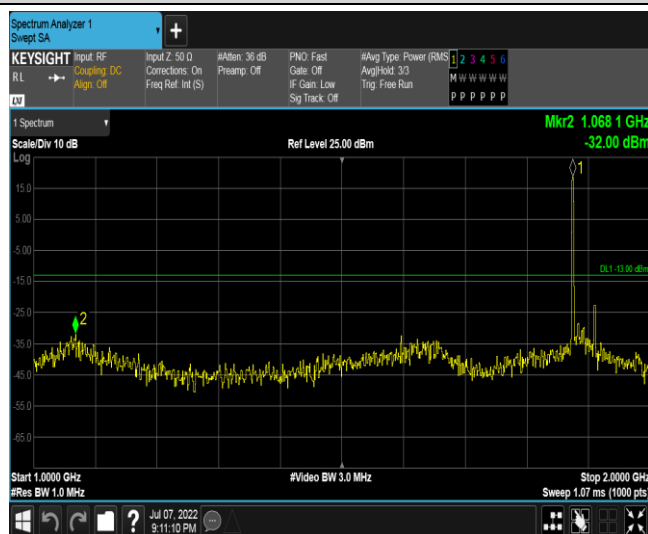

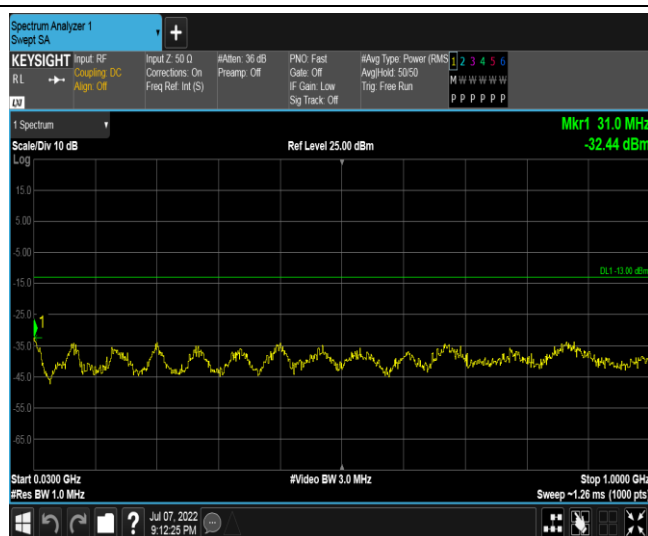

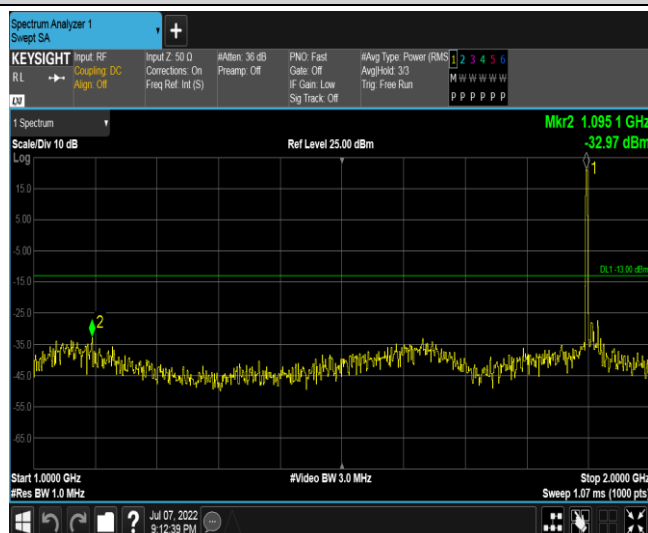
